## **Promotion Terms & Conditions**

- All applications received after the specified Promotion Period, or submitted through any
  means other than specified below, will not be eligible for the Promotion. Any
  correspondence on missing and/or delayed submissions will not be entertained.
- 3. This Promotion is conducted by Flo Energy Singapore Pte Ltd ("Flo Energy" or the "Retailer") and is open to all businesses in Singapore with an average monthly electricity consumption above 2,000 kWh.
