

How to Apply for Financial Aid

The Application Process

Avenues has partnered with Clarity Tuition in our financial aid process for the 2026–27 academic year. Clarity offers a streamlined platform for families to share secure financial information, and for Avenues to assess a family's demonstrated financial need. Our goal is to make the process as easy as possible for your family. Most families can complete the Clarity application in less than 30 minutes. It is mobile-friendly, your 1040 and W2 will automatically be transferred from the IRS. The application does not need to be completed in a single sitting; you can always save your progress and return later.

Avenues will communicate our financial aid decision to you. To make our decision, we use the information from the Clarity application as a starting point but also consider our school policy, practices, and available budget. To review Avenues financial aid policy, please visit our website.

How to Complete the Clarity Financial Aid Application Online

- Go to the Clarity application, and create your account.
- Begin by entering your household and applicant information.
- Select Avenues NewYork as a recipient school.
- You'll be asked to "approve" the release of your 1040 and W2 to Clarity via IRS.gov. If you don't have an IRS.gov account, you'll need to create one to authorize the release.
- Sign the IRS Form 4506c in Clarity to start the process.
- Make sure the address you enter matches exactly with the address on your most recent Form 1040. If your current address does not match, indicate that your address has changed in the last two years.
- Sign into your IRS.gov account and authorize the release in the Tax Information Authorization area of the site.
- New applicants are also required to manually upload your 2023 1040 with schedules.
- Complete the financial entries using your 2024 taxes and your best estimate for 2025.
- Business owners should check the "Documents Requests" and upload the K1 and business taxes.
- The application fee is \$65 and covers all the Clarity schools to which you are applying.

Additional Tips for Successful Completion

- Gather your 2023 (new applicants only), 2024 1040, W2 or 1099/K1 (if applicable), your mortgage or rental information, any asset account balances and credit card statements so you have the information you need at your fingertips.
- Share your family's story. The Financial Aid Committee carefully reviews all the financial information you provide, please be sure to explain your family's unique situation. It is helpful to share any recent changes in family status or significant financial adjustments from year to year. Note sections throughout the application are available to you.
- Itemize your "out of pocket expenses" to include 2024 expenses that were not listed in the previous sections. Examples include legal fees, funeral expenses, tutoring, club fees, athletic camps, music or art lessons, family vacations or travel expenses.
- Automatic fee waivers are applied to those families who qualify. Clarity uses family size, income, and asset information in the application to assess a family's situation and eligibility.
