9. **Winner Selection:** The DP World Tour Championship players will play the 17th hole on the Earth Course at Jumeirah Golf Estates during the 2 round of the DP World Tour Championship, held on Friday November 14 2025. The closest shot of the players to the pin will set the Marker. The best shot from each entrant will be compared against the Marker. Any valid entrant whose best shot is closer to the pin than the Marker will be entered into a Prize draw. The Prize draws will be conducted by a random computer program by Monday November 17 2025.
