Portfolio Holdings Strategy

The fund is traded daily and follows the UCITS (5/10/40) framework. Minimum 90% invested and holdings are divided into two main strategies - 60% (min. 50%) Equity megatrend Electrification and 40% (min. 30%) Precious Metals (focus Gold and all holdings as physical ETC:s). The 22 holdings within Electrification have an Target Weight at 4%/2% and they are allowed to be within +/-25% of target weight. Holdings are traded at the most liquid markets (approximately 50% US and 50% Global exUS). Benchmark is 60% Nasdaq Global TR Index (NQGIT) plus 40% Bloomberg Barclays Global-Aggregate TR Index (LEGATRUU) in the funds/share class trading currency (class A = SEK).

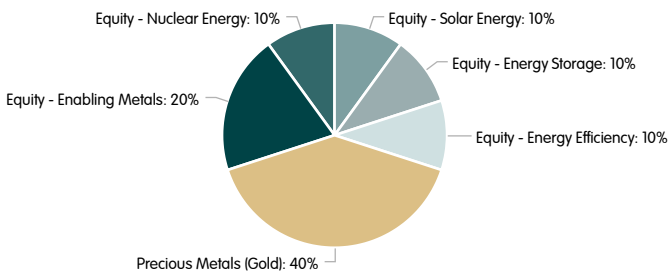

Investment Objective

The fund's strategy is structured around four sub-strategies – the generation of environmentally sustainable energy through solar and nuclear power – reduced energy consumption, lower emissions and recycling – energy storage – and the extraction of the raw materials essential for electrification.

We believe that companies exposed to the electrification megatrend will generate returns that outperform global equity markets and that gold will outperform bonds over the coming decades as the debt creation and money printing just goes on unabated.
