A written report is prepared and distributed as appropriate following the conclusion of each review. The reports contain partner responses and corrective actions to be taken with regard to specific findings and recommendations, including a timetable for anticipated completion and a justification for any recommendations not addressed. SC is responsible for ensuring that any issues identified are prioritized for additional training and support. SC partners receive donor funds into project-specific bank accounts. Due diligence is completed on all partners prior to disbursement of funds.
