

## **Terms and conditions of registration and entry to Challenge Events**

### **DEFINITIONS**

"Conditions" These terms and conditions

"Event" The package of elements associated with any running, cycling or challenge event that Street Child has places in.

"Event Fee" The fee paid by a Participant in respect of Registration for a Challenge Event.

"Registration Form" The electronic form that must be completed by all potential Participants and any permitted Substitutes.

### **1. Who Are We?**

Street Child is a charity registered in the UK, with number 1128536. Our office address is 206 – 208 Stewart's Road, London SW8 4UB. If you have any questions relating to these Conditions or the Event you should contact the Street Child team as set out below:

We will endeavour to respond to email messages as soon as possible and up to 3 working days.

### **2. Use of your information**

2.1. By providing your information when you register for an Event, we will use this information for the purposes of completing your registration with the Event Organisers of your chosen Challenge Event. If you provide personal information on behalf of additional entrants, please only provide this if they have confirmed that they are happy for you to do so as we will use this information for the same purposes.

2.2. Your personal information may also be used for the purposes of sending communications to you where you have confirmed that you would like to receive further information about the charity's work when registering for an Event, or to send key information to you regarding the Event.

2.3. All personal information held by us will be handled in accordance with applicable privacy laws and Street Child's privacy statement which can be found [here](#).

### **3. Registrations and payment**

Registration fees for Challenge Events differ but will be clearly marked on the Event page. Payment of your registration fee must be made within 30 days of your registration and/or before the Event's registration deadline.

#### **4. Fundraising**

We ask that by registering for one of Street Child's places on a Challenge Event you pledge to fundraise the given target for the Event, clearly displayed on the Event page before you register. This fundraising is independent of race entry cost the Event Fee. We may contact you with support and suggestions regarding fundraising if we feel you are not on target.

#### **5. Withdrawal, Cancellations or Alterations**

If you wish to cancel your place or withdraw from the Event please communicate this to us in writing at least 30 days before the Event Registration Deadline.

Your Event Fee is non-refundable but can be transferred to a future event. If you wish to transfer your registration to another event, please communicate to this in writing.

Street Child reserve the right to cancel your place or withdraw you from our team if you fail to respond to vital event information requests or if you do not pay your Event Fee within the allocated time frame.

#### **10. Publicity**

Photos may be taken at the Event. These photos will be used to promote future Events online, in press articles and on social media. If you do not wish your image to be used in photos or video please let us know.

Where you appear in the background of an image or as part of a large crowd, Street Child reserves the right to use these photographs for promotional purposes.

#### **11. General**

These amended Conditions (and the documents referred to in them) constitute the entire agreement and understanding of the parties and supersede any previous agreement between the parties relating to the Event. You acknowledge and agree that by submitting the Registration Form (and the documents referred to in it) you shall not rely on, and shall have no remedy in respect of, any statement, representation, warranty, understanding, promise or assurance (whether negligently or innocently made) of any person (whether party to this Agreement or not) other than as expressly set out in the Registration Form and these Conditions. If any provision of these Conditions shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from these Conditions, shall be enforced to the fullest extent allowed by law as to affect the intention of the parties, and shall not affect the validity and enforceability of any remaining provisions. No waiver by either party of a breach or a default hereunder shall be effective unless in writing and signed by both parties and any such waiver shall not be deemed to be a waiver of any subsequent breach or default of the same or similar nature. We reserve the right to vary these Conditions by giving notice to you in writing in any official Event material or correspondence prior to the Event. All decisions and rulings by us, our employees and our agents shall be binding and final.

#### **12. The legal position of these terms and conditions.**

These Conditions form a legally binding agreement between you and us. These Conditions shall be governed by English law and are subject to the exclusive jurisdiction of the courts of England and Wales. These Conditions were last updated on 23<sup>rd</sup> August 2018.
