

Participant Entry Information Terms and Conditions

For the purposes of these Terms and Conditions and the relevant event 'The Organisers' can refer to Street Child, or Threshold Sports. The term 'The Organisers' does not affect any of the individual entities liabilities to each other or the participant.

How to Enter

1. To have the opportunity to take part in the event you must:
 - a. complete the Online Registration Form (a confirmation email will be sent once your place is confirmed)
 - b. accept these terms by clicking the checkbox at the end of these terms and conditions.
2. You may only register once. Any subsequent registrations will not be taken into account.
3. Event registration is open from 02/02/2026 and closes at 17:00 GMT on 19/05/2026
4. We are not responsible if your entry is incomplete, lost or does not comply with the rules.
5. Your entry is personal to you accepting these Terms and Conditions and you agree to;
 - a. participate in the Event wearing the number assigned to your registration
 - b. not authorise or permit any third party to use your participant number for the Event
 - c. not sell or transfer or give any other person the right to participate in the Event and / or use your number
 - d. inform the event organisers of any changes to the information supplied in your Online Registration Form and in particular any changes to your medical conditions and contact details
 - e. comply with the Event training advice as issued by The Organisers
 - f. have appropriate personal accident and insurance cover in place in order to participate in the Event

Important Information

6. Sorry, but you can't take part in this event if you are under 18 years old.
7. This is a fundraising event – if you do not meet the minimum fundraising target, we reserve the right to refuse participation and you may not be allowed to enter future Big Ride events.
8. The minimum fundraising targets are GBP 3,150 for 2-day challenges, GBP 2,100 for 1-day challenges, GBP 1,575 for 1-day challenges excluding camping. If your company has a partnership agreement with Street Child then your own fundraising target may differ and participation is subject to your employer's approval.

9. You will be required to complete a medical questionnaire as part of the registration process and to provide any other medical information as requested.
10. By accepting these terms, you confirm that you are physically and medically fit to take part in your chosen event.
11. If you have a medical problem or disability which may affect your participation in the Event, you must inform The Organisers as soon as reasonably practicable so that The Organisers can advise as to the suitability of the chosen arrangements. If The Organisers or suppliers are unable to accommodate the particular needs of the person concerned and reasonably believe that his or her health and / or safety would be put at risk by his or her participation in the Event, The Organisers reserves the right to decline your participation in that event.
12. The Organisers have the right to refuse participation of any participant in the Event if any participant is deemed to be medically unfit to take part in the Event.
13. Except for any bike insurance applicable to official event transport services in these terms and conditions, you are responsible for your own belongings in taking part in your chosen event. It is your responsibility to have suitable insurance in place, such as home or travel insurance, which covers loss or damage to your bike, if applicable, and your other belongings whilst taking part in the event.
14. Be aware that:
 - a. the event is not a race;
 - b. you enter the event at your own risk;
 - c. you are expected to follow the rules of the road and/or public byways and show consideration to other public users at all times;
 - d. the 'on foot' routes will be fully signed and manned by event marshals where necessary;
 - e. a limited support service will be provided along the official cycle routes for those who can't continue because of mechanical failure (cycling) or injury; and
 - f. the cycle route(s) are on open roads and may involve areas with busy road conditions (e.g. roundabouts, major junctions).
15. You are responsible for your safety; as part of this responsibility you must:
 - a. not consume alcohol or any illegal substances before or during participation;
 - b. obey our instructions (including from traffic officers, The Organisers and authorised marshals);
 - c. behave responsibly and appropriately at all times on the routes and at the venues;
 - d. follow the official routes;
 - e. let the medical team know immediately if you are feeling unwell;
 - f. begin at the official start time you are allocated;
 - g. If entering a cycling event you must ensure that your bike is road worthy and suitable for your chosen event, and
 - I. wear a safety-approved cycle helmet when cycling (no helmet, no ride);
 - II. bring (and be able to use) a puncture repair kit;
 - III. not use a mobile phone or music player whilst taking part in the event;
 - IV. remove tri-bars from your bike

16. Your bike (where applicable) will be covered by insurance for up to £10,000 during transportation where using the event transport services.
17. If, during or before the event, we believe that you are unfit to take part or you have not complied with these terms, The Organisers may remove you from taking part in the event and we'll not be liable to you for this.
18. By entering the event, you agree that you will only take part on the day if you are in good health and will undertake adequate training for the event. You understand that we will take reasonable steps to promote your safety and that you must comply with all instructions given by the event The Organisers and marshals.
19. If you can't attend the event for any reason, or if any of your details or circumstances change, please let us know immediately by emailing events@street-child.co.uk
20. If you pull out of the Event after midnight on 19/05/2026 you will be charged a cancellation charge of GBP 850. We cannot refund your sponsors if you pull out or are forced to cancel. We cannot refund your sponsors if the Event is cancelled or shortened for unforeseen circumstances.

22. There are a limited number of places available at each event.

23. Places shall be allocated on a first come, first served basis.

24. All event entries include access to the bike transportation service, all soft drinks, snacks and main meals throughout the event and on the course as well as some alcoholic drinks in the event village. One piece of event branded clothing for each day of participation and basic sleeping equipment (tent, and roll mat), hot showers, toilets and wash basins for those staying overnight. Sleeping bag, pillows and towels are not included. All other expenses are at your own cost or at your organisation's discretion. In particular, we will not pay for any other travel (including if you are removed or retire from the event, cycling or running/walking kit or accessories. A complete kit list will be provided to you pre-event.

25. We may change the timings, dates, routes or format of the event or cancel all or part of the event. If we do this we'll notify you of the change by email or in person (as appropriate).

Publicity and content

26. By taking part in the event you give us your unconditional, payment-free, permission to use, copy, process, publish, transmit and display your name on the Event website.

27. Photographs and video content will be taken during the event and may be uploaded to websites, including (but not limited to), the Event website, the Street Child website, and Street Child's Facebook and Twitter pages, and used in future

marketing material. By registering for the event you give us your unconditional, payment-free permission to use this content for these purposes.

28. Where we need to, we and our supplier will use your details and registration information to run the event and contact you with information about the event. Medical information will be kept confidential and will only be shared with medical personnel and teams allocated to the event. We won't store your details after the event.
29. Street Child will need to collect some information from you in order to enroll you in the event and your information will always be used in accordance with our Privacy Policy.
