MINUTES OF MEETING

May 22, 2023

A meeting of the Louisiana State Board of Medical Examiners, pursuant to lawful notice, was convened and called to order at 8:30 a.m., Monday, May 22, 2023, by order of the President, at the offices of the Board, 630 Camp Street, New Orleans, Louisiana.

(1.) General Administrative Matters; Public comments; Meeting Order; Dr. Johnson opened the meeting with the Pledge of Allegiance. Dr. Culotta read the mission

statement of the LSBME.

- **(2.) Minutes of April 24, 2023;** The Board reviewed and discussed the minutes of its meetings held on April 24, 2023. On the motion of Dr. Thomas, duly seconded by Ms Sport, the Board voted unanimously to approve the minutes of its April 24, 2023 meeting, with corrections.
- (3.) Follow-Up Action Items; USMLE Test Update; The Board reviewed the information regarding the USMLE, COMPLEX, and FLEX 4-test limit, and no limit to the SPEX exam. The Board also was informed that the FSMB expects the LSBME to give an exemption to our rules automatically if the Board sponsors an additional testing, which is explicitly clear in two areas of their form. The Board tabled this agenda item for a follow-up at June's Board meeting.
- (4.) Follow-Up Action Item; Direct Supervision of a Physician and Private Radiological Technologist; The Board reviewed the proposed amendment to the current rules regarding direct supervision of Private Radiological Technologist. Upon the motion of Dr. Thomas, duly seconded by Ms. Sport, the Board voted unanimously for staff to begin promulgating the amendment to the rules as presented.
- (5.) Communication and Information; Request for Wavier on Mailing List Rule; The Board reviewed the request from Wendy James, Great Seminars, regarding a Board waiver to the mailing list in regard to releasing emailing addresses. Upon the motion of Dr. Thomas, duly seconded by Dr. O'Neill, the Board voted unanimously to deny the waiver request.
- (6.) General Administrative Matters; President's Report; The President informed everyone of the great things he heard about the FSMB meeting in Minneapolis. He informed everyone that Ms. Aloma James met with groups that are having some of the same issues as our Board, where licensees are wanting to pay less but have their applications processed quicker. The President asked Dr. Cresswell about the FSMB Bylaws Committee he sits on, and his experiences at the meeting. Dr. Cresswell informed the Board that he also hosted a forum for Investigators, Directors of Investigations, and Executive Directors from all over the country regarding best practices, sentencing, and investigation standards streamlined nationally.

The President expressed how important it is for staff to attend the FSMB even amid budget restrictions to ensure the agency stays up to date with best practices across the country. He asked staff to look into FSMB scholarships for next year to cut cost for some staff to attend, and to look into getting the typical 3 scholarships for staff and a fourth for a Board member.

- (7.) General Administrative Matters; Secretary-Treasurer's Report; The Secretary-Treasurer informed the Board regarding the LLA audit and HB 288. She also informed the Board that she plans to meet with Ms. Wilton for the second level review's first report at the June Board meeting.
- (8.) General Administrative Matters; Executive's Director's Report; The Executive Director informed the Board:

- Since our last board meeting, I met with FSMB regarding our Bridge program, and the FSMB will classify the BRP license as a special license in the database of the FSMB. There is only one person eligible for the Bridge to Residency Program (BRP) and that application is currently incomplete.
- I have met with Employer Coalition of La. Regarding health care workforce statistics.

 Recent data shows that the least healthy parish in Louisiana is Bienville parish and there are no active Physicians or PAs in the parish. They have asked us to have the best data we can have, and we are making it happen.
- Since our last meeting, the staff has met with LAPA to address their concerns regarding rules for PAs.

The Athletic Trainers Advisory Committee (ATAC) has met and given final approval to a set of rules that they would like to have enacted.

The Occupational Therapy Advisory Committee (OTAC) has met twice, and they continue to work on an overhaul of their rules.

- We are working with the CE broker to fix a glitch in the CME/CE reporting for the medical psychologists and the MPAC will resolve this at their next meeting.
- The Louisiana Applicant Processing System (LAPS), the new statewide fingerprinting and CBC system, is evolving rapidly, and we are working to expedite functionality as soon as we are active by the system. New key points of the system are that the LSBME will no longer have to collect cards or money and we do not have to send anything to the LSP (Louisiana State Police). The LSP contractor will have multiple sites throughout the state for the applicants to present themselves with a form that has the LSBME code printed on the form and pay the processing contractor. The contractor will forward the electronic fingerprints to the FBI and results should be available for the LSBME to review in approximately 7 days.
- I have had eight calls and/or emails with the LDH, and they have assigned a deputy finance director to assist us in the evaluation of fees, costs, and reserve concerns as directed by the board. Ms. LaKenya and I have reviewed the response to their first request and replied accordingly. We are awaiting their initial review and will work closely with LDH and our staff and assigned board members in this matter.
- The recent OTS statewide internet outages have not affected the LSBME. We are independent of the OTS and its statewide network. Kudos to our IT director and staff for their guidance in keeping us separate. There has been an increasing number of cyber-attacks nationwide which is related to the growth and expansion of AI. This requires more frequent necessary upgrades to our cyber-security systems.
- I have had over 12 hours of meetings with Dr Chaney and will continue to collaborate with him to create a more efficient and functional agency.
- I attended the LSUS Medical School graduation this past Saturday.
- (9.) General Administrative Matters; Financial Report. The Board reviewed the Combined Balance Sheet and Profit and Loss Four Year Comparison for March 2023. Upon the motion of Dr. Williams, duly seconded by Dr. Horton, the Board voted unanimously to approve the financial report.
- (10.) Future Board Meeting Dates. The Board reviewed the future meeting dates for 2023.

¹ Dr. Johnson and Ms. Sport were out of the meeting and not included in this unanimous vote.

No further action was needed or taken.

(11.) Rules and Regulations. Rules/Amendments. Upon the motion of Dr. O'Neill, duly seconded by Dr. Thomas, the Board voted unanimously to approve the proposed Athletic Trainers proposed Rule changes.

On the motion of Dr. Taylor, duly seconded by Dr. Thomas, the Board voted unanimously to movie the Rule Considerations to Executive Session for Attorney Advice.

- [12.] Minutes of Executive Sessions. Upon the motion of Dr. Thomas, duly seconded by Dr. O'Neill, the Board voted unanimously to convene in executive session pursuant to La. R.S. 42:17A to receive and review the minutes of the Board's April 24, 2023, executive session. Following review, the Board returned to public session. Upon the motion of Dr. O'Neill, duly seconded by Dr. Williams, the Board voted unanimously to approve the April 24, 2023, executive session minutes.
- [13.] Executive Agenda Item moved from Public Session; Telemedicine Rules; Attorney Advice. The Board convened in executive session to receive Attorney Advice regarding Telemedicine and the current rule that prohibits any licensee from practicing telemedicine on probation or with any kind of restrictions. No further action was needed or taken on this matter.
- [14.] Report on Pending Litigation. Upon the motion of Dr. Clark, duly seconded by Ms. Sport, the Board voted unanimously to convene in executive session pursuant to La. R.S. 42:17A(2, 4 and 10), La. C.E. art. 508, and/or La. R.S. 44:4.1C, to receive and review the report of legal counsel on pending litigation to which the Board is a party, the unauthorized practice of medicine cases assigned for injunction, and the status of proceedings for judicial review of prior Board decisions. Upon the motion of Ms. Sport, duly seconded by Dr. Thomas, the Board voted unanimously to accept the litigation report.
