AUGUST 20, 21, 2007 NEW ORLEANS. LOUISIANA

A meeting of the Louisiana State Board of Medical Examiners, pursuant to call of the President and lawful notice, was duly convened and called to order at 8:30 a.m., Monday, August 20, 2007, by order of the President, at the offices of the Board, 630 Camp Street, New Orleans, Louisiana.

First Session Monday, August 20, 2007

- 1. **Minutes of July 2007.** The Board reviewed the minutes of its meeting of July 16, 2007. Motion was made by Dr. LeBlanc, seconded, and unanimously carried, to approve the minutes of the meetings together with the executive sessions conducted during such meeting with all necessary corrections.
- **2. Confirmation of Interim Board Actions**. The Board reviewed the Memorandum of Interim Board Actions in the matter of Laura Crump Fairbanks, M.D., and Dana Ray Fouchi, M.D. in which the Board voted to invoke the Sick Physician Statute in both matters. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board affirmed the interim Board actions, noting the correction necessary with respect to Dana Ray Fouchi, M.D.
- 3. Status Report on Action Items of Prior Board Meetings; Report on Assignments to Counsel. The Board noted that all action items as assigned to staff and counsel from previous meetings had been completed.

4. Rules and Regulations.

Final Rules/Amendments: Physicians and Surgeons; Collaborative Drug Therapy: Act 627/SB 679 (2006 Regular Session of the Louisiana Legislature) amended the pharmacy law to provide that the Board and the Pharmacy Board shall publish Notice of Intent of rules dealing with collaborative drug therapy management within 120 days from the effective day of the amendment, i.e., August 15, 2006 or by December 15, 2006 at the latest. (See SB679 for further details). A draft was prepared and circulated to the Executive Director of the Pharmacy Board for discussion. A draft of the rules was then provided to the Board at its meeting of September 18, 2006 for consideration and discussion. A special call meeting was held on October 13, 2006, to review further revisions to the proposed rules. Following discussion, the Board authorized publication of a Notice of Intent to adopt the rules in the November 2006 edition of the Louisiana Register. During the twenty-day period prescribed for a public hearing (ending December 11, 2006) no requests were received for a public hearing. Three written comments were received all dated December 21, 2006, the last day of the written comment period. Due to certain discrepancies between the rules noticed by the Board and the Pharmacy Board, discussions were held between representatives of both boards and modifications were proposed to each of the rules. The modifications resulted in both rules becoming duplicates of each other. These suggestions were considered and approved by the Board during its meeting of February 12, 2007, following which the Board determined to provide Notice of Intent in the Louisiana Register of substantive changes to the rules previously proposed, hold a hearing to receive comment with respect to the proposed changes. In accordance with such Notice of Intent, a joint public hearing of the Board and the Louisiana State Board of Pharmacy was held at the offices of the Board on April 20, 2007 to receive comments on the proposed substantive changes to the proposed rules. At its

meeting of June 18, 2007, the Board reviewed the written comments from the original notice, the transcript from the joint public hearing, discussed and approved responses to the commenters, and determined to adopt the rules with the substantive changes previously noticed. A legislative report was thereafter forwarded to the oversight committees and commenters on July 3, 2007. The rules were promulgated by publication in the August 20, 2007 edition of the *Louisiana Register*.

- b. Rules/Amendments Noticed of Intent Physicians and Surgeons Rural Physician Self-Referral. In 2006 the Louisiana legislature adopted Act 819, prohibiting Louisiana licensed physicians from making referrals to healthcare facilities located in the primary service area of a rural hospital, in which the referring physician or an immediate family member owns a direct or indirect ownership interest. The Act provides relevant exceptions and requires the Board to adopt rules and regulations providing that violation of the law provides cause for action against the physician=s license. At its meeting of June 18, 2007, the Board reviewed, discussed and approved publication of Notice of Intent to adopt rules specified by Act 819. The Notice of Intent appeared in the August 20, 2007 edition of the Louisiana Register. A public hearing on the proposed rules has been scheduled for the Board=s offices on Monday, September 24, 2007, at 3:00 p.m.
- Rules/Am Under Development Respiratory Therapy. The Advisory Committee for Respiratory Therapy had prepared a number of amendments to Chapter 25 (46XLV.2501-2569) of the respiratory therapy rules (Licensure). Dr. Ferdinand, the Board=s liaison to the Committee and counsel reviewed the proposed amendments and worked with the Committee to develop a more comprehensive draft for the Board=s consideration. In December 2005 a further draft, containing additional modifications not previously addressed, was received by the Board, along with suggested revisions to the Respiratory Therapy Practice Act. Following review and discussion, the Board determined to defer the rule-making effort pending outcome of legislative consideration of proposed amendments to the Act. In the interim, Dr. Ferdinand, counsel and staff met with representatives of the Advisory Committee to discuss and assist with revisions to the Respiratory Practice Act. A copy of the Committee=s suggestions for revisions were considered by the Board at its meeting of February 12, 2007. The suggestions were subsequently filed as HB 251, approved by the Legislature and signed by the Governor (Act 142). The Respiratory Therapy Advisory Committee is reviewing the current respiratory therapy rules to ascertain what modifications may be needed in light of the changes to the Act. As soon as the RTAC=s recommendations have been received and reviewed by Dr. Ferdinand and counsel, they will be presented to the Board for consideration. Midwifery: The Midwifery Advisory Committee suggested a number of amendments to the Board=s midwifery rules on licensing, 46XLV.2301-2373 and practice, 46X:V.5301-5363. Members of the Committee met with the Board during its January 2005 meeting to discuss their suggestions. The Board reviewed the proposed amendments at its meeting of February 15, 2005 and appointed a Subcommittee to study the issue and report their recommendations to the full Board. The Board=s Subcommittee studied the Advisory Committee=s suggestions and provided draft recommendations for their review and discussion. A reply to the Subcommittee=s recommendations, dated June 26, 2006, was received, and the Subcommittee met during the July 2006 meeting and accepted some of the recommendations and rejected others. A revised draft was sent to the Advisory Committee on August 8, 2006 with the request that any final modifications be received in time to place a final draft on the September 2006 agenda for the Board=s consideration. The Midwifery Advisory Committee

and several individual midwives expressed concern over several areas of the proposed revisions and requested a meeting. A meeting was held between the Subcommittee and the Advisory Committee in November 2006 to discuss their concerns. A revised draft was forwarded to the Midwifery Advisory Committee in January 2007 and a reply was received accepting the changes in February 2007, but providing further recommendations on one section of the rules. A further draft to address this issue was sent to the Committee in March. Its reply was received June 4, 2007 and was disseminated to the Subcommittee for review and finalization. The Subcommittee accepted the suggested revisions contained in Kathy Acree=s letter dated May 29, 2007. At its meeting of June 18, 2007, the Board approved the suggested changes and approved publication of a Notice of Intent to amend revisions to 5355 in the Louisiana Register. Perfusion The Advisory Committee for Perfusionists submitted a rough draft of rules for the Board=s consideration. Following review and discussion, the Board appointed Dr. Ferdinand and Board counsel to work with the advisory committee in the formulation of administrative rules relating to the licensure and practice of perfusion in this state. Dr. Ferdinand and counsel met with the Advisory Committee Chair to assist in developing a more comprehensive, focused draft of rules for the Board=s consideration. A revised draft was recently received and is being studied. As soon as it has been refined, it will be presented to the Board for consideration. Physicians and Surgeons; Registered Dispensing Physicians; Licensure and Practice: The Board is studying its existing rules governing registered dispensing physicians relative to controlled substances to determine if modification is in order. Physicians and Surgeons - Mid-Level Providers: The Board appointed a Committee to work on the development of rules relative to supervision. collaboration and consultation with mid-level providers. As soon as a draft is finalized, it will be presented to the Board for consideration. Physician Assistants - An analysis of the current PA rules is being undertaken, particularly, the substantive roles of supervising physicians, locum tenens, supervising groups, as well as scope of practice issues. A draft of the proposed amendments concerning the substantive roles of supervising physicians, locum tenens and supervising groups was considered and approved by the Physician Assistant Advisory Committee. The Board considered the proposed amendments at its meeting of July 16, 2007, and at its meeting of August 20, 2007, upon motion made, duly seconded and passed by unanimous voice vote, the Board authorized publication of a Notice of Intent to adopt the rule amendments in the next issue of the Louisiana Register. Acupuncture - HB 837 created a category of licensee called Aacu detox specialists,@ whose practice is limited to the application of needles to a specific point or combination of points on the ear. Applicants must be certified by the National Acupuncture Detoxification Association and practice under the general supervision of a physician or an acupuncturist=s assistant. The law requires the Board to promulgate rules through its Integrative and Complimentary Medicine Advisory Committee that it deems necessary to regulate the certification and practice of acu detox in this state. The Board instructed staff to contact the Integrative and Complimentary Medicine Advisory Committee so that a rule-making effort may be undertaken. As soon as a final draft is prepared, it will be presented to the Board for consideration. Adjudication - The Board has directed counsel to revise its rules on adjudication (60 day hearing for summary suspension). As soon as a draft is finalized, it will be presented to the Board for consideration. Clinical Laboratory Personnel - Following a review of its balance sheet, financial information and budgetary needs at its meeting of March 2007, the Clinical Laboratory Personnel Advisory Committee voted at its June 30, 2007 meeting to recommend that the Board accept the recommendation for a license/annual renewal fee increase of fifteen dollars (\$15.00) for all CLP licensees. At that time the Committee also voted to recommend that the Board undertake the following additional rule-making efforts: (i) to adopt staff=s recommendations to include a number of causes that may give rise to the denial, suspension, or revocation of licensure; (ii) to delete Chapter 111 of its rules so that the Board may continue to handle disciplinary proceedings relative to CLP applicants/licensees as it does for all other allied health care providers; and (iii) to eliminate certification examinations CLS-G/CLS-T offered by two organizations which, in the view of the Committee, do not provide the minimum acceptable educations, clinical, employment or experience requirements requisite to licensure. The Board received the report of Dr. Gage-White on clarification of item (iii), and upon motion made, duly seconded and passed by unanimous voice vote, authorized publication of a Notice of Intent to adopt rule amendments in the next issue of the Louisiana Register. Physicians and Surgeons - Supervision of Unlicensed Providers - The Board has directed staff/counsel to work on the development of rules for supervision of unlicensed providers of cosmetic and other medical services. As soon as a draft is finalized, it will be presented to the Board for consideration. Podiatry - HB 770 (Rep. Salter) was adopted by the Legislature and appears as Act 204. The bill expands the scope of the practice of podiatry to include Atreatment of the ankle, muscles, or tendons of the lower leg governing the functions of the foot and ankle by a podiatrist who has completed advanced training determined to be sufficient by the Board at a program accredited by nationally recognized associations acceptable to the Board.@ Implementation of the increase scope of practice must proceed by rules promulgated by the Board that are predicated on the education or level of training, or both, of an applicant. In addition, the certificate (license) issued by the Board to a podiatrist must reflect an applicants practice authority based on his or her level of training. Pursuant to the Act, staff and counsel are working on a draft of these rules and will request the input of the Board=s Podiatry Advisory Committee and the Louisiana Orthopedic Association. As soon as a draft has been prepared, it will be presented to the Board for review and consideration. Physicians and Surgeons - Demonstration of Clinical Competency - The Board has directed staff/counsel to work on the development of rules for demonstration of clinical competency for licensure/renewal. As soon as a draft is finalized, it will be presented to the Board for consideration.

- **5.** Rulings and Advisory Opinions; Respiratory Therapy; Scope of Practice; Arterial Blood Gas Analysis; Follow-up. The Board reviewed the draft response to correspondence received from Cornelius B. Roche, BS, RRT, LRT, asking whether it is within the scope of practice for a respiratory therapist to perform arterial puncture for the purpose of acquiring blood to be analyzed for lab values, other than blood gas analysis data. Following review and discussion, it was the consensus of the Board to approve the response as written that it is within the scope of practice for a respiratory therapist to perform arterial puncture for the purpose of obtaining a sample of blood for no other purpose than a blood gas analysis. However, arterial puncture for the purpose of peripheral arterial line is permitted, whatever the purpose, as long as the line is used for testing relative to respiratory therapy.
- **6.** Rulings and Advisory Opinions; Podiatry; Scope of Practice. The Board reviewed the correspondence received from Darek L. Guichard, DPM, informing the Board that it was the opinion of the Podiatry Advisory Committee as well as the Louisiana Podiatric Medical Association that noninvasive vascular testing of the lower extremity is within the scope of practice for podiatric physicians. Following review and discussion, it was the consensus of the Board to send Dr. Guichard an acknowledgment letter thanking him for the Committee=s response.

- 7. Rulings and Advisory Opinions; Respiratory Therapy; Scope of Practice; Insertion of PICC Line. The Board reviewed correspondence received from K. Theresa DelRio, RRT, RPFT, requesting that specially trained respiratory therapists be allowed, in accordance with Act 142 of the 2007 Louisiana Legislature, to place peripherally inserted central catheter lines as requested by physicians for patients who have long-term intravenous needs. Following review and discussion, it was the consensus of the Board to inform Ms. DelRio that allowing specially trained respiratory therapists to place PICC lines was beyond the scope of practice for respiratory therapist and to point out that the new law allowed for insertion and care of peripheral arterial lines and starting intravenous lines for respiratory therapy patients and not for non-respiratory patients simply because of long-term intravenous needs.
- **8.** Rulings and Advisory Opinions; Personal Appearance; Public Immunization. Michele Eichhorn, R.N., along with her husband, made a personal appearance in connection with their request for approval of a public immunization program. Ms. Eichhorn, answered questions regarding CDC immunization guidelines and protocols for administration of vaccinations. Following their dismissal, it was the consensus of the Board to approve the public immunization program with acceptance of various stipulations.
- **9.** Rulings and Advisory Opinions; Respiratory Therapy; Scope of Practice; Nebulizer Equipment. The Board reviewed correspondence received from Michelle Roberts, Legal Intern, Praxair Law Department, Praxair, Inc., requesting an advisory opinion on whether instructions regarding nebulizer equipment and usage may be given over the phone by a licensed respiratory therapist to a patient receiving treatment in the home. Following review and discussion, it was the consensus of the Board to inform Ms. Roberts that the Respiratory Therapy Practice Act reserves to licensed respiratory therapists the authority to provide instructions concerning home medical equipment and its usage, and that in the Board=s opinion that would mean the initial instructions should be provided in person and any follow-up instructions can be over the phone.
- **10.** Communication and Information; National Board of Osteopathic Medical Examiners, Inc. The Board reviewed the communication received from John R. Gimpel, D.O., M.Ed., Vice President for Clinical Skills Testing extending an invitation to members of the Board to visit the testing site located in Conshohocken, Pennsylvania. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board authorized Drs. Dawson, Sheppard and Marier to attend the testing facility.
- 11. Communication and Information; Gehl Davis, M.D. The Board reviewed correspondence received from Gehl Davis, M.D. requesting the Board=s opinion on a number of scenarios resulting from natural or man made disasters. Following review and discussion, it was the consensus of the Board to inform Dr. Davis that in all situations, it would be necessary for the physician to attend to or arrange for others to care of his/her patient, investigation into any potential infraction of the Louisiana Medical Practice Act would be on a case by case basis, and, therefore, the Board does not feel it appropriate to respond to the hypothetical situations.
- **12.** Communication and Information; Louisiana State Medical Society. The Board reviewed the communication received from the Louisiana State Medical Society extending an invitation to Dr. Amusa to report on the activities of the Board for the past year to the House of Delegates= annual meeting scheduled for September 27-29, 2007 in Baton Rouge. Dr. Amusa reported she will make the presentation at the annual meeting. No further action was required or taken on this matter.

- **13.** Communication and Information; Food and Drug Administration. The Board reviewed the information received from the Food and Drug Administration regarding the use of Zelnorm for qualifying patients. No further action was required or taken on this matter.
- 14. General Administrative Matters; Financial Reports.

<u>Financial Statement</u> - The Board reviewed a statement on the revenue and expenses for the period ending June 30, 2007 and approved all expenditures as noted therein. The Board also reviewed the status of investments as of June 30, 2007. The Board also reviewed a balance sheet and income statement for Clinical Laboratory Personnel for the period ending June 30, 2007, and approved all expenditures as noted therein. The Board also reviewed the status of investments for Clinical Laboratory Personnel as of June 30, 2007.

<u>Audit</u> - The Board reviewed the audit of financial statements for the period ending December 31, 2006 performed by the independent auditing firm of Hienz & Macaluso, LLC. No further action was required or taken on this matter.

- **15. General Administrative Matters; President=s Report**. The Board received the report of the President on her activities since the last meeting of the Board. Dr. Amusa asked Dr. LeBlanc to give a brief report on his activities as member of the Federation of State Medical Boards, Board of Directors. Dr. LeBlanc reported on his visit to the South Carolina Medical Board. No further action was required or taken on this matter.
- 16. General Administrative Matters; Executive Director=s Report. The Board received the report of the Executive Director on his activities since the last meeting of the Board. Dr. Marier reported on the facility planning project, the request to seek approval for Special Officer Commissions for the investigators, questions to be considered on the physician renewal application, assessing legal costs associated with investigations, request from the Board of Nursing to assist with the promulgation of rules relative to Act 451 of the 2005 Regular Session of the Legislative, which provides for the performance of certain tasks by direct service workers in an individual=s residence, and appointment to the Integrative and Complementary Medicine

Advisory Committee. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board authorized Dr. Marier to appoint Drs. Rai and Nelson to the Integrative and Complementary Advisory Committee and any others, if the current members were unable to serve.

- [17.] Physicians Health Committee. On motion of Dr. Bourgeois, the Board convened in executive session to consider the report of Dr. Amusa on the meeting of the Physicians Health Committee held at 1:15 p.m., Monday, August 20, 2007, and as fully reported in the minutes thereof. Following the review, the Board resumed in open session. Upon motion made, duly seconded and passed by majority voice vote, the Board made the following decisions:
 - a) <u>Brazeel, Steven McCrae, M.D.</u> To accept the Consent Order in the matter of Steven McCrae Brazeel, M.D. placing his license on probation for a period of three years.¹
