A meeting of the Louisiana State Board of Medical Examiners, pursuant to call of the President and lawful notice, was duly convened and called to order at 8:30 a.m., Monday, June 18 2007, by order of the President, at the offices of the Board, 630 Camp Street, New Orleans, Louisiana.

- 1. VX Systems, Inc. VX Systems, Inc, gave a presentation on the IT infrastructure development of the website, investigation module and on-line renewal process. No further action was required or taken on this matter.
- **2. Minutes of April 2007.** The Board reviewed the minutes of its meeting of April 16, 2007. Motion was made by Dr. Gage-White, seconded, and unanimously carried, to approve the minutes of the meetings together with the executive sessions conducted during such meeting with all necessary corrections.
- **3.** Confirmation of Interim Board Actions. The Board reviewed the Interim Board Actions in the matters of Cynthia Lynn Diglis, M.D., Tara Odom Mercer, and Vinicio E. Madrigal, M.D., in which the Board voted to invoke the Sick Physician Statute in the matter of Cynthia Lynn Diglis, M.D., and invoke the Sick Physician Statute and summarily suspend the licenses of Tara Odom Mercer and Vinicio E. Madrigal, M.D. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board affirmed the interim Board actions.
- 4. Status Report on Action Items of Prior Board Meetings; Report on Assignments to Counsel. The Board noted that all action items as assigned to staff and counsel from previous meetings had been completed.

5. Rules and Regulations.

- a. Final Rules/Amendments: None published since the last meeting of the Board.
- b. Rules/Amendments: Noticed for Intent: Physicians and Surgeons; Collaborative Drug Therapy: Act 627/SB 679 (2006 Regular Session of the Louisiana Legislature) amended the pharmacy law to provide that the Board and the Pharmacy Board shall publish Notice of Intent of rules dealing with collaborative drug therapy management within 120 days from the effective day of the amendment, i.e., August 15, 2006 or by December 15, 2006 at the latest. (See SB679 for further details). A draft was prepared and circulated to the Executive Director of the Pharmacy Board for discussion. A draft of the rules was then provided to the Board at its meeting of September 18, 2006 for consideration and discussion. A special call meeting was held on October 13, 2006, to review further revisions to the proposed rules. Following discussion, the Board authorized publication of a Notice of Intent to adopt the rules in the November 2006 edition of the Louisiana Register. During the twenty-day period prescribed for a public hearing (ending December 11, 2006) no requests were received for a public hearing. Three written comments were received all dated December 21, 2006, the last day of the written comment period. Due to certain discrepancies between the rules noticed by the Board and the Pharmacy Board, discussions were held between representatives of both boards and modifications were proposed to each of the rules. The modifications resulted in both rules becoming duplicates of each other. These suggestions were considered and approved by the Board during its meeting of February 12, 2007, following which the Board determined to provide Notice of Intent in the Louisiana Register of substantive changes to the rules previously proposed, hold a hearing to receive comment with respect to the proposed changes. In accordance with such Notice of Intent, a joint public hearing of the Board and the Louisiana

State Board of Pharmacy was held at the offices of the Board on April 20, 2007 to receive comments on the proposed substantive changes to the proposed rules. The transcript from the joint public hearing was considered at its meeting of June 18, 2007. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board approved promulgation of the rules in the August edition of the Louisiana Register along with the final report to be submitted to the Legislative Committees. Physicians and Surgeons -Temporary Permits (Visiting Physician, Professor, Short-Term Residency/Preceptorship Permit) - In view of difficulties experienced by applicants for certain short-term permits, staff proposed certain amendments to eliminate administrative burdens, delays and costs currently associated with the processing of restricted provisional temporary permits issued by the Board to visiting physicians who provide a service to the citizens of this state, to visiting professors who provide instruction or education to Louisiana physicians or graduate medical students, and to those physicians who rotate through a short-term residency program or serve a preceptorship in a medical school or accredited institution in this state for purposes of graduate medical education. Proposed amendments were presented to the Board for consideration at its meeting of December 11, 2006 to address several items. First, the amendments would allow these applicants and the Board to forego submission, collection and processing of criminal history record information. That process typically takes ninety days and is impractical with respect to the restricted provisional nature of these temporary permits given that applicants are in the state but for a brief period of time. Often visiting physicians are in Louisiana as little as one day to attend to a single patient but in no event more than ninety days. In addition, all of these permittees will be vouched for and performing under the inviting Louisiana physician (visiting professor, physician), medical school or institution (visiting residency/preceptorship). Second, the proposed rule amendment will eliminate the need for a personal appearance (short-term residency and preceptorship permits), and facilitate the Board-s use of electronic technology for processing forms, applications and conducting its own verification of licensure status in other states and for the other purposes specified in the proposed amendments. Finally, inasmuch as visiting physicians and professors provide a valuable service to the citizens of this state by attending to Louisiana patients and educating Louisiana physicians, the proposed rule amendments also allows the Board to waive the \$100 fee for the approximate 20-30 anticipated number of annual applicants for these categories of restricted temporary permits. Louisiana citizens who receive healthcare services from physicians issued restricted provisional temporary permits under the proposed rule amendments, and Louisiana physicians, graduate medical student who receive instruction and training (and in turn their current and future patients who are citizens of this state) will receive an unquantifiable benefit by virtue of the expertise of visiting physicians and/or professors. The Board authorized publication of a *Notice of Intent* to adopt the rules in the *Louisiana Register* which appeared in the February 20, 2007 edition. It is anticipated that the rules will become final upon promulgation in the July edition of the Louisiana Register.

c. <u>Rules Under Development</u> - <u>Respiratory Therapy</u>. The Advisory Committee for Respiratory Therapy had prepared a number of amendments to Chapter 25 (46XLV.2501-2569) of the respiratory therapy rules (Licensure). Dr. Ferdinand, the Board-s liaison to the Committee and counsel reviewed the proposed amendments and worked with the Committee to develop a more comprehensive draft for the Board-s consideration. In December 2005 a further draft, containing additional modifications not previously addressed, was received by the Board, along with suggested revisions to the Respiratory Therapy Practice Act. Following review and discussion, the Board determined to defer the rule-making effort pending outcome

of legislative consideration of proposed amendments to the Act. In the interim, Dr. Ferdinand, counsel and staff met with representatives of the Advisory Committee to discuss and assist with revisions to the Respiratory Practice Act. A copy of the Committees suggestions for revisions were considered by the Board at its meeting of February 12, 2007. HB 251 is making its way through the legislative process. Presuming the legislative effort is successful, Dr. Ferdinand will request the RTAC to review the current rules to ascertain what modifications may be needed to the rules in light of changes to the Act. Midwifery: The Midwifery Advisory Committee suggested a number of amendments to the Board-s midwifery rules on licensing, 46XLV.2301-2373 and practice, 46X:V.5301-5363. Members of the Committee met with the Board during its January 2005 meeting to discuss their suggestions. The Board reviewed the proposed amendments at its meeting of February 15, 2005 and appointed a Subcommittee to study the issue and report their recommendations to the full Board. Subcommittee studied the Advisory Committees suggestions and provided draft recommendations for their review and discussion. A reply to the Subcommittee=s recommendations, dated June 26, 2006, was received, and the Subcommittee met during the July 2006 meeting and accepted some of the recommendations and rejected others. A revised draft was sent to the Advisory Committee on August 8, 2006 with the request that any final modifications be received in time to place a final draft on the September 2006 agenda for the Board-s consideration. The Midwifery Advisory Committee and several individual midwives expressed concern over several areas of the proposed revisions and requested a meeting, A meeting was held between the Subcommittee and the Advisory Committee in November 2006 to discuss their concerns. A revised draft was forwarded to the Midwifery Advisory Committee in January 2007 and a reply was received accepting the changes in February 2007, but providing further recommendations on one section of the rules. A further draft to address this issue was sent to the Committee in March. Its reply was received June 4, 2007 and was disseminated to the Subcommittee for review and finalization. The Subcommittee accepted the suggested revisions contained in Kathy Acree-s letter dated May 29, 2007. A draft of the proposed rules was considered by the Board at its meeting of June 18, 2007. Upon motion made, duly seconded and passed by unanimous voice vote, the Board authorized publication of a Notice of Intent to amend the rules in the Louisiana Register. Perfusion The Advisory Committee for Perfusionists submitted a rough draft of rules for the Board-s consideration. Following review and discussion, the Board appointed Dr. Ferdinand and Board counsel to work with the advisory committee in the formulation of administrative rules relating to the licensure and practice of perfusion in this state. Dr. Ferdinand and counsel met with the Advisory Committee Chair to assist in developing a more comprehensive, focused draft of rules for the Board-s consideration. As soon as the draft is received, reviewed and Dr. Ferdinand has had an opportunity to confer with the Advisory Committee and a draft of the proposed rules is finalized, it will be presented to the Board for consideration. *Physicians and Surgeons*; Registered Dispensing Physicians; Licensure and Practice: The Board is studying its existing rules governing registered dispensing physicians relative to controlled substances to determine if modification is in order. Physicians and Surgeons - Mid-Level Providers: The Board appointed a Committee to work on the development of rules relative to supervision, collaboration and consultation with mid-level providers. Physicians and Surgeons - Rural Physician Self-Referral. In 2006 the Louisiana legislature adopted Act 819, prohibiting Louisiana licensed physicians from making any referral for services to a healthcare facility located in the primary service area of a rule hospital, in which the referring physician or an immediate family member owns a direct or indirect ownership interest. The Act provides relevant exceptions and requires the Board to adopt rules and regulations providing that violation of the law provides cause for action against the physician-s license. The draft rule was presented to the Board for consideration. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board authorized publication of a *Notice of Intent* to adopt rules in the next issue of the *Louisiana Register*.

- **6.** Rulings and Advisory Opinions; Respiratory Therapy; Wound Care Treatment. The Board reviewed correspondence received from C. David Belden, B.S., RRT, Director of Respiratory Therapy, MeadowsBrook Specialty Hospital, Lafayette asking whether wound care treatment is within the scope of practice for respiratory therapy.. Following review and discussion, it was the consensus of the Board to inform Mr. Belden that wound care treatment is not within the scope of practice for respiratory therapy.
- 7. General Administrative Matters; Personal Appearance; Jay Weiss, M.D., Medical Director, Palmetto Addiction Recovery Center. Jay Weiss, M.D., Medical Director Palmetto Addiction appeared before the Board to discuss the role of Palmetto Addiction Recovery Center in the recovery process for people suffering from substance abuse. Dr. Weiss gave a power point presentation, which showed the history and philosophy of PARC. No further action was required or taken on this matter.
- **8.** Rulings and Advisory Opinions; Scope of Practice; Podiatry. The Board received correspondence from Vernon Garber, DPM, seeking an advisory opinion on whether noninvasive vascular testing of the lower extremity is within the scope of practice for podiatric physicians. Following review and discussion, upon motion made and passed by majority voice vote¹, the Board voted to inform Dr. Garber that it was the preliminary view of the Board that noninvasive vascular testing of the lower extremity was not within the scope of practice for podiatric physicians. However, the Board would seek the advice of its advisory committee, and if necessary consider the matter at a subsequent meeting.
- 9. General Administrative Matters; Financial Reports.

<u>Financial Statement</u> - The Board reviewed a statement on the revenue and expenses for the period ending April 30, 2007 and approved all expenditures as noted therein. The Board also reviewed the status of investments as of April 30, 2007. The Board also reviewed a balance sheet and income statement for Clinical Laboratory Personnel for the period ending April 30, 2007, and approved all expenditures as noted therein. The Board also reviewed the status of investments for Clinical Laboratory Personnel as of April 30, 2007.

- **10. General Administrative Matters; President=s Report**. The Board received the report of the President on her activities since the last meeting of the Board. Dr. Amusa discussed meeting the Board=s staff at further meetings of the Board and legislative updates.
- 11. General Administrative Matters; Executive Director=s Report. The Board received the report of the Executive Director on his activities since the last meeting of the Board. Dr. Marier discussed the current legislative sessions, the Board Orientation online and the requirement of supervising physicians to submit to the criminal background check. Following review and discussion, upon motion made, duly seconded and passed by unanimous voice vote, the Board authorized the elimination of the criminal background check for physicians applying as supervising physicians of a physician assistant.
