Edipeel is a food additive approved for use under Commission Regulation (EU) 2019/801 of 17 May 2019 amending Annex II to Regulation (EC) No 1333/2008—and retained under the provisions of the United Kingdom's exit from the European Union effective January 1, 2021—as a glazing agent for citrus fruit, melons, pineapples, bananas, papayas, mangoes, avocados, and pomegranates at levels of quantum satis.¹ Edipeel is allowed for use on all fruits and vegetables in Australia, Canada, Chile, China, Colombia, Japan, Kenya, Mexico, New Zealand, Peru, South Africa, and the United States, without restriction. Edipeel may be allowed for use in additional countries or regions not listed here.

Edipeel is composed of food grade mono- and diglycerides of fatty acids (E 471) derived from plants.
