#### MONTHLY PERFORMANCE COMMENTARY

Third Point Investors Limited returned 2.8% on a NAV basis in October 2022, compared with a 7.2% return for the MSCI World Index and an 8.1% return for the S&P 500 Index. During the month the Company's share price gained 5.3%, reflecting a tightening in the discount to NAV from 17.0% to 15.0%. The top contributors for the month included utility company Pacific Gas & Electric Co., media and entertainment company The Walt Disney Co., and internet media company Twitter Inc. The top detractors for the month included healthcare company Cano Health Inc., enterprise cybersecurity company SentinelOne Inc., and a short position.





Unless otherwise stated, information relates to the Third Point Offshore Master Fund L.P. Exposures are categorized in a manner consistent with the Investment Manager's classifications for portfolio and risk management purposes in its sole discretion.

Performance results are presented net of management fees, brokerage commissions, administrative expenses, and accrued incentive allocation, if any, and include the reinvestment of all dividends, interest, and capital gains. While incentive allocations are accrued monthly, they are deducted from investor balances only annually or upon withdrawal. From Fund inception through December 31, 2019, Third Point Offshore Fund, Ltd.'s historical performance has been calculated using the actual management fees and incentive allocations paid by the Fund. The actual management fees and incentive allocations paid by the Fund reflect a blended rate of management fees and incentive allocations based on the weighted average of amounts invested in different share classes subject to different management fee and/or incentive allocation terms.
