

This End User License Agreement (“EULA”) defines the terms and conditions under which you are permitted to install and use the font software created and distributed by Kimera. By downloading, installing, or using any Kimera Font Software, you acknowledge that you have read, understood, and agree to be bound by this Agreement.

1.	Parties & Definitions
Supplier Licensee	Kimera (Michael Clasen) The business entity for which the Typeface is used.
Purchaser	A person or company purchasing the License on behalf of the Licensee.
Font Software	The digital font files created and distributed by Kimera.
License Type	The specific use-case purchased (e.g. Desktop, Web, App).
Company Size	The total number of employees working for the Licensee as a single legal entity (e.g. Acme GmbH).
First Designer	The first external designer, design studio or developer working for the Licensee and using the Fonts for the Licensee’s project.
Third Party	Any additional supplier, agency, contractor or vendor using the Fonts for the Licensee (e.g. developers, printers, marketing agencies, post-production studios).
2.	Grant of License
Kimera grants the Licensee a non-exclusive, non-transferable, perpetual right to install and use the Font Software within the scope of the purchased License Type(s). All rights not expressly granted remain with Kimera.	
3.	Ownership
The Font Software and all its design and code components are protected by copyright and remain the exclusive property of Kimera. This Agreement grants usage rights only; ownership is not transferred.	
4.	Company Size
License fees are determined by the Licensee’s total number of employees as a single business entity. If other legal entities within the same corporate group use the Fonts, each must obtain a separate license. Providing incorrect or incomplete Company Size information may require a license upgrade and may constitute a breach of this Agreement.	
5.	Purchase on Behalf of a Client
5.1	It is permitted to purchase Licenses on behalf of a client.
5.2	The client must be registered as the Licensee during checkout.
5.3	The Purchaser represents and warrants that they are authorized to act for the Licensee.
5.4	The License is granted solely to the Licensee.
5.5	The Purchaser obtains no rights in their own name, unless acting as the First Designer covered under the Licensee’s base License.
5.6	The Purchaser may install and use the Fonts only to create work for the Licensee within the licensed scope.

5.7	If the invoice is issued to the Purchaser, they must forward the invoice and this EULA to the Licensee without delay.
5.8	Fonts may not be resold. Service fees may be billed separately.
5.9	Any false or incomplete information (Licensee name, Company Size, or lack of authorization) constitutes a material breach and may result in termination or require a new License.
6.	First Designer
The First Designer working for the Licensee is automatically covered under the Licensee’s base License and may use the Fonts to produce assets for the Licensee.	
7.	Third Party License
For any additional third parties, the Licensee must obtain a Third Party License add-on. A Third Party License allows such parties to install and use the Fonts solely to produce or modify assets for the Licensee, within the purchased License Type(s). Third Parties must stop using the Fonts once their work for the Licensee is completed. Fonts may not be used for other clients, internal branding, or self-promotional work beyond the licensed context. Third Parties may include, for example, external designers, developers, marketing agencies, printers, or post-production companies.	
8.1	Desktop License
With a purchase of a Desktop License, the Licensee obtains the right to install the Font Software on computers. It may be used in desktop publishing software such as Adobe In-Design, Illustrator, Microsoft Word, PowerPoint, and similar applications. The Font Software may be used to create any printed or digital documents, merchandise, objects, or signage for one brand. The License covers both static and motion content (e.g. animations, video titles, moving images). The Font Software may only be shared with external collaborators (e.g. printers, developers, or post-production partners) if they hold a valid Third Party License.	
8.2	Web License
By purchasing a Web License, the Licensee is granted the right to embed the Font Software on one website domain owned by the Licensee. Only the original Font Software provided by Kimera may be used. The Fonts must be stored on the same server associated with the licensed domain. Technologies other than @font-face are not permitted, and the use of third-party hosting or web-font services is strictly prohibited.	
8.3	App License
The Font Software delivered with an App License may be embedded in one digital application owned by the Licensee. The Font may be used during development and within the distributed version of that application. Each additional application, title, or software product requires a separate License.	
8.4	Social Media License
A Social Media License grants the Licensee the right to use the Font Software to create assets for social media platforms. A Desktop License must be purchased and registered to the Licensee prior to obtaining a Social Media License. This License allows the creation of images, videos, and motion content for publication on the Licensee’s official accounts.	

8.5	Broadcast License
A Broadcast License grants the Licensee the right to use the Fonts for broadcasting and streaming purposes. This License is required for creating video content for streaming platforms such as YouTube, Netflix, Vimeo, Twitch, as well as for television, cinema, and commercial film use.	
8.6	Logo License
A Logo License grants the Licensee the right to use the Font Software for the creation of a logo or wordmark for one brand. The use of this logo or wordmark is not limited by the restrictions of other License Types. The logo or wordmark may be converted to outlines. For an additional brand, an additional License must be purchased.	
8.7	Student License
A Student License authorizes the Licensee to use the Font Software for private and private-commercial purposes only, and exclusively while being enrolled as a student. Private-commercial purposes are defined as cases where no client or third party is involved. The Licensee may use the Fonts to create personal commercial work but must purchase additional Licenses for any third-party or client-related use.	
8.8	Corporate License
The purchase of a Corporate License grants the Licensee the right to use the Font Software for all use cases, regardless of company size. Specific details must be discussed with and confirmed by Kimera. The Corporate License is intended for larger organizations managing multiple internal departments, channels, and media.	
8.9	Trial License
A Trial License allows the use of the Font Software for testing purposes only. Commercial or public use is prohibited. The Font Software may, however, be used by designers to pitch design directions to clients. This License includes the full character set of the Font Software.	
8.10	Custom Typeface License
Custom Typeface projects commissioned by the Licensee are governed by the Kimera Custom Typeface License Addendum. All general terms of this EULA remain in effect. In case of conflict, the Addendum shall prevail.	
9.	Modifications
You are not allowed to convert, modify, or rename the font software under any circumstance. Any modifications must be discussed with the Supplier as a bespoke project.	
10.	Purchase and Transfer of Licenses
Licenses are not transferrable to other brands or individuals. It is allowed to purchase the font software on behalf of a client. The client must be registered as the Licensee during the purchase, informed about this agreement, and provided with the invoice related to the purchase. The client has to accept this agreement. You are not authorized to invoice your client at another price as the one displayed on our site.	
11.	Limited Liability
Although every effort has been taken to produce the font software to the highest standards, in no circumstance whatsoever will the Supplier be liable to you for any consequential, indirect, incidental, punitive or special damages including any lost profits, lost data or lost savings. All font software installed is done so at the Licensee’s risk.	

12.	Termination
If you breach this contract all of your rights automatically end and you have to stop using the font software from this moment on. In addition to any legal recourse we have, you’ll need to pay for any costs we incur, like legal fees, investigation costs, and legal settlements. Reinstatement requires purchase of a new License.	
13.	Miscellaneous
Any breach of the terms of this agreement shall be cause for termination. The use of font software in any racist, homophobic, transphobic, or sexist context is prohibited. We will pursue legal action if you are found to be using our fonts illegally. We reserve the right to update this agreement at any time without prior consent or notice. You acknowledge that you have read, understood, and agreed to be bound by the terms and conditions of this agreement.	
14.	Governing Law
This Agreement is governed by the laws of Germany. Exclusive jurisdiction lies with the courts of Munich, Germany. If any provision is held invalid, the remainder of this Agreement shall remain in force.	
15.	Acceptance
By downloading, installing, or using the Font Software, the Licensee (and, where applicable, the Purchaser) confirms that they have read, understood, and agree to be bound by this Agreement.
