## EU-Chemical Regulation REACH

**AF-Color®, AF-Carbon®, AF-Complex®, AF-Clean®, AF-Eco®, AF-CirCarbon®, AF-CirComplex®, AF-CirColor®**

Dear Sir or Madam,

The products, being launched by our company, concern "mixtures" by definition. Therefore, a registration under Art. 2 Nr. 9 of the REACH regulation is not necessary at ECHA, as well. As the case may be, substances must be registered, being used for the preparation of these products. Thus, we cooperate closely with our raw-material suppliers. In the course of this cooperation, we assure that our raw-material suppliers act in a REACH-conform way and have their products registered in due time.

A further component of REACH is the so-called candidate list (SVHC = Substances of Very High Concern). This list includes substances, ECHA is especially interested in. The current candidate list can be found on the homepage of ECHA: [SVHC-List](#).

We confirm that we do not use substances according to the SVHC-list of 25<sup>th</sup> of June 2025. Furthermore, we confirm that substances listed until 25<sup>th</sup> of June 2025 in Annex XVII of REACH (Substances restricted under REACH) are used in compliance with the restrictions specified therein. Substances listed in Annex XIV of REACH ("Authorisation List") are not used by AF-COLOR branch of AKRO-PLASTIC GmbH. Because AF-COLOR branch of AKRO-PLASTIC GmbH does not use any substances of very high concern and the raw materials used by us do not contain SVHC > 0,1% mass fraction, the so-called "SCIP notification", i.e. an entry of the products manufactured and distributed by us into the SCIP database, is not necessary.
