\$1,000 Annual Scholarship for Book Lovers

The \$1,000 Annual Scholarship for Book Lovers (the "Scholarship") seeks to empower ambitious students to achieve more through access to postsecondary education. The awards are offered in the US only for study at colleges, universities and vocational-technical schools.

Scholarship eligibility

Students are eligible to apply for the Scholarship provided that they:

- are citizens of the United States;
- are at least 16 years old;
- are in their final year of high school, secondary school, (upper) secondary school graduates, or current college/university undergraduates;
- have a high school cumulative GPA of 3.0 or higher;
- demonstrate leadership at school and/or in the community; and
- will be enrolled in full-time undergraduate study at an accredited college, university, or vocational-technical school within the United States for the entire academic year in which the Scholarship is awarded.

The Scholarship is non-renewable. A total of 1 (one) scholarship will be awarded each year.

How to apply

You, the student, are responsible for gathering and submitting all required information. This is a competitive program. Your application is evaluated on the information supplied; therefore, answer all applicable questions as completely as possible.

Our next Scholarship cycle will open each year starting from 2024 on January 31 and applications will be accepted until by 3:00 p.m. Central Standard Time, April 15. Applications must be submitted electronically to email address scholarship@makeheadway.com with a subject: "Application — [your name] — [year of applying] — Headway Scholarship" (i.e., Application — George Hale — 2024 — Headway Scholarship).

As part of the application process, you will be asked to submit the following:

1. Information about you:

- your full name, address, and phone number;
- activities, Awards, and Honors;
- information about the post-secondary school you plan to attend; and

- your educational and career goals.
- 2. A current, complete transcript of grades (academic record). Transcripts must display student name, school name, grades and credit hours for each course and term in which each course was taken.
 - Students in their final year of high school/secondary school and students who have not completed a full year of college/university must send copies of their official final grades/ marks from the past three or four years of (upper) secondary school and copies of their end-of-year exam results if applicable; or
 - Students who have completed one full year or more of college/university level courses should send a copy of their official college/university academic record for each year through the most recent grading/marking period.
- 3. Essay OR Video. Share your vision for a non-fiction book that has the potential to become a timeless handbook for humanity. The task involves presenting a well-thought-out explanation as to why the chosen book holds this significant role. You have the flexibility to express your ideas either through a written essay, limited to a maximum of 500 words, or through a video presentation on YouTube not exceeding 2 minutes in duration. If you opt for a video presentation, please include a link to your video on YouTube with the title "Headway App Scholarship for Book Lovers [year]" (i.e., Headway App Scholarship for Book Lovers 2024). Additionally, in the video description, provide the following text: "Embark on my vision for a timeless non-fiction handbook in my Headway App Scholarship submission. Explore the essence of my proposed book and its literary significance. Join the discussion and visit https://makeheadway.com/ to enhance your reading experience with Headway, a dynamic book summary app!"
- **4.** A letter of recommendation. The letter must be from a faculty or staff member at your school or a member of the community that has worked with you in a supervisory role. The letter of recommendation should be original and should not be duplicates of college recommendation letters. Applicants are not permitted to include relatives as references.

All correspondence throughout the application process is sent by email. It is YOUR RESPONSIBILITY to monitor your email account for messages from us. Students failing to provide a valid, active email account that will accommodate bulk mail may not receive consideration.

How are recipients selected and notified

Scholarship recipients are selected on the basis of financial need, academic record, demonstrated leadership and participation in school and community activities, a statement of goals, and an outside appraisal.

All applicants will be notified by email in June.

Correspondence throughout the application process will be by email. Students failing to provide a valid active email account that will accommodate bulk mail may not receive consideration.

This is a competitive program. Not all applicants to the program will be selected as recipients.

Selection of recipients is made by the Company's representatives. All applicants agree to accept the decision as final.

What are the details of the award and how and when are scholarships paid

The amount of Scholarship award is USD 1,000 each year. Payment is made in one installment in July. Requests for alternate payment schedules and check processing will be considered on an individual basis and cannot be guaranteed. Payments will be made via wire transfer to the recipient. The Scholarship may be used to pay for tuition, books, lab fees, and other related education expenses. Any portion of the Scholarship used for other than non-taxable expenses must be reported as income on the Recipient's tax returns. It is the Recipient's responsibility to report any tax liability thereunder. The Company does not cover any tax related expenses.

Obligations

- Recipients must complete and submit a signed Scholarship Acceptance Form before funds can be processed.
- Recipients must notify their school about the award and deliver the scholarship check to the school in a timely manner.
- Recipients are required to notify Scholarship America of any change in address, school enrollment or other relevant information and to send a complete transcript when requested.

Terms and Conditions

The Company may suspend, change, or terminate this program at any time without prior notice. The interpretation, application and administration of these program provisions shall be determined by the Company at its sole discretion.
