

illimity Bank S.p.A. ("illimity") is the parent company of the Group of the same name.



Everything began in January 2018 when SPAXS S.p.A. ("SPAXS") was launched, becoming the largest Italian Special Purpose Acquisition Company and one of the biggest in Europe. The focus was to acquire and capitalise a company in the banking industry, with €600 million raised.

illimity is a new paradigm bank that specialises in lending to SMEs, using a truly innovative and highly technological business model.



The purchase of Banca Interprovinciale S.p.A. ("Banca Interprovinciale") in 2018 and the merger with SPAXS formed the basis for the creation of illimity Bank, which since the 5th of March 2019 is listed on the Italia Stocj Exchange's MTA equities market and since the 10th of September 2020 on the STAR segment.

illimity specialises in lending to SMEs that have real potential, acquires secured and unsecured distressed corporate credits, to then service these using its platform — Neprix — and it offers innovative direct digital banking services for retail and corporate customers through illimitybank.com. Moreover, illimity SGR sets up and manages Alternative Investment Funds, the first of which is dedicated to UTP credits.



Lastly, with **abilio** - the Group company specialized in digital intermediation - it manages the sale of real estate and capital assets.




