


Finland currently has no cash prize charity lotteries due to the monopoly on all gambling activities in the country, held by *Veikkaus*. Its lottery products generate approximately €375 million annually for the Finnish state budget through state ownership. The Finnish government plans to partially end this monopoly in 2026, however the changes will only allow online casino and betting operators and will not open the market for cash charity lotteries — despite their potential to deliver significant benefits to civil society.



Charity lotteries could generate up to €150 million in additional funding for Finnish civil society each year!

A series of research reports, commissioned by the Association of Charity Lotteries in Europe and produced by Regulus Partners, show that charity lotteries:

- Have great potential to raise more funds for charities in Finland;
- Would complement the existing lottery activities of Veikkaus, by growing the overall lottery market:
- Are a low-risk product that would have a positive impact on Finnish civil society.



## What can be done?

- Urge a review of Finland's gambling reform plans
  The government should reconsider its 2026 partial
  demonopolisation and create a policy framework that
  would allow low-risk charity lotteries to raise essential
  funds for Finland's civil society.
- Include charity lotteries in the reform

  Excluding them from the partial demonopolisation would be a major missed opportunity. Across Europe, charity lotteries provide stable, long-term funding for CSOs blocking them in Finland denies vital resources to civil society.
- Promote a balanced and responsible market
  Allowing low-risk charity lotteries alongside tighter
  controls on high-risk gambling would support harm
  reduction while ensuring that part of the gambling
  market benefits the common good.

With endorsement of these policy recommendations, we hope the Finnish government will take action to create an enabling policy environment that allows charity lotteries to raise substantial and much-needed funds for Finnish civil society.
