#### **REGULATIONS:**

FASHION & ACCESSORIES OPEN DAYS – WIN A €250 SHOPPING VOUCHER "Visit the Fashion & Accessories Open Days and win €250 in store credit."

#### **Article 1: General**

- 1. These terms and conditions (hereinafter the "Regulations") for the contest "Visit and get a chance to become one of the lucky winners of a €250 shopping voucher" (hereinafter the "Contest") apply to the promotion organized by BITM (Brussels International Trade Mart Ltd. and Co.) - 4. Participation in the Contest implies full and unconditional acceptance of these Regulations by the company. Failure to comply with these Regulations will automatically result in the invalidity of the participation and the loss of any rights to the prize, without the Organizer being held liable in any way. Participation is only possible in the manner described in these Regulations.

#### **Article 2: Conditions for Participants**

1. **Participation in the Contest** is only open to companies (with a valid VAT number)

that have access to Trademart or have applied for access.

- 5. The Organizer cannot be held liable for any damage or costs, of any kind, resulting directly or indirectly from participation in the Contest or the awarded prizes.
- 6. The participant acknowledges that participation is entirely at their own risk.
- 7. The Organizer cannot be held responsible for incorrect or incomplete information provided by participants, which may result in the loss of the prize.
- 8. If the Contest is canceled due to force majeure or in accordance with these Regulations, the Organizer shall not be held liable. The Organizer also disclaims responsibility for any technical issues.
