Telecoms Annual Price Changes

On 1st January each year the monthly charge for your Line Rental or Digital Voice Seat Rental (per line or seat) will increase by £1.00 during your agreed fixed term period.

Additionally, the monthly charge for Digital Voice Unlimited Landline & Mobile Calls Plan or Digital Voice Unlimited Calls Everywhere Plan will increase by £0.50 during your agreed fixed term period.

All other out of bundle charges will increase on 1st January each year by the Consumer Price Index (CPI) rate of inflation plus 3.9%.
