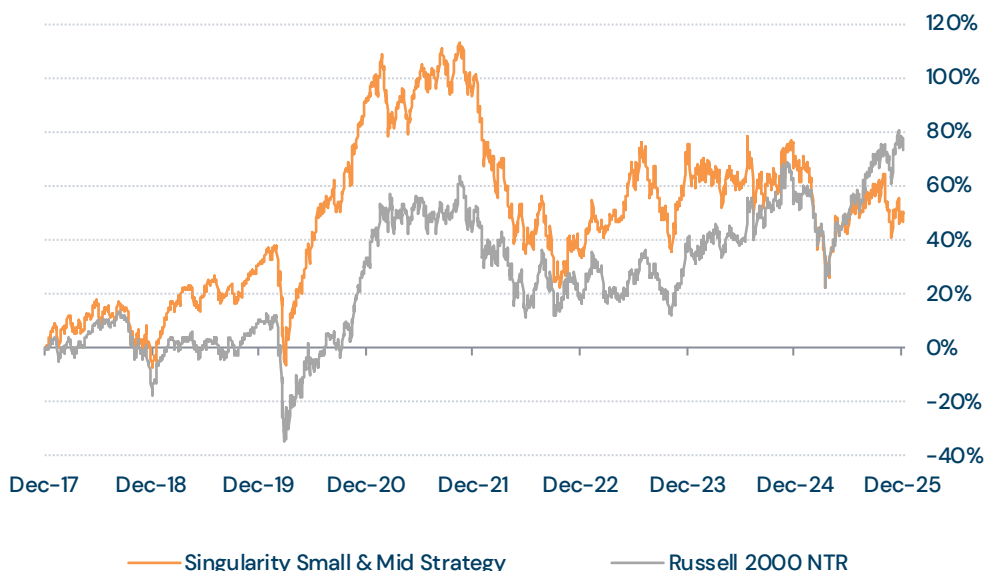
Investment Profile

The **Singularity Small & Mid AMC** identifies applied innovation within the Russell 2000 Index. The portfolio comprises a maximum of 100 small-cap companies, representing the next generation of applied innovation firms in the US. Portfolio construction follows The Singularity Group's (TSG) applied innovation screening methodology, selecting only listed companies that generate revenue from innovative products and services. This product is suitable for long-term investors seeking capital growth.

- A rigorous investment process screening for innovation cashflows, not expenses

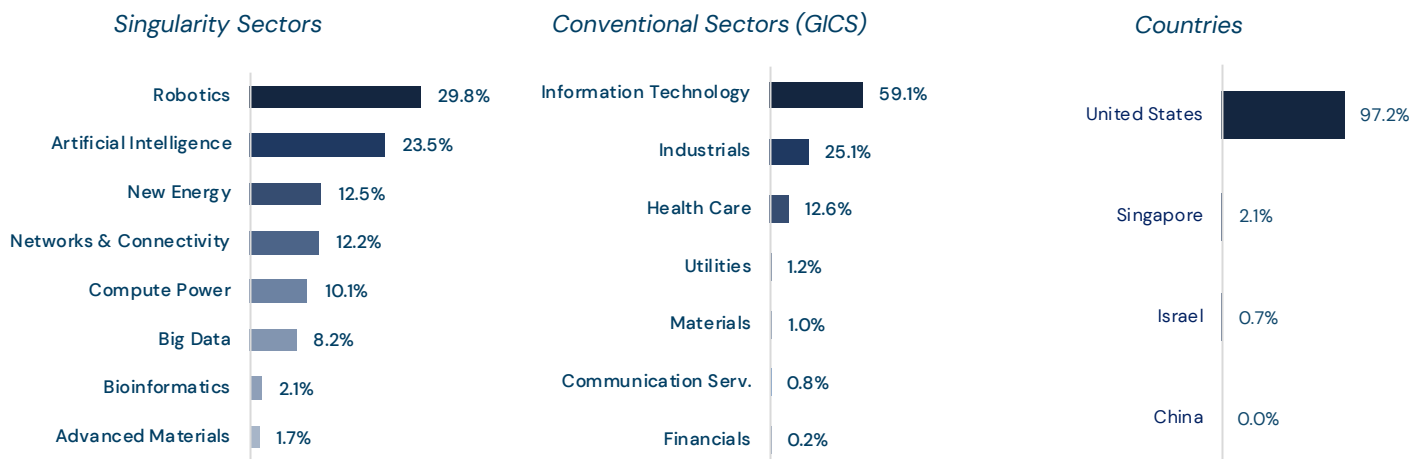

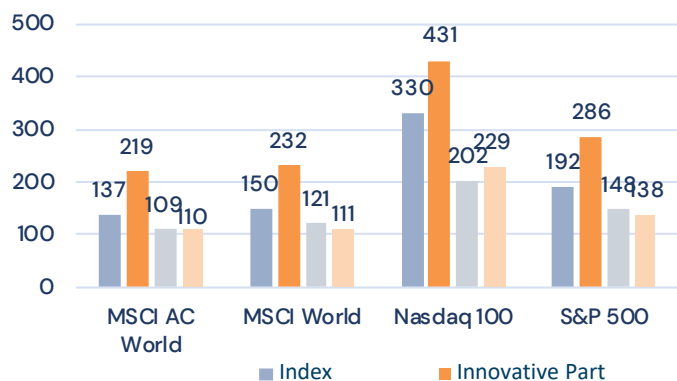

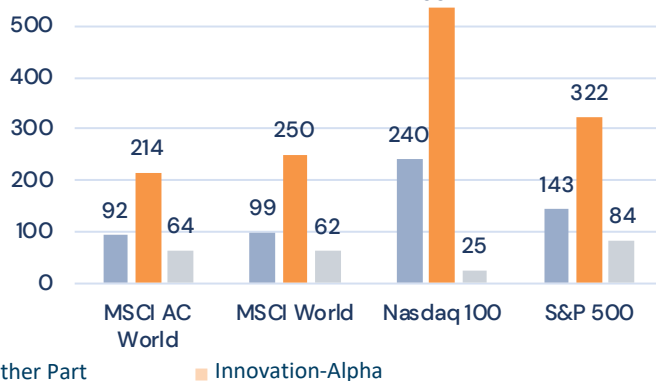
