# **TERMS AND CONDITIONS**

#### TERMS AND CONDITIONS OF THE REFER A FRIEND FREE PRIZE DRAW PROMOTION

#### 1. THE PROMOTION

which People's Postcode Lottery may be offering.

1.1. This promotion is available to players of People's Postcode Lottery aged 18 years and over who are resident in Great Britain, who play in the November 2025 draw, who have signed up to People's Postcode Lottery's Refer A Friend scheme at <a href="https://www.postcodelottery.co.uk/refer-a-friend">https://www.postcodelottery.co.uk/refer-a-friend</a> and who are not self-excluded with People's Postcode Lottery "the Referrer". This promotion is separate from any other referral promotions

If a person to whom the Referrer has provided their details in order to sign up through the People's Postcode Lottery Refer A Friend scheme "the Referred Friend":-

- is over the age of 18, resident in Great Britain and meets the other conditions to be accepted as a player of the People's Postcode Lottery;
- signs up with People's Postcode Lottery between 1 October 2025 (when this promotion starts) and 31 October 2025 (when this promotion ends) through People's Postcode Lottery's Refer A Friend scheme using the referral details provided to them by the Referrer;
- is either a new customer to People's Postcode Lottery or a previous customer who has not played for at least 24 months; and
- plays in the November 2025 lottery draws managed by People's Postcode Lottery;

the Referrer will be automatically entered into a Refer A Friend Free Prize Draw in which the prize shall be £10,000. In circumstances where there is more than one Referred Friend of a Referrer who satisfies the criteria specified above, the Referrer will receive one entry into the Refer A Friend Free Prize Draw for each such Referred Friend, subject to a maximum limit of 5 entries into the Refer A Friend Free Prize Draw. Any other applicable limits on rewards available to Referrers over a 12-month period in relation to any other referral promotions by People's Postcode Lottery are unaffected by this and will continue to apply.



### 2. SELECTION OF WINNERS

- 2.1 On 18 November 2025 the winner of the £10,000 will be randomly picked from all valid entries, using People's Postcode Lottery's randomisation software.
- 2.2 People's Postcode Lottery will check eligibility of winning participants prior to confirming the award of a prize. If the winner is found to be ineligible or if any potential winner does not comply with these terms and conditions, then the winner may in People's Postcode Lottery's sole discretion, be disqualified and an alternate winner, as applicable, may be selected.
- 2.3 People's Postcode Lottery's determination of any matter relating to eligibility or entitlement to a prize from the Refer A Friend Free Prize Draw shall be final and binding.
- 2.4 The winner of the Refer A Friend Free Prize Draw will be notified of their win by post, email and/or telephone within 30 days of the prize draw by a representative of People's Postcode Lottery.

### 3. GENERAL CONDITIONS

- 3.1 People's Postcode Lottery shall have no liability for any system failure or other action or event that prevents a customer from entering the promotion.
- 3.2 This promotion is without prejudice to People's Postcode Lottery's discretion to refuse applications for new subscriptions or to close a subscription as set out in its **terms and conditions**. The Referrer will not receive an entry into the Refer A Friend Free Prize Draw in respect of any Referred Friend if People's Postcode Lottery decides not to allow the Referred Friend into the November 2025 lottery draws managed by them.
- 3.3 People's Postcode Lottery reserves the right to refuse to enter a Referrer into the Refer A Friend Free Prize Draw if it considers, acting reasonably, that these terms have been breached or the offer has been abused.
- 3.4 This promotion does not form part of the society lotteries managed by People's Postcode Lottery. It is a free promotion funded by Postcode Lottery Limited.
