

Special Prize Draws Offer

TERMS AND CONDITIONS OF THE SPECIAL PRIZE DRAWS (“PRIZE DRAWS”) PROMOTION

1. THE PROMOTION

1.1. This promotion is available to **Existing Players** (as defined below) of Postcode Lottery Limited trading as People's Postcode Lottery (the **Promoter**) aged 18 years and over who are resident in Great Britain, and who are not self-excluded with People's Postcode Lottery.

1.2 Only **one** entry per Existing Player.

1.3. To enter the Prize Draw, the Existing Players must enter via the Prize Draw link on My Account, or if they are unable to access My Account, via the Promoter's [Customer Experience Team](#).

1.4 Players who enter via the Promoter's Customer Experience Team will be entered at the time their entry is processed by the Customer Experience Team and not at the time the Player initially contacts the Promoter. The Promoter will process such entries as soon as reasonably practicable, but the Promoter accepts no liability for any entries that are not entered into the Prize Draw due to the time taken to process the entry.

1.5. Prizes in each Prize Draw will be as advertised on the Promotions tab of MyAccount. In every week of the promotion there will be three prizes in each Prize Draw except in the final week (4 to 11 October 2025) when there will only be one prize. Normally each week the prizes will be a vehicle, a holiday and an experience but there may be alternative prizes such as vouchers and gadgets. In the final week, there will be one cash prize available – the “Best Year of your Life”. Full details of the prizes available for Week One are found at the end of these terms and conditions. Details of the prizes for subsequent weeks will be released during the promotion in advance of each draw. The value of prizes may vary.

1.6 Existing Players who are blocked or self-exclude during the Prize Draw period will be removed from the Draws at the time they are blocked or self-exclude.

1.7 Each respective Prize Draw will be open for new entries as follows:

- Week 1 from 00:01:00 hours on Friday 22 August 2025 until 23:59:59 hours on Saturday 6 September 2025
- Week 2 from 00:01:00 hours on Sunday 7 September 2025 until 23:59:59 hours on Saturday 13 September.
- Week 3 from 00:01:00 hours on Sunday 14 September 2025 until 23:59:59 hours on Saturday 20 September.
- Week 4 from 00:01:00 hours on Sunday 21 September 2025 until 23:59:59 hours on Saturday 27 September.
- Week 5 from 00:01:00 hours on Sunday 28 September 2025 until 23:59:59 hours on Saturday 4 October.
- Week 6 from 00:01:00 hours on Sunday 4 October 2025 until 23:59:59 hours on Saturday 11 October 2025.

Except as set out in 1.6 above, once an Existing Player has entered the Prize Draw, they will automatically be entered into all available Prize Draws. For example, an Existing Player entering on 5 September 2025 will have one entry into each of the six weekly Prize

Draws while an Existing Player entering on 26 September 2025 will have one entry into each of the three remaining weekly Prize Draws.

2. SELECTION OF WINNERS and CLAIMING OF PRIZE/S

2.1 Each of the Prize Draws will take place on a Monday running from Monday 8 September 2025 to Monday 13 October 2025 inclusive. Winners of the relevant Prize Draw will be selected by the Promoter at random using the Promoter's randomisation software.

2.2 The Promoter will check eligibility of winning participants prior to confirming the award of a prize. If the winner is found to be ineligible or if any potential winner does not comply with these terms and conditions, then the winner may in the Promoter's sole discretion, be disqualified and an alternate winner will be selected.

2.3 The Promoter's determination of any matter relating to eligibility or entitlement to a prize from the Existing Player Prize Draw shall be final and binding.

2.4 The winner/s of the Prize Draw will be notified of their win by email and/or telephone within 48 hours of the prize draw by a representative of the Promoter.

2.5 The first name and county of the winners from each Prize Draw will be shown on the Promotions section of My Account on the Wednesday after the relevant Prize Draw unless a winner has already contacted the Promoter to object to this information being provided. In such circumstances the first name and county of the winner will not be published but will be provided to the Advertising Standards Authority if required.

2.6 While the Promoter shall use its best efforts to ensure the accuracy of all winner notification communications, the Promoter shall not be liable to award prizes to any individuals advised in error that they have won in a Prize Draw, in circumstances where they have not in fact won in the relevant Prize Draw.

2.7 Prizes are generally non-transferable and will be given to the winner only although the Promoter may, at its sole discretion, allow transfer of a prize in exceptional circumstances.

2.8 The prize may not be claimed by a third party on a winner's behalf.

2.9 While the Promoter makes every effort to describe the prizes accurately, the published details are indicative, and the specification of a prize (but not any stated value) may vary.

2.10 The Promoter shall be entitled to supply an alternative prize of equal or greater value where an advertised prize is unavailable for reasons outside the Promoter's reasonable control.

2.11 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not claimed their prize within 7 days of the Announcement Date, the Promoter reserves the right to select an alternate winner.

2.12 The Promoter does not accept any responsibility for any loss, damage, injury or disappointment suffered by a winner as a result of taking up a prize or being unable to take up a prize.

3. GENERAL CONDITIONS

3.1 The Promoter shall have no liability for any system failure or other action or event that prevents a customer from entering the promotion. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result

of taking up a prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Existing Players' statutory rights are not affected.

3.2 This promotion does not form part of the society lotteries managed by the Promoter. It is a free promotion, and prizes are funded by the Promoter.

3.3 These terms and conditions are governed by English Law and entrants to the Prize Draw submit to the non-exclusive jurisdiction of the English courts.

3.4 Any Existing Player who, if successful in a Prize Draw, would win prizes worth more than £500,000 in aggregate across that draw and any other individual paid-for society lottery draws managed by People's Postcode Lottery occurring within the previous 50 days of the relevant Prize Draw will not be eligible to win a prize in the Prize Draw.

4. PRIVACY

4.1 The Promoter is the Data Controller for personal data you provide when entering this Prize Draw. The Promoter takes the protection of personal data seriously.

4.2 The processing of entrants' and winners' details is a legitimate interest activity, which is necessary for the successful operation of the Prize Draw. For the avoidance of doubt, cancelled subscriptions shall include subscriptions actively cancelled by the Player – either directly with People's Postcode Lottery or via their bank – and lapsed subscriptions. For purposes of these terms and conditions, a lapsed subscription is a subscription where there have been three consecutive missed payments by the Player.
