Prizes will be awarded for new build and renovation projects which include Internorm windows and doors.

In association with our partners 'architektur.aktuell' and 'Zentralvereinigung der Architekt·innen Österreichs' (Central Association of Austrian Architects), we are offering a total prize fund of €4,000 for the winning projects.

An independent panel of experts will judge and select the best project for each category.

Terms of participation

1. Only those projects completed between 2020 and 2026 and using Internorm products qualify to be entered in the Internorm Architecture Competition 2026. It is obligatory to submit photographic evidence of the inside and outside of the project (renderings are not permitted). Only projects that have been realised in cooperation with an architect or planner are permitted to be entered into the competition. The project must be submitted by the due date by the architect or the planner themselves; therefore, the consent of the owner and the architect/planner is required before submitting the project.

2. The Internorm Architecture Competition 2026 offers a prize in accordance with §§ 860ff ABGB, sponsored by Internorm International GmbH. The evaluation of the projects, as well as the nomination of the winner is executed by an independent expert jury. The judges' decision is final and binding. As such, no correspondence will be entered into and legal steps are not permitted. The due date for the submission of the documents found on www.internorm.com/architecturecompetition2026, is **19 August 2026**. Any taxes and public dues on the prize money are to be paid by the winners themselves. There is no obligation on the part of the awarding bodies to disseminate or publish the nominated or prize-winning entries.

3. By participating in the Internorm Architecture Competition, the submitter confirms that they are the intellectual authors of the submission, and agree to the publication of the same in the context of publications, exhibitions, presentations on the internet and by means of electronic and social media (time unlimited) and such like; insofar as third-party rights exist, the submitter declares that the corresponding approval for publication and use has been granted, and indemnifies and holds harmless the awarding authorities or agents.

4. The participants declare that they agree for the submitted documents to become the material property of the competition organisers. The client and the architect/planner give their consent to the use of the data stated on the data sheet by the competition organisers, in particular for the publication of the data stated on the data sheet. The consent to the use of individual or several items of data can be revoked at any time.

The submission must include a description of the project, interior and exterior photographs of the project (renderings are not permitted), a declaration of consent and a fully completed submission form.
