- *foresees a 40% reduction in achievable emissions calculated according to the Market-Based approach by 2033 and a 99% reduction by 2047 compared to the baseline (2023);*
- *offset the residual GHG emissions calculated according to the ISO 14067 standard, in accordance with the Carbon Neutrality Management Plan, in relation to the sales of the above-mentioned models for the year 2024, by purchasing CER credits generated by the “Xe Namnoy 2 Hydropower (Laos, Asia)” project;*

The decarbonization process aimed at achieving carbon neutrality for the safety footwear models listed above is currently outlined in the “Carbon Neutrality Management Plan” document, October 2025 edition. The Carbon Neutrality Commitment was signed by the President of the U-POWER Group on October 20, 2025.
