

BLACKBERRY CLIENT END USER LICENSE AGREEMENT

This client software ("**Client**") is provided by BlackBerry Limited or its subsidiary or affiliate ("**BLACKBERRY**"), and is provided solely for use in conjunction with the associated enterprise server software and service ("**Server Software**"), which together with the Client and the Managed Applications as defined below (collectively the "**Client Software**") is referred to herein as the "**Solution**".

To install, activate or use any of the Client Software you must either (a): have (i) entered into with BLACKBERRY a BlackBerry Solution License Agreement for the Solution, including any addendum or additional terms that relate to the Solution, (the "**BBSLA**") on your own behalf; and (ii) if required for your Solution, acquired, and paid the fees, if any, for a Client Access License for the installation, activation and use of such Client Software on your device; or (b) be authorized to install, activate and use the Client Software on behalf of your employer or other legal entity ("**Licensed Entity**") that has: (i) entered into a BBSLA, (ii) made you aware of the terms of your use of the Client Software under the BBSLA, (iii) agreed to be responsible for your use of the Client Software; and (iv) if required for your Licensed Entity's Solution, acquired, and paid the fees, if any, for Client Access Licenses for the installation, activation and use of such Client Software on your device.

Your organization may utilize the Solution to perform Mobile Application Management ("**MAM**") by making available to you applications that are designed to run either on the personal side or in the work space partition of your device ("**Managed Applications**"), including software applications provided by a third party. Such applications are considered Third Party Software under the BBSLA. Third Party Software may include additional terms and conditions between you or your Licensed Entity and the supplier of the Third Party Software that govern its use. BLACKBERRY is not responsible for Third Party Software and all questions or concerns regarding same should be addressed to the Third Party Software supplier.

Your organization may utilize the Solution to perform Mobile Device Management ("**MDM**") functions on your device, including the collection of personal information. Your organization is responsible for the collection, processing, use and management of all information collected using the Solution.

In addition to the above conditions, if you obtained any Client Software from Apple's iTunes App Store, you acknowledge and agree on behalf of the Licensed Entity on whose behalf you are authorized to install, activate and use the Client Software, or if not so authorized you acknowledge and agree on your own behalf, that; (i) Apple has no responsibility whatsoever for such Client Software, including without limitation its performance, maintenance and support, or for any claim by a third party that such Client Software infringes the intellectual property rights of a third party. If the Client Software fails to conform to any applicable warranty, you may notify Apple, and Apple will refund the purchase price for such Client Software, if any, and, to the maximum extent permitted by applicable law, Apple will have no other warranty obligation whatsoever with respect to the Client Software.; and (ii) Apple and its subsidiaries are third party beneficiaries of this Agreement, and have the right (and will be deemed to have accepted the right) to enforce this Agreement as a third party beneficiary.
