



PANAMA'S DARIÉN LOWLANDS

Canopy Camp

October 31 - November 8, 2026

This tour to the lowlands of eastern Panama fuses the rich diversity of tropical birds for which Panama is justly famous with the classic atmosphere of a luxurious African tented camp. We will be quartered in the Canopy Camp, courtesy of Raúl Arias de Para, whose vision for sustainable ecotourism and devotion to preserving Panama's birds and wild places introduced the birding world to the famed Canopy Tower in the Canal Zone and the Canopy Lodge in El Valle. Located in the lowlands of Darién, just a five-hour-drive (via the Pan-American highway) from Panama City, and tucked into the base of some low-lying hills whose forested slopes are part of a protected zone, this camp will provide a comfortable base for a great week of Neotropical birding. Our accommodation will be in spacious, walk-in, African-style tents, mounted on platforms,



and replete with comfortable beds, fans, and private bathrooms with showers (hot water) and flush toilets. Keeping with the tradition established by the other Canopy lodges, the camp will offer imaginatively prepared, tasty meals, and an abundance of cold drinks.

The camp clearing affords a fabulous view of the surrounding forest and edge habitat. Dawn brings a flurry of activity and a cacophony of avian sound, dominated by the screeching calls of commuting parrots, the yelping of Yellow-throated Toucans, and the incessant croaking of Keel-billed Toucans, but also including the haunting calls of Little Tinamou, the raucous screeches of Red-throated Caracaras (uncommon), the noisy chattering of White-headed Wrens, and the plaintive whistles of Barred Puffbirds and Cinnamon Becards. Hummingbird feeders on the deck may harbor a half dozen species or more including Pale-bellied Hermit, Scaly-breasted, Violet-bellied & Sapphire-throated hummingbirds, and White-vented Plumeleteer. Our mornings and late afternoons will be spent exploring the camp trail system and a number of nearby sites, where, in addition to seeing a broad cross section of toucans, trogons, motmots, woodcreepers, antbirds, tanagers, and other tropical birds that typify the Canal Zone, we will also search for a number of special birds whose Panamanian ranges are (in most cases) largely restricted to the far eastern lowlands and foothills, among them: Capped and Cocoli herons; Chestnut-fronted Macaw; Spectacled Parrotlet; Pale-bellied Hermit; Olivaceous Piculet; Red-throated Caracara; Gray-cheeked Nunlet; Rufous-tailed Jacamar; Black-tailed Trogon; Red-rumped, Spot-breasted, and Golden-green woodpeckers; Red-billed Scythebill; Double-banded Graytail; Black Antshrike; Rusty-winged Antwren; Bare-crowned Antbird; Sooty-headed Tyrannulet; Ochre-ored Flatbill; Cattle Tyrant; One-colored Becard; Golden-headed Manakin; Black-capped Donacobius; White-eared Conebill; Orange-crowned Oriole; and Black Oropendola.

In recent years, nests of both Harpy Eagle and Crested Eagle have been discovered in the surrounding areas. If any nests are active during our visit, we will make a special effort to seek out these near mythical species. Since they only nest once every two to three years, it is very possible that no nests will be active on a given trip. However, young birds often hang around the nest site for several months. We will be monitoring the situation closely for each tour. Any visit to a Harpy or Crested eagle nesting site would likely involve some combination of travel by dugout canoe, walking and possibly horseback.

This tour can be taken by itself or in combination with Panama: Fall at El Valle's Canopy Lodge (October 5-12, 2025) and/or Fall at Panama's Canopy Tower (October 18-25, 2025).

October 31, Day 1: Arrival in Panama City and Transfer to Crowne Plaza Panama Airport Hotel

Participants not continuing from Panama: Fall at El Valle's Canopy Lodge (October 5-12, 2025), arriving in Panama City's Tocumen International Airport anytime this afternoon or evening, after clearing customs and gathering luggage, should take the courtesy shuttle to the nearby Crowne Plaza Panama Airport Hotel where a room will be reserved in your name. There may be a representative with a Crowne Plaza sign just outside of customs, but if not, proceed to the center island outside where hotel shuttles pick up clients. Alternatively, since the shuttle bus only runs once an hour, you can take a taxi to the hotel for a relatively inexpensive cost.

NIGHT: Crowne Plaza Panama Airport Hotel, Hacia

November 1, Day 2: Tocumen to the Bayano Valley, and on to the Canopy Camp, Darién

We will gather at 6:30 a.m. in the hotel lobby for breakfast before heading eastward to the Darién. We will begin our birding about an hour and a half away in the lowland forests around Bayano Reservoir. This area will provide our first chances for such highly sought species as Cocoi Heron, Black Antshrike, Rufous-winged Antwren, and White-eared Conebill. We will carefully watch the roadsides for the likes

of Savanna Hawk and Pearl Kite as we head eastward. We will end up in the small town of Tortí for lunch, where hummingbird feeders sometimes make it hard to concentrate on eating! Up to six species are possible with Scaly-breasted, Snowy-bellied and Sapphire-throated hummingbirds, and Black-throated Mango among the more noteworthy.

After lunch, we will continue our drive eastward into the Darién.

Much of the countryside east of the Bayano region has been deforested, but this open country is good for Savanna Hawk, Yellow-headed and Crested caracaras, Pearl Kite, Sapphire-throated Hummingbird, Fork-tailed Flycatcher, Red-breasted Meadowlark and a number of other species. We'll arrive at the Canopy Camp in the late afternoon, with time to settle in to our accommodations before dark, and, perhaps, with time to enjoy the late flurry of bird activity around the camp clearing.

The Canopy Camp is designed in the tradition of African-style luxury tented camps. The spacious, walk-in tents are mounted on platforms, replete with comfortable beds, fans, and adjacent private bathrooms with showers and flush toilets. The tents are well spaced through the camp clearing, maximizing privacy. Keeping with the tradition established by the other Canopy lodges (Canopy Tower, Canal Zone and Canopy Lodge, El Valle), the camp will offer imaginatively prepared, tasty meals, and an abundance of cold drinks. This will be a never before afforded opportunity to bird the lowlands of Darién in comfort!

NIGHT: Canopy Camp, Sanson, Darién

November 2-6, Days 3-7: Darién Lowlands Based out of the Canopy Camp

The Canopy Camp is tucked into the base of a jagged line of low-lying hills whose forested slopes are part of a protected zone. Dawn should yield a good variety of birds right around the tents and dining area. Mealy and Red-lored parrots, Keel-billed and Yellow-throated toucans, Collared Aracari, Black-cheeked and Red-rumped woodpeckers, Barred Puffbird, Black-tailed Trogon, Whooping Motmot, Streak-headed Woodcreeper, Cinnamon Becard, Spot-crowned Barbet, White-headed Wren, and Chestnut-headed Oropendola are some of the species regularly seen right around the clearing. It will be hard to tear ourselves away. Nearby Nando's Trail makes a loop into the deep forest, allowing for other possibilities such as Golden-collared and Golden-headed manakins, Black-faced Antthrush, Tropical Royal Flycatcher and more. The entry road into the camp is also very good for birds. Thickets of vervain and verbena have been planted here and attract a wide variety of hummingbirds. Blue-chested, Rufous-tailed and Violet-bellied are the most common, but rarities such as Rufous-crested Coquette and Ruby-Topaz Hummingbird (mostly dry season) have been found. Olivaceous Piculet, Lineated and Crimson-crested woodpeckers, White-bellied Antbird, Black-crowned Tityra, Buff-breasted Wren, and Black-chested Jay might also be encountered.

Our exact day-to-day itinerary will be kept flexible, allowing us to take advantage of local weather and birding conditions. However, our time here will certainly include one or more mornings birding a wonderful stretch of forested road at El Salto, an excellent area for raptors, as well as for multiple species of trogons and woodpeckers (including the highly sought Golden-green), Olivaceous Piculet,

Whooping Motmot, Gray-cheeked Nunlet, Barred Puffbird, Double-banded Graytail, Black Antshrike, Bare-crowned Antbird, Ochre-lored Flatbill, Choco Sirystes, Blue Cotinga, Black-bellied and White-headed wrens, and Yellow-backed Orioles, among many others. Trails at El Salto and nearby Tierra Nueva, as well as those at the Canopy Camp, will allow us access into the heart of the forest, maximizing our chances of ferreting out the more secretive forest interior species. We'll also hope to spend one morning birding by boat either along the Río Chucunaque and Río Tuquesa to the Embera village of Nuevo Vigia or up the Rio Membrillo to the Wounaan village of Sinai. The former could be particularly good for finding raptors, parrots and the rare Spectacled Parrotlet.

In January 2014 a very rare pair of Dusky-backed Jacamars was located in this area and this species has been encountered on this tour since 2018. Near Sinai in 2016 & 2018, a nest of the near mythical Harpy Eagle was found and has been seen since 2018. Of course, there are no guarantees that this nest will continue to be active (Harpy Eagles generally nest only once every two or three years), but if it is, this will likely be our destination. Other possibilities in either area include Little Cuckoo, the rare Green-and-rufous Kingfisher, Rufous-tailed Jacamar, Chestnut-fronted Macaw (rare), White-necked Puffbird, Gray-cheeked Nunlet, Black Antshrike, and three species of oropendolas.

Open country and marshland such as that found at Las Lagunas, Quebrada Felix or Yaviza wetlands harbor an entirely different set of birds. Open pastures and edge habitat at those locations could produce Roadside Hawk, Spot-breasted Woodpecker, Pied Puffbird, Ochre-lored Flatbill, Pied Water-

Tyrant, Pacific Antwren, Black-capped Donacobius, Red-breasted Meadowlark, Orange-crowned Oriole and

more. Forest in the vicinity of Aligandi provides yet another possible destination with all three hawk-eagles, Red-billed Scythebill, and Blue Cotinga among the avian possibilities. Most days we will return to the camp for lunch and siesta, with late afternoons typically devoted to birding forest-edge, open country and marshes. This is often the best time to see the spectacular Black Oropendola, as birds commute from their feeding areas back to the nesting colonies for the night. On at least one night, we'll plan some night-birding activities, which could afford us views of some nocturnal mammals as well.

NIGHTS: Canopy Camp, Sanson, Darién

November 7, Day 8: Canopy Camp to Panama City

After a final morning of birding in the Darién lowlands, we will spend the afternoon retracing our route back to Panama City, perhaps with one more stop at Lake Bayano. Conversely, depending on what we've already seen (or missed), we may leave camp immediately after breakfast and drive directly to Tortí, where we would spend the remainder of the morning birding the nearby San Francisco Reserve. This private reserve has some lovely tall forest (offering such possibilities as Great Jacamar, Black-breasted Puffbird, One-colored Becard, and White-fronted Nunbird). Even the endemic Yellow-green Tyrannulet is a possibility here as well. After lunch at a restaurant in Tortí, we will begin making our way back to Panama City, where we will enjoy a farewell dinner.

Participants continuing on Fall at Panama's Canopy Tower (October 18-25, 2025) will be transferred along with Barry Zimmer to the Canopy Tower this evening after dinner.

NIGHT: Crowne Plaza Panama Airport Hotel, Hacia

November 8, Day 9: Departures for Home

The hotel's complimentary shuttle service to Tocumen International Airport can be used to make morning or afternoon flights home.

ESSENTIAL TOUR INFORMATION

TOUR SIZE: This tour will be limited to 10 participants. However, VENT reserves the right to increase the tour limit by one in order to accommodate a couple when only one space is available.

TOUR LEADER: Kevin Burke with the assistance of local guides



Kevin Burke is originally from the Shenandoah Valley in Virginia. He grew up running around in the woods and trails of Shenandoah National Park. His family spent many summers camping and hiking in the park. One of Kevin’s favorite activities was jumping in the river and turning over every rock to see what was underneath. This eventually earned him the nickname “Hellgrammite Kid.” This early exposure to the natural world has vaulted into a lifelong obsession with the outdoors. Kevin was introduced to birding while spending summers in

Rhode Island at his grandmother’s house. She would point out all the feeder birds and help him identify them. These early encounters helped foster a love for birds. An early Ornithology class at Hocking College in Ohio rekindled his love for birds. He has been birding every day since. He went on to get a Bachelor of Science in Ecotourism and Conservation Ecology from the University of Idaho. Kevin has been involved with leading bird trips in some capacity for almost 20 years. He has led birding trips all throughout the United States, Costa Rica, Ecuador, and the Dominican Republic. His birding journeys have also taken him to some spectacular locations such as Portugal, Colombia, The Bahamas, and Canada. This is truly a lifelong obsession. He currently resides with his family in Hendersonville, North Carolina. Kevin’s wife and two kids also enjoy birding. They have fun kayaking, hiking, and camping in the mountains that surround their home. One of their favorite activities is jumping on the paddle board and kayaks and leisurely floating the French Broad River near their house.

TOUR COSTS & PAYMENT INFORMATION

TOUR FEES: \$4,795 per person based on double occupancy in standard double accommodations at the Canopy Camp (see Canopy Tower Accommodations section below).

\$5,090 per person for occupying standard double accommodations as a single at the Canopy Camp (see Canopy Camp Accommodations section below).

\$5,195 per person based on double occupancy in premium double accommodations at the Canopy Tower (see Canopy Camp section below).

These include all meals from breakfast on Day 2 through dinner on Day 8, accommodations as stated in the itinerary, all ground transportation during the tour, and guide services provided by the tour leaders. It does **not** include airfare to nor from Panama City. The fee also excludes laundry, personal expenses, and other items of a personal nature. For information about gratuities, please see the “TIPPING” sub-section below. If the minimum group size is not met, each participant will be charged a small-group supplement—shared equally and communicated in advance—to allow the tour to proceed.

REGISTRATION & DEPOSIT: You may register for this tour through the VENT [website](#) or by calling our office (512-328-5221). The initial deposit for this tour is **\$1,000** per person. At 180 days VENT will collect a second deposit that brings the total deposit amount to 40% of the tour price. We accept MasterCard and Visa for both deposits.

PAYMENTS: All tour payments may be made by credit card (MasterCard or Visa), check, money order, or bank transfer (contact the VENT office for bank transfer information). These include initial deposits, second deposits, interim payments, final balances, special arrangements, etc. Full payment of the tour fee is due 120 days (July 3, 2026) prior to the tour departure date.

EXTRA ARRANGEMENTS: Should you wish to make arrangements to arrive early or extend your stay, please contact the VENT office at least two months prior to your departure date. We can very easily make hotel arrangements and often at our group rate, if we receive your request with enough advance time.

FUEL SURCHARGES: Our prices are based on fuel prices at the time of itinerary publication. While we will do everything possible to maintain our prices, it may be necessary to institute a fuel surcharge.

TIPPING: An important part of the value of a VENT tour is knowing that tips for local service providers at our destinations—restaurant staff, hotel staff, drivers, local guides, and various other

support staff—are included in your tour fee. If you would like to offer any of your local guides an additional tip, \$5 to \$10 a day is a common amount.

Tips for your VENT tour leader(s) are **not** included, but it is customary to tip one or both if you feel that you have received exceptional service. To assist in your planning, we recommend tipping your VENT tour leader(s) \$15 to \$20 per day, or the equivalent of approximately 2–4% of the tour fee.

If you plan to give tips by cash, they should be given directly to your tour leader at the end of the tour and **not** sent to the VENT office. Some of our tour leaders use mobile payment applications such as Venmo, PayPal, and Wise. If you would like to use this method, please ask your tour leaders directly whether they can accept tips through such an application.

We emphasize that tipping is optional and that these amounts are only recommendations. The amount you decide to tip is based entirely on your experience and at your discretion.

CANCELLATION & REFUNDS

CANCELLATION BY PARTICIPANT:

- **More than 120 days prior to the tour start date:** A refund of all monies paid will be issued, less 50% of the deposit (including initial and second deposit)
- **120 days or fewer prior to the tour start date:** No refund will be provided.
- **Optional add-ons:** Some tours offer optional add-ons that are designated as non-refundable. Any such add-ons are clearly identified as non-refundable at the time of booking. By selecting and purchasing an optional add-on, the participant acknowledges and accepts its non-refundable status. Fees paid for non-refundable add-ons are not refundable under any circumstances, regardless of when the tour is cancelled.

This cancellation policy applies to all participants and all tours (Pre-Tours and Extensions are considered self-contained tours separate from the main tour). Because unexpected events can occur, we strongly recommend the purchase of travel insurance.

CANCELLATION BY VENT:

If VENT cancels a tour prior to departure without cause or good reason, VENT will provide the participant a full refund, which will constitute full settlement to the participant.

If VENT cancels or delays a tour or any portion of a tour as a result of any Force Majeure event, VENT will use its reasonable best efforts to refund any payments on the balance of the tour fee to participant; provided that, VENT will have no obligation to provide a participant with a refund and will not be liable or responsible to a participant, nor be deemed to have defaulted under or breached any applicable agreement, for any failure or delay in fulfilling or performing any term of such agreement. A **“Force Majeure”** event means any act beyond VENT’s control, including, without limitation, the following: (a) acts of God; (b) flood, fire, earthquake, hurricane, epidemic, pandemic or explosion; (c) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot or other civil unrest; (d) government order, law or actions; (e) embargoes or blockades; (f) national or regional emergency; (g) strikes, labor stoppages, labor slowdowns or other industrial disturbances; (h) shortage of adequate power or transportation facilities; and (i) any other similar events or circumstances beyond the control of VENT.

This VENT Cancellation & Refunds policy does not apply to air tickets purchased through VENT or to any special arrangements, such as additional hotel nights, that fall outside of the services described in the tour itinerary.

Victor Emanuel Nature Tours is not a participant in the California Travel Consumer Restitution Fund. California law requires certain sellers of travel to have a trust account or bond. This business has a bond issued by Travelers in the amount of \$50,000. CST #2014998-50.

TRAVEL INSURANCE

MEDICAL EVACUATION INSURANCE/PROTECTION REQUIREMENT: This tour visits remote locations where immediate access to primary medical care may not be available. **For this reason, travel insurance/travel protection which covers you for emergency evacuation is required for participation on this tour.** This coverage is included in the **Ripcord Rescue Travel Insurance™** program. Alternatively, comparable service can be obtained through **Medjet** and its **MedjetAssist** plan. If you choose not to purchase insurance/travel protection through Ripcord or Medjet, you are required to obtain it through another provider. Please refer to the TRAVEL INSURANCE/TRAVEL PROTECTION section for additional information.

SUGGESTED OPTIONS: To safeguard against losses due to illness, accident, or other unforeseen circumstances, we strongly recommend the purchase of travel insurance as soon as possible

after making a deposit. VENT has partnered with **Redpoint Travel Protection** as our preferred travel insurance provider. Through Redpoint, we recommend its comprehensive Ripcord plan, which includes a medical evacuation benefit. With this in mind, it is important to note that medical evacuation is not offered by Redpoint as a stand-alone policy or benefit. For travelers not interested in comprehensive travel insurance, VENT recommends **Medjet** and its **MedjetAssist®** plan. Medjet is not an insurance company, and Medjet Assist is not an insurance product; rather, Medjet is a membership-based air-medical transport company specializing in moving hospitalized travelers from an admitting hospital to a medical facility of choice. Medjet does not provide medical evacuation service from the point of injury or illness; yet, the MedjetAssist plan offers robust enough travel protection to satisfy the medical evacuation insurance requirement in place for many VENT tours.

About Redpoint Travel's Ripcord Plan

Ripcord is a completely integrated travel insurance program with single contact for emergency services, travel assistance, and insurance claims. Critical benefits include comprehensive travel insurance for trip cancellation/interruption, medical evacuation from your point of injury or illness to your hospital of choice; medical expense coverage, death of pet, and much more. Optional expanded insurance coverage is available and includes items such as evacuation coverage in case of a natural disaster or political or security reasons, waiver for pre-existing medical conditions exclusion, and a "Cancel for Any Reason" benefit. Ripcord is available to U.S. and non-U.S. residents.*

*To be eligible for the pre-existing medical condition exclusion waiver and the optional Cancel for Any Reason (CFAR) upgrade, you must purchase your policy within 15 days of making your first trip payment. The CFAR benefit provides reimbursement for 75% of covered costs, and increases the policy premium by approximately 50%. Policies may be purchased either for the full value of the tour fee at the time of deposit or in segments as individual tour payments are made (deposit, second deposit, final balance, additional arrangements, etc.). The "pay as you go" approach

reduces up-front expense and ensures that the amount paid toward your full policy premium is in proportion to the amount paid toward the full tour fee. If you choose to “pay as you go,” you must cover each deposit or payment within 15 days, and insure all non-refundable trip costs in order to maintain the CFAR benefit. For travelers under 75, MedjetAssist may be purchased as Short-Term Memberships of 8, 15, 21, and 30 days, or Regular Annual Memberships from 1 to 5 years. For travelers 75–84, Medjet offers a Diamond Membership that is the same program but with a few additional conditions.

GETTING THERE & REQUIRED TRAVEL DOCUMENTS

AIR TRAVEL: Victor Emanuel Travel is a full-service travel agency and wholly owned subsidiary of Victor Emanuel Nature Tours (VENT). Victor Emanuel Travel will be happy to make any domestic or international air travel arrangements from your home and return. Per person fees apply for each set of travel arrangements: \$50 domestic; \$75 international.* Many of our travelers choose to make their own air travel arrangements, but we emphasize the benefits to using our services. If you book your air arrangements yourself, Victor Emanuel Travel is unable to provide support in managing any flight delays and/or cancellations that could occur before and during a tour. When you purchase

air tickets through Victor Emanuel Travel, our staff has ready access to your air ticket record and can provide assistance as problems arise. Please feel free to call the VENT office to confirm your air arrangements. **Please be sure to check with the VENT office prior to purchasing your air ticket to confirm that the tour is sufficiently subscribed to operate. VENT cannot be held responsible for any air ticket penalties.**

*An air ticket will be purchased by Victor Emanuel Travel on behalf of the traveler with the traveler's consent. A purchase is considered final upon receipt of payment. If a ticket is subsequently reissued at the behest of the traveler (i.e. voluntary change of plans), the same fee rates apply for the reissue process, in addition to any fees that may be charged by the airline.

BAGGAGE: Please limit baggage to one piece of luggage and one carry-on. The airlines now strictly enforce baggage regulations. Excess baggage charges, which can be substantial, are the personal responsibility of each participant. Please consult your pre-departure materials and/or airline to find out specific weight restrictions.

As a precaution against lost luggage, we suggest that you pack a change of clothes, toiletries, medications, important travel documents, optics, and any other essential items in your carry-on bag. Due to ever-changing circumstances in the government's attempts to improve airport security, we recommend that you check the website of the [Transportation Security Administration \(TSA\)](#) for information pertaining to permissible carry-on items.

TRAVEL DOCUMENTS:

PASSPORTS: A passport valid for at least three months beyond your planned departure from Panama is required.

VISAs: Visas are not required for U.S. citizens traveling to this destination. If you hold a passport from another country, please check with your consulate or embassy for the most accurate guidance.

IMPORTANT: The visa details above are current for U.S. citizens as of June 19, 2026. Because entry requirements can change without notice, we kindly remind all participants to double-check the latest information before traveling. Travelers using non-U.S. passports are responsible for confirming any entry requirements that apply to their home country.

CONDITIONS: This tour will involve much roadside birding, as well as relatively short walks (mostly less than a mile) over dirt roads or forest trails. Trails and roads are likely to be muddy as this is the heart of the rainy season (May through December). Waterproof shoes and/or boots are highly recommended. If there is an active Harpy or Crested Eagle nest, we may have to make a longer hike (sometimes two miles or more). Also, reaching the nest site could involve any combination of driving, boat ride, walking and potentially even horseback. The day we visit the Embera village of Nuvo Vigia, we will be traveling up the Chucunaque and Tuquesa rivers by motorized dugout canoes. We will probably have two full days away from the Camp where we take lunch with us. Other days, we will return to the camp for lunch followed by some siesta time. Climate is likely to be quite humid and high temperatures often reach the mid to upper 80's. The first and last days of the tour will be largely devoted to traveling to and from Panama City while squeezing in birding along the way.

CANOPY CAMP ACCOMMODATIONS: The Canopy Camp has a total of eight tents. The seven available for tour participants include two Tent Suites and five standard tents. Both Tent Suites, one of which has a queen bed while the other has two twin beds, have more space than a standard tent. All tents will be pre-reserved on a first-come, first-served basis. You will be advised of tent availability and your specific assignment at the time of your registration. All tents are built onto a wooden platform and all have private bathrooms with flush toilets and hot water showers located just outside the tent on the platform. The bathroom itself has a ceiling, but the shower is open air overhead.

PHYSICAL REQUIREMENTS: Participants should be prepared for early starts (breakfast times will likely vary between 5:00 AM and 7 AM; there may be one even earlier morning if an active Harpy Eagle nest is available) with full mornings of activity. Regardless of our morning activities, we will be returning to camp for lunch and a mid-afternoon break on most days based out of the Canopy Camp. On two days we will spend the entire day in the field, taking lunch with us. Late afternoon excursions of a few hours will be less physically rigorous, and will mostly involve roadside birding. Most walking on this tour will be along lightly traveled roads or trails of easy to moderate grade. In the rainy season (May through December), these trails can be quite muddy. We may spend some time on one or two trails that are somewhat hillier (Nando's Trail out of the camp could be considered moderate to difficult). None of the hiking will involve distances of much more than a mile to a mile and a half, but we will likely be on our feet for much of the morning. A hike to a possible Harpy Eagle nest site could be of

longer distance. Also, a visit to a Harpy or Crested eagle nest site would likely involve travel by boat (dugout canoes) and possibly by horseback, in addition to hiking.

CLOTHING: As is the case for all our tropical tours, lightweight field clothing is the norm for Panama. This includes several pair of lightweight field pants, along with cool and comfortable long-sleeved shirts. A hat and sunscreen are recommended for protection from the sun.

Dark-colored or neutral clothing is suggested, as white or bright colors may frighten secretive birds. Lightweight and comfortable walking shoes are recommended, since some days we will spend a good bit of time on foot. Some participants may find sturdier hiking shoes preferable for trail walks and waterproof overshoes such as NEOS or rubber boots are highly recommended (=essential) during the rainy season for the potentially muddy trails and rain. A small umbrella and/or rain gear are essential as well.

CLIMATE: The climate in the Darien lowlands and eastern Panama Province is usually warm & very humid, with mornings in the 70s to 80s. Conditions at midday can be humid and very warm, with temperatures reaching into the 90s. Rainstorms may occur at any time of year, but are more likely during the rainy season, which runs from May into early December, when rain of some sort is expected daily. Rain showers can be heavy in the rainy season, but are generally more prevalent in the afternoon hours. Generally, the weather in eastern Panama is good, with our activities corresponding to the cooler parts of the day and heightened bird activity.

LAUNDRY SERVICE: Laundry service is available at the Canopy Camp.

CURRENCY: The U.S. Dollar is the official currency of Panama. VISA and American Express are most commonly used, but MasterCard and Diners Club are also accepted.

EQUIPMENT: You should pack a pair of binoculars that are in good condition, along with a belt pack or day pack (good for carrying books, sunscreen, camera, etc.). As a precaution, it's a good idea to pack your binoculars, a change of clothing, toiletry items, medications, and travel documents in your airline carry-on bag. Your leaders will have a spotting scope; but if you have one and wish to bring it, please feel free to do so.

INTERNET ACCESS: Wi-Fi is available in the common areas of the Canopy Camp as well as the individual tents. However, service can be sporadic due to its remote location. Wi-Fi is available at the Crowne Plaza Panama Airport Hotel.

HEALTH & SAFETY

HEALTH: The Centers for Disease Control and Prevention (CDC) in Atlanta advise that there is some risk of malaria and currently recommends that **travelers to Darién Province in Panama should take one of the following antimalarial drugs (listed alphabetically): atovaquone/proguanil, doxycycline, mefloquine, or primaquine (in special circumstances).**

VENT follows Centers for Disease Control and Prevention (CDC) recommendations for standard travel precautions, which includes vaccination against a variety of preventable diseases. Among these so-called Routine Vaccinations are measles/mumps/rubella (MMR) vaccine, diphtheria/pertussis/tetanus (DPT) vaccine, poliovirus vaccine (boosters for adult travelers), and Varicella (Chickenpox). You should also be up-to-date with Hepatitis A and Hepatitis B vaccinations.

If you are taking personal medication, prescription or over-the-counter, be sure to bring an ample supply that will allow you to get through the tour safely. Please consult your physician as necessary. Remember to pack all medication in your carry-on baggage, preferably in original containers or packaging. As airline baggage restrictions can change without warning, please check with your airline for procedures for packing medication.

COVID-19: We continually emphasize that our number one priority is the health and safety of our customers and employees. Although VENT no longer maintains any of its COVID-era prevention protocols, we strongly recommend best practices for protecting yourself and your fellow travelers against COVID-19 illness. These measures include receiving the primary series vaccinations for those eligible, staying “Up to Date” with COVID-19 booster shots, wearing high filtration N-95 or KN-95 masks when in airports and on airplanes, and avoiding risky social settings in the lead-up to your tour. These recommendations are firmly rooted in CDC guidance for avoiding COVID-19.

SUN EXPOSURE: The sun’s ultraviolet rays are dangerous under prolonged exposure (sometimes only a matter of minutes), even in winter and early spring. Anytime you are outdoors you will

want to protect your skin, including your lips, eyes, nose, and ears. A severe sunburn is potentially very painful and will affect your level of enjoyment. Always protect yourself when outdoors and be sure to bring an ample supply of high SPF sunscreen and lip balm. We strongly recommend the use of ultra-violet blocking, polarized sunglasses.

BITING INSECTS: Remove if not a concern, otherwise expand on it.

INSECT REPELLENTS: There are insect repellents for the skin and an insect repellent used to treat clothing that should not be applied to the skin.

Insect repellents for the skin are commonly available in three forms:

- **DEET:** (N,N-diethyl-meta-toluamide): A chemical compound that is marketed under various brand names (OFF!®, Cutter™, Ultrathon™, etc.) and offered in a variety of formulations including sprays, lotions, time-release preparations, and disposable wipes. The formulations will state a percentage of the active ingredient DEET on the packaging. DEET may be applied to exposed skin directly and/or sprayed on clothing. Please be careful when applying DEET as it can damage plastics and lens coatings.
- **Picaridin:** A synthetic formulation that is derived from piperine, a substance found in plants that produce black pepper.
- **Herbal insect repellents:** Various mixtures of organic ingredients such as oils from eucalyptus, citronella, cedar, and other herbs. The herbal repellents are more difficult to categorize because of the difference in ingredients from one brand to another. There is considerable variation in their effectiveness.

Insect repellent for clothing is marketed in one approved formulation:

- **Permanone® (Permethrin):** is an odorless spray-on repellent that may be used for pre-treatment of clothing, gear, and tents. It should not be used directly on the skin or sprayed on clothing while it is being worn. The pre-treatment process requires a number of hours to complete and must be done outdoors, so it is best completed in advance of travel. Do-it-yourself pre-treatment must be repeated more often than commercial treatment using Insect Shield® technology. It is available at various outdoor stores and can easily be found online.

- **Insect Shield® apparel:** Clothing pre-treated with Permethrin is made by a variety of manufacturers. It is available for purchase from some sporting goods suppliers. The clothing is advertised as retaining its repellency for up to 70 washings.

The US EPA offers a search tool to help choose a repellent that is best for a particular situation. For example, some repellents work for mosquitoes, but not for ticks.

eBird. Cornell Lab of Ornithology. Among the largest and most successful citizen science projects in existence, eBird is an essential tool in promoting bird study and conservation. Among a range of benefits, eBird allows users to keep a variety of lists in a single application. When taxonomic splits are incorporated, lists are automatically updated. Additionally, trip leaders can share daily lists, so one only need accept a shared list and it will upload to your files. **Highly recommended.**

Merlin Bird ID. Cornell Lab of Ornithology. Merlin is an app designed as a birding coach for beginning and intermediate birdwatchers. Excellent for use in the field, Merlin asks the observer a series of questions about his or her bird sighting, including date and location, and color, size, and behavior of a bird. Merlin then processes the viewer's responses to present a shortlist of possible identifications,

from which the user can choose the likely bird. Species profiles include a brief physical description, photographs, and sound samples. The Photo ID feature allows anyone with a camera to snap a photo and obtain a list of suggestions. Merlin's Sound ID feature allows identification of birds through audible recognition. To use Merlin, download the app and the appropriate regional "pack." For this trip, please download the pack Europe. Highly recommended.
