Fall at Canopy Tower

October 17 – 24, 2026

Panama is without doubt one of the premier birding destinations in the Neotropics. It is famous for its rare combination of easy access to extensive, high-quality habitat, good food and water, comfortable accommodations, and high diversity of birds—all within a compact geographic area. While ideal for those new to the Neotropics, VENT's Panama tours also offer plenty of challenges and local specialties for those who have birded elsewhere in the region. Our focus will be on finding, identifying, and observing a wealth of wonderful tropical birds, including trogons, toucans, motmots, puffbirds, manakins, antbirds, and tanagers. We'll take time to sort out the look-a-likes, learn a bit about the plant associations and habitats, and call up many of the more skulking species.

Among the pleasures of a visit here is the opportunity to stay at the Canopy Tower, a lodge located amidst spectacular birding in Soberania National Park. Offering the chance to hear the dawn chorus, to gaze upon seldom-seen denizens of the upper reaches of the forest, and to remain in such beautiful surroundings without sacrificing amenities, this innovative venture has taken its place as one of Central America's very finest ecotourist hotels.

This special departure occurs during an excellent time for observing hawk migration through Panama. Virtually the entire U.S. population of Broad-winged and Swainson's hawks, plus hundreds of thousands of Turkey Vultures, migrate to South America through Panama. With the right weather conditions, spectacular flights can be observed. The Canopy Tower provides an ideal site from which to observe this phenomenon. Imagine sitting in a comfortable chair on the roof of the lodge while you view exciting tropical species and observe one of the world's greatest hawk spectacles.



Our specific day-to-day itinerary will be kept flexible, allowing us to take advantage of local weather and birding conditions. Having such a comfortable base in the midst of so much fine birding gives us leeway in planning our activities.

This tour can be taken by itself or in combination with Panama: Fall at El Valle's Canopy Lodge (October 24-31, 2026 and/or Panama's Darien Lowlands: Canopy Camp (October 31-November 8, 2026).

October 17, Day 1: Arrival in Panama City and Transfer to the Canopy Tower

Participants reserved on direct flights from various cities, which are scheduled to arrive into Panama City's Tocumen International Airport prior to 8:00 p.m., will be met at the airport and transferred to the Canopy Tower, which is about 45 minutes away. The Canopy Tower is not set up to accommodate late evening arrivals.

NIGHT: Canopy Tower, Gamboa

October 18, Day 2: Canopy Tower and Entrance Road

An early start this morning (we will meet at 6:00 a.m. atop the observation deck) will find us on top of the Tower enjoying a cup of coffee or tea while watching the sunrise over the forested hillsides. The predawn chorus often includes the strange barks and moans of forest-falcons, the haunting calls of a tinamou, or the last hoots of an owl. As the light hits the treetops, the forest really begins to come alive. Birds begin singing and actively foraging, many of them

close and often below us. Species regularly seen from here include Scaled Pigeon, the incredible Keel-billed Toucan, Collared Araçari, Red-lored and Mealy parrots, Black-breasted Puffbird, Slaty-tailed Trogon, Brown-capped Tyrannulet, Masked Tityra, wintering Bay-breasted Warblers and Yellow-throated Vireos, and the stunning Slate-colored Grosbeak. Fruiting cecropias often harbor a nice variety of tanagers including Plain-colored, White-shouldered, and Palm; Fulvous-vented Euphonia; and gorgeous Green Honeycreepers. We'll also keep a sharp eye out for two of the true prizes of the tree tops, the spectacular Blue Cotinga and the brilliant Green Shrike-Vireo. We've had good luck seeing cotingas here (about half of our trips), often at close range, and the shrike-vireo, whose monotonous titmouse-like song can be heard in many areas of the tropics, can perhaps be viewed best here at the Tower. Mammals may also be in evidence with Brown-throated Three-toed Sloth, Mantled Howler Monkey, and the adorable Geoffroy's Tamarin all possible. It can be hard to tear oneself away from the show to go inside for breakfast. Fortunately, the dining room has panoramic windows that will allow us to keep an eye out even while eating!

After breakfast we'll likely head back out to the top of the Tower for a raptor watch. A variety of forest species are possible from here, including such gems as White, Semiplumbeous, and Short-tailed hawks and Black Hawk-Eagle. In fall, the Tower serves as an excellent spot to observe migrating raptors as well. We will spend some time here hoping to observe flights of migrating Broad-winged and Swainson's hawks and Turkey Vultures.

By mid-morning we'll tear ourselves away from the Tower and begin working our way down the one-mile entrance road. As we descend Semaphore Hill, a host of new birds will greet us. Broad-billed and Rufous motmots, various trogons, Chestnut-backed Antbird, and Velvety and Red-capped manakins are among the many possibilities. Ant swarms are sometimes encountered along this road as well, with a variety of attendant antbirds and woodcreepers possible.

After lunch and an afternoon siesta, we will likely spend some time watching the hummingbird feeders around the base of the tower. While there is much seasonal variation, up to eight species are possible here. Among the more regular visitors are the stunning White-necked Jacobin, Long-billed Hermit, the incomparable Violet-bellied Hummingbird, Blue-chested Hummingbird and White-vented Plumeleteer.

In the mid-afternoon we will head for the small town of Gamboa. Feeders here may produce Orange-chinned Parakeet, a dazzling variety of tanagers (Crimson-backed, Flame-rumped, Blue-gray, and Palm), honeycreepers (Red-legged, Green, and occasionally Shining), as well as other species. Near Gamboa there are some nice wetlands where we'll seek out a whole new group of birds. Tiny White-throated Crakes dart about the marsh. Wattled Jacanas and Purple Gallinules walk on the floating vegetation. Greater Anis are often seen atop the brushy tangles, while Lesser Kiskadees prefer perches closer to the water. Sometimes a Capybara strolls by, and Rufescent Tiger-Herons are regular. A careful check of the shoreline might reveal a skulking Gray-cowled Wood-Rail or a gorgeous American Pygmy-Kingfisher hiding in the shadows. The open field and edge habitats surrounding the marsh can be good for Squirrel Cuckoo, Barred Antshrike, Isthmian Wren, Black-striped Sparrow, and Yellow-billed Cacique, in addition to a variety of raptors, hummingbirds, parrots, and flycatchers.

NIGHT: Canopy Tower, Gamboa

October 20-21, Days 3-4: Pipeline Road

Beginning just beyond the old Canal Zone town of Gamboa, Pipeline Road winds for miles through the forests and foothills of Soberania National Park. The combination of rich primary and secondary forests; clear, beautiful streams; lack of traffic (the road dead ends); and abundant birdlife make this arguably the most famous birding road in the world. One never knows quite what to expect here, but there will certainly be much to see. Perhaps we'll find a fruiting tree with three species of toucans and several trogons feeding in it. Maybe it will be a Black-breasted Puffbird or Broad-billed Motmot perched motionless at eye level, or a noisy troop of Purple-

throated Fruitcrows working the forest edge. We may locate a lek of spectacular Golden-collared Manakins displaying on sunlit patches of the forest floor. The wild frenzy of wing snapping and jumping is truly an amazing sight. Fruiting cecropias lure honeycreepers, tanagers, and dacnis to their fruiting spikes. We'll always be on the alert for a foraging ant swarm with its attendant antbirds (the Spotted, Bicolored, and perhaps the stunning Ocellated) and woodcreepers (Northern Barred and Plain-brown among the possibilities). Other than the Darién, the very remote frontier zone between Panama and Colombia, Pipeline Road is the best area we've found in the Neotropics for locating ant swarms. Surely the whirl of activity around a swarm is one of the most exciting phenomena of the bird world. As the voracious ants march along the forest floor seeking smaller terrestrial prey, the birds pursue larger, more mobile insects and other arthropods. Because the birds are so intent on feeding, it is often possible to get very close views of them.

Some of the other birds we may encounter in the Pipeline Road area are Black Hawk-Eagle; Blue-headed and Mealy parrots; Slaty-tailed, White-tailed, Gartered, and Northern Black-throated trogons; Rufous Motmot; Great Jacamar; Cinnamon Woodpecker; Scaly-throated Leaf-tosser; Fasciated and Black-crowned antshrikes; Checker-throated Stipplethroat, Dot-winged and White-flanked antwrens, Spot-

crowned Antvireo; Streak-chested Antpitta (secretive); Black-faced Antthrush; Brownish Flycatcher (Twistwing); and Chestnut-headed Oropendola.

We'll have two full days to enjoy the riches of the famous Pipeline Road area.

NIGHTS: Canopy Tower, Gamboa

October 22, Day 5: Cerro Azul, Cerro Jefe

An early start (about 4:30 a.m.) will take us to the foothills of Cerro Azul and Cerro Jefe. We'll head directly for a trail that transects the stunted forest on Cerro Jefe. Bird life in the foothills differs dramatically from the Canal Zone. Violet-capped, Snowy-bellied, and Violet-headed hummingbirds; Green Hermit; Crowned Woodnymph; and Bronze-tailed Plumeleteer are among the twelve species of hummingbirds that may be encountered. Even the rare White-tipped Sicklebill is remotely possible. Red-lored and Mealy parrots can often be seen cruising by at eye level in the morning light. Fruiting trees typically attract some of the most

colorful foothill birds including Speckled, Bay-headed, and Emerald tanagers; and Scarlet-thighed and Blue dacnis. The very local and striking Rufous-winged Tanager, difficult to see anywhere else in its range, is regularly spotted here as well. Other birds we may encounter include Yellow-eared Toucanet, Stripe-cheeked Woodpecker (endemic), Mistletoe Tyrannulet, Scale-crested Pygmy-Tyrant, Spotted and Black-striped woodcreepers, Shining Honeycreeper, and Yellow-faced Grassquit. It should be noted that many of these foothills birds can be hard to locate in a short visit, especially with unpredictable foothills weather, but the possibilities here are certainly enticing.

NIGHT: Canopy Tower, Gamboa

October 23, Day 6: Rainforest Discovery Center and Gamboa Area

This morning we will return to Pipeline Road, where we will spend most of the morning at the Panama Rainforest Discovery Center (PRDC). A highlight of our visit will be the time spent atop the PRDC canopy tower, which will give us an impressive view of the rainforest canopy. Blue Cotingas are regularly seen from here, as are Scaled Pigeon, various swifts, Squirrel Cuckoo, White-necked Puffbird,

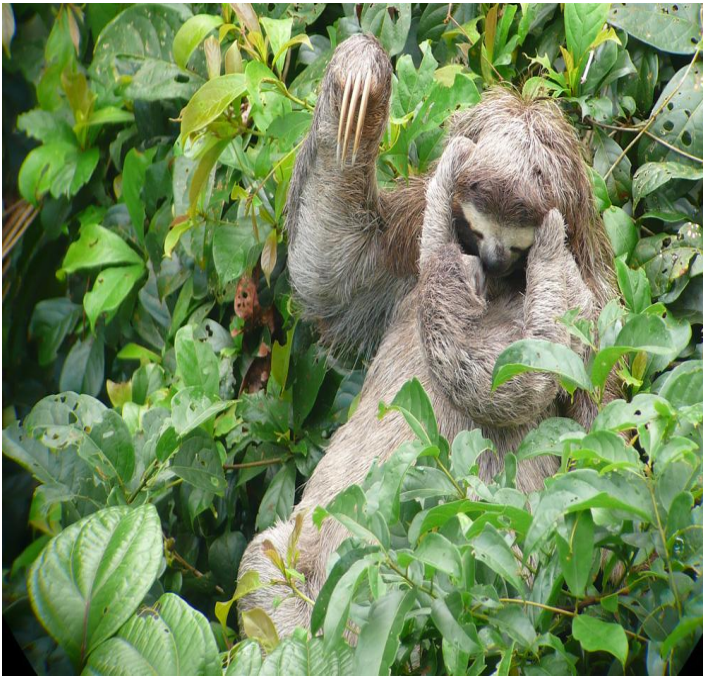

Pied Puffbird, several species of trogons, Brown-capped Tyrannulet, Yellow-winged Flatbill, and mixed-species flocks with a variety of warblers, honeycreepers and tanagers. The tower can be particularly good for seeing forest raptors as they perch above the canopy in the early morning or as they catch the first thermals later in the morning. Possibilities include Gray-headed Kite, Hook-billed Kite, Semiplumbeous Hawk, and Black Hawk-Eagle, among others. When activity in the canopy dies down, we will descend from the tower to bird the trail system below, where many of the typical Pipeline Road birds are possible. Eventually, we will make our way back to the visitor center, where a number of feeders along the deck often attract large numbers of hummingbirds of several species, among them White-necked Jacobin, Violet-bellied Hummingbird, Blue-chested Hummingbird, Crowned Woodnymph, Rufous-tailed Hummingbird, White-vented Plumeleteer, Long-billed Hermit and Stripe-throated Hermit.

We will return to the Canopy Tower for lunch and siesta, after which we will spend the afternoon somewhere in the Gamboa area. Our exact plans will remain flexible to take advantage of current conditions. We might choose to bird along the Chagres River near the Gamboa Rainforest Resort & Marina. The forest edge here can make for interesting birding, with such possibilities as Jet Antbird, Great Antshrike, White-bellied Antbird, Golden-fronted and Scrub greenlets, Yellow-tailed Oriole and others. Conversely, we might head to Old Gamboa Road where the trail leads through more open country and thus yields a different variety of birds. Jet Antbird; Rufous-breasted, Buff-breasted, and

Isthmian wrens; Lance-tailed Manakin; and Rosy Thrush-Tanager are among the many possibilities. The nearby Summit ponds often produce Boat-billed Heron, kingfishers, Southern Rough-winged Swallow, Lesser Kiskadee, and Rusty-margined Flycatcher. More common open country species such as Orange-chinned Parakeet, Red-crowned Woodpecker, and Buff-throated and Streaked saltators should also be in evidence.

On this, or another of our evenings, we will offer a post-dinner night drive by open vehicle along the entrance road down Semaphore Hill from the Canopy Tower and back. This night drive may treat us to such nocturnal birds as Common Potoo, Choco Screech-Owl, Mottled Owl, or Black-and-white Owl, not to mention a number of exciting mammals, with Northern Tamandua, Kinkajou, Bushy-tailed Olingo, Hoffmann's Two-toed Sloth, Brown-throated Three-toed Sloth, Paca and Western Night Monkey among the many possibilities.

NIGHT: Canopy Tower, Gamboa

October 24, Day 7: Metropolitan Natural Park, Panama Canal Museum and Miraflores Locks

The entire morning will be devoted to the drier forests of the Metropolitan Natural Park area. The avifauna here is quite different from that around the Canopy Tower. Among the many possibilities are Gray-headed Chachalaca, Whooping Motmot, White-necked Puffbird, Lineated Woodpecker, Fasciated Antshrike, White-bellied and Dusky antbirds, Yellow-crowned Tyrannulet, Lance-tailed Manakin, Golden-fronted Greenlet, Rufous-breasted and Rufous-and-white wrens, Long-billed Gnatwren, Red-crowned Ant-Tanager and Crimson-backed Tanager. In addition, we'll spend some time searching for two of the real specialty birds of this area: the endemic Yellow-green Tyrannulet (rare) and the magnificent Rosy

Thrush-Tanager, both of which can be found in this park. A late morning stop at Panama Viejo could yield twelve or more species of shorebirds plus a variety of herons, gulls, and terns.

In the afternoon we will have an optional trip to visit the Miraflores Locks to watch a ship transit the locks and spend time in their visitor center. Alternatively, some may wish to spend a final afternoon atop the observation deck of the Canopy Tower.

NIGHT: Canopy Tower, Gamboa

October 25, Day 8: Departure for Home

Transfers from the Canopy Tower to the airport will be provided in time for various flights home.

ESSENTIAL TOUR INFORMATION

TOUR SIZE: This tour will be limited to 10 participants. However, VENT reserves the right to increase the tour limit by one in order to accommodate a couple when only one space is available.

TOUR LEADER: Barry Zimmer with the assistance of local guides



Barry Zimmer has been birding since the age of eight. His main areas of expertise lie in North and Central America, but his travels have taken him throughout much of the world, including such exotic locales as Japan, Russia, Madagascar, Africa, and New Zealand. Barry is a longtime member of the New Mexico Bird Records Committee, and served on the Texas Bird Records Committee for 12 years. He has co-authored three books: *Birds of the Trans-Pecos*, *A Birder's Guide to the Rio*

Grande Valley, and *Birds and Birdfinding in the El Paso Area*. Barry has a keen interest in nature photography, having captured over 1,000 species of birds on film. His other interests include sports (a diehard Red Sox fan), cooking, and movies. He received his degree in psychology at the University of Texas in El Paso. Barry resides in El Paso with his wife, Yvonne, and their daughter, Alexandra.

TOUR FEES: **\$4,195** per person based on double occupancy in standard double accommodations at the Canopy Tower or as a single in small single accommodations at the Canopy Tower (see Canopy Tower Accommodations section below).

\$4,520 per person for occupying standard double accommodations as a single at the Canopy Tower (see Canopy Tower Accommodations section below).

\$4,495 per person based on double occupancy in premium double accommodations at the Canopy Tower (see Canopy Tower Accommodations section below).

These include all meals from breakfast on Day 2 through dinner on Day 7, accommodations as stated in the itinerary, all ground transportation during the tour, and guide services provided by the tour leaders. It does **not** include airfare to nor from Panama City. The fee also excludes laundry, personal expenses, and other items of a personal nature. For information about gratuities, please see the “TIPPING” sub-section below. If the minimum group size is not met, each participant will be charged a small-group supplement—shared equally and communicated in advance—to allow the tour to proceed.

REGISTRATION & DEPOSIT: You may register for this tour through the VENT [website](#) or by calling our office (512-328-5221). The initial deposit for this tour is **\$1,000** per person. At 180 days VENT will collect a second deposit that brings the total deposit amount to 40% of the tour price. We accept MasterCard and Visa for both deposits.

PAYMENTS: All tour payments may be made by credit card (MasterCard or Visa), check, money order, or bank transfer (contact the VENT office for bank transfer information). These include initial deposits, second deposits, interim payments, final balances, special arrangements, etc. Full payment of the tour fee is due 120 days (June 19, 2026) prior to the tour departure date.

EXTRA ARRANGEMENTS: Should you wish to make arrangements to arrive early or extend your stay, please contact the VENT office at least two months prior to your departure date. We can very easily make hotel arrangements and often at our group rate, if we receive your request with enough advance time.

FUEL SURCHARGES: Our prices are based on fuel prices at the time of itinerary publication. While we will do everything possible to maintain our prices, it may be necessary to institute a fuel surcharge.

TIPPING: An important part of the value of a VENT tour is knowing that tips for local service providers at our destinations—restaurant staff, hotel staff, drivers, local guides, and various other support staff—are included in your tour fee. If you would like to offer any of your local guides an additional tip, \$5 to \$10 a day is a common amount.

Tips for your VENT tour leader(s) are **not** included, but it is customary to tip one or both if you feel that you have received exceptional service. To assist in your planning, we recommend tipping your VENT tour leader(s) \$15 to \$20 per day, or the equivalent of approximately 2–4% of the tour fee.

If you plan to give tips by cash, they should be given directly to your tour leader at the end of the tour and **not** sent to the VENT office. Some of our tour leaders use mobile payment applications such as Venmo, PayPal, and Wise. If you would like to use this method, please ask your tour leaders directly whether they can accept tips through such an application.

We emphasize that tipping is optional and that these amounts are only recommendations. The amount you decide to tip is based entirely on your experience and at your discretion.

CANCELLATION & REFUNDS

CANCELLATION BY PARTICIPANT:

- **More than 120 days prior to the tour start date:** A refund of all monies paid will be issued, less 50% of the deposit (including initial and second deposit)
- **120 days or fewer prior to the tour start date:** No refund will be provided.
- **Optional add-ons:** Some tours offer optional add-ons that are designated as non-refundable. Any such add-ons are clearly identified as non-refundable at the time of booking. By selecting and purchasing an optional add-on, the participant acknowledges and accepts its non-refundable status. Fees paid for non-refundable add-ons are not refundable under any circumstances, regardless of when the tour is cancelled.

This cancellation policy applies to all participants and all tours (Pre-Tours and Extensions are considered self-contained tours separate from the main tour). Because unexpected events can occur, we strongly recommend the purchase of travel insurance.

CANCELLATION BY VENT:

If VENT cancels a tour prior to departure without cause or good reason, VENT will provide the participant a full refund, which will constitute full settlement to the participant.

If VENT cancels or delays a tour or any portion of a tour as a result of any Force Majeure event, VENT will use its reasonable best efforts to refund any payments on the balance of the tour fee to participant; provided that, VENT will have no obligation to provide a participant with a refund and will not be liable or responsible to a participant, nor be deemed to have defaulted under or breached any applicable agreement, for any failure or delay in fulfilling or performing any term of such agreement.

A “**Force Majeure**” event means any act beyond VENT’s control, including, without limitation, the following: (a) acts of God; (b) flood, fire, earthquake, hurricane, epidemic, pandemic or explosion; (c) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot or other civil unrest; (d) government order, law or actions; (e) embargoes or blockades; (f) national or regional emergency; (g) strikes, labor stoppages, labor slowdowns or other industrial disturbances; (h) shortage of adequate power or transportation facilities; and (i) any other similar events or circumstances beyond the control of VENT.

This VENT Cancellation & Refunds policy does not apply to air tickets purchased through VENT or to any special arrangements, such as additional hotel nights, that fall outside of the services described in the tour itinerary.

TRAVEL INSURANCE

SUGGESTED OPTIONS: To safeguard against losses due to illness, accident, or other unforeseen circumstances, we strongly recommend the purchase of travel insurance as soon as possible after making a deposit. VENT has partnered with **Redpoint Travel Protection** as our preferred travel

insurance provider. Through Redpoint, we recommend its comprehensive Ripcord plan, which includes a medical evacuation benefit. With this in mind, it is important to note that medical evacuation is not offered by Redpoint as a stand-alone policy or benefit. For travelers not interested in comprehensive travel insurance, VENT recommends **Medjet** and its **MedjetAssist®** plan. Medjet is not an insurance company, and Medjet Assist is not an insurance product; rather, Medjet is a membership-based air-medical transport company specializing in moving hospitalized travelers from an admitting hospital to a medical facility of choice. Medjet does not provide medical evacuation service from the point of injury or illness; yet, the MedjetAssist plan offers robust enough travel protection to satisfy the medical evacuation insurance requirement in place for many VENT tours.

About Redpoint Travel's Ripcord Plan

Ripcord is a completely integrated travel insurance program with single contact for emergency services, travel assistance, and insurance claims. Critical benefits include comprehensive travel insurance for trip cancellation/interruption, medical evacuation from your point of injury or illness to your hospital of choice; medical expense coverage, death of pet, and much more. Optional expanded insurance coverage is available and includes items such as evacuation coverage in case of a natural disaster or political or security reasons, waiver for pre-existing medical conditions exclusion, and a "Cancel for Any Reason" benefit. Ripcord is available to U.S. and non-U.S. residents.*

The CFAR benefit provides reimbursement for 75% of covered costs, and increases the policy premium by approximately 50%. Policies may be purchased either for the full value of the tour fee at the time of deposit or in segments as individual tour payments are made (deposit, second deposit, final balance, additional arrangements, etc.). The "pay as you go" approach reduces up-front expense and ensures that the amount paid toward your full policy premium is in proportion to the amount paid toward the full tour fee. Per person fees apply for each set of travel arrangements: \$50 domestic; \$75 international.* Many of our travelers choose to make their own air travel arrangements, but we emphasize the benefits to using our services. If you book your air arrangements yourself, Victor Emanuel Travel is unable to provide support in managing any flight delays and/or cancellations that could occur before and during a tour. When you purchase air tickets through Victor Emanuel Travel, our staff has ready access to your air ticket record and can provide assistance as problems arise. Please feel free to call the VENT office to confirm your air arrangements.

Please be sure to check with the VENT office prior to purchasing your air ticket to confirm that the tour is sufficiently subscribed to operate. VENT cannot be held responsible for any air ticket penalties.

*An air ticket will be purchased by Victor Emanuel Travel on behalf of the traveler with the traveler's consent. A purchase is considered final upon receipt of payment. If a ticket is subsequently reissued at the behest of the traveler (i.e. voluntary change of plans), the same fee rates apply for the reissue process, in addition to any fees that may be charged by the airline.

BAGGAGE: Please limit baggage to one piece of luggage and one carry-on. The airlines now strictly enforce baggage regulations. Excess baggage charges, which can be substantial, are the personal responsibility of each participant. Please consult your pre-departure materials and/or airline to find out specific weight restrictions.

As a precaution against lost luggage, we suggest that you pack a change of clothes, toiletries, medications, important travel documents, optics, and any other essential items in your carry-on bag. Due to ever-changing circumstances in the government's attempts to improve airport security, we recommend that you check the website of the [Transportation Security Administration \(TSA\)](#) for information pertaining to permissible carry-on items.

TRAVEL DOCUMENTS:

PASSPORTS: A passport valid for at least three months beyond your planned departure from Panama is required.

VISAs: Visas are not required for U.S. citizens traveling to this destination. If you hold a passport from another country, please check with your consulate or embassy for the most accurate guidance.

IMPORTANT: The visa details above are current for U.S. citizens as of June 19, 2026. Because entry requirements can change without notice, we kindly remind all participants to double-check the latest information before traveling. Travelers using non-U.S. passports are responsible for confirming any entry requirements that apply to their home country.

CANOPY TOWER ACCOMMODATIONS: The Canopy Tower has a total of two suites (Blue Cotinga with a small balcony and Harpy Eagle), five standard double guestrooms (Canopy Rooms) and four small single

rooms, all with private bathrooms. Based on room availability, singles have a choice of paying a supplement to occupy one of the Canopy Rooms or be waived for the single supplement for occupying one of the small single rooms. All rooms will be pre-reserved on a first-come, first-served basis. You will be advised of your room category at the time of your registration.

Please also note that since there is no elevator, all guests will climb several flights of stairs to the guestrooms, dining area and observation deck.

WHAT TO BRING

CLOTHING: As is the case for all our tropical tours, lightweight field clothing is the norm for Panama. This includes several pair of lightweight field pants, along with cool and comfortable long-sleeved shirts. A hat and sunscreen are recommended for protection from the sun.

Dark-colored or neutral clothing is suggested, as white or bright colors may frighten secretive birds. Lightweight and comfortable walking shoes are recommended, since some days we will spend a good bit of time on foot. Waterproof boots or overshoes such as NEOS may prove useful (May to December), as the trails can be muddy. A small umbrella and/or rain gear are essential.

EQUIPMENT: You should pack a pair of binoculars that are in good condition, along with a belt pack or day pack (good for carrying books, sunscreen, camera, etc.). As a precaution, it's a good idea to pack your binoculars, a change of clothing, toiletry items, medications, and travel documents in your airline carry-on bag. Your leader will have a spotting scope; but if you have one and wish to bring it, please feel free to do so.

CONDITIONS: This tour will largely involve roadside birding and short walks (less than a mile) along dirt roads or forest trails. At Cerro Jefe, we will walk a forest trail that goes somewhat uphill and is often muddy. In general, road conditions and trails will be muddy, as this is the rainy season (May through December). Either waterproof shoes or boots are recommended for most of the walking. Humidity averages quite high and temperatures will likely be in the upper 80's every day. Two of our days will be full days in the field bringing lunch with us. The remainder of the days, we will back at the Canopy Tower for lunch, and will have time for a post-lunch siesta. The Canopy Tower does not have an elevator. Walking up two or three flights of stairs to reach your room will be necessary. Getting to the dining room and ultimately the observation deck will require one and two more flights of stairs respectively.

Travel during the tour will be in open air vehicles for short drives, and by coaster or van for longer drives.

CLIMATE: The climate in the Canal Zone of Central Panama is usually warm, with mornings in the 70s and afternoons in the 80s. Conditions at midday can be humid and very warm, with temperatures reaching into the lower 90s. Rainstorms may occur at any time of year, but are more likely during the rainy season, which runs from May into early December, when a shower of some sort (some could be intense) is expected almost daily. Generally, the weather in Central Panama is mild and pleasant, with our activities corresponding to the cooler parts of the day and heightened bird activity.

LAUNDRY SERVICE: Laundry service is available at the Canopy Tower. Because the clothes are sent out to nearby Gamboa to be cleaned, expect items to be returned within 48 hours.

CURRENCY: The U.S. Dollar is the official currency of Panama. VISA and American Express are most commonly used, but MasterCard and Diners Club are also accepted.

INTERNET ACCESS: The Canopy Tower has a computer with internet access available for guest use and Wi-Fi available in all the rooms and common areas.

MISC:

- Departure Tax - US \$40 (included in the price of your air ticket)
- Electricity - 120 volts; plugs are the flat 2-pin American type.
- Language - The official language is Spanish, but English is spoken.
- Time - Eastern Standard Time

HEALTH & SAFETY

HEALTH: VENT follows Centers for Disease Control and Prevention (CDC) recommendations for standard travel precautions, which includes vaccination against a variety of preventable diseases. Among these so-called Routine Vaccinations are measles/mumps/rubella (MMR) vaccine, diphtheria/pertussis/tetanus (DPT) vaccine, poliovirus vaccine (boosters for adult travelers), and Varicella (Chickenpox). You should also be up-to-date with Hepatitis A and Hepatitis B vaccinations.

If you are taking personal medication, prescription or over-the-counter, be sure to bring an ample supply that will allow you to get through the tour safely. Please consult your physician as necessary. Remember to pack all medication in your carry-on baggage, preferably in original containers or packaging. As airline baggage restrictions can change without warning, please check with your airline for procedures for packing medication.

COVID-19: We continually emphasize that our number one priority is the health and safety of our customers and employees. Although VENT no longer maintains any of its COVID-era prevention protocols, we strongly recommend best practices for protecting yourself and your fellow travelers against COVID-19 illness. These measures include receiving the primary series vaccinations for those eligible, staying “Up to Date” with COVID-19 booster shots, wearing high filtration N-95 or KN-95 masks when in airports and on airplanes, and avoiding risky social settings in the lead-up to your tour. These recommendations are firmly rooted in CDC guidance for avoiding COVID-19.

SUN EXPOSURE: The sun’s ultraviolet rays are dangerous under prolonged exposure (sometimes only a matter of minutes), even in winter and early spring. Anytime you are outdoors you will want to protect your skin, including your lips, eyes, nose, and ears. A severe sunburn is potentially very painful and will affect your level of enjoyment. Always protect yourself when outdoors and be sure to bring an ample supply of high SPF sunscreen and lip balm. We strongly recommend the use of ultra-violet blocking, polarized sunglasses.

BITING INSECTS: Remove if not a concern, otherwise expand on it.

INSECT REPELLENTS: There are insect repellents for the skin and an insect repellent used to treat clothing that should not be applied to the skin.

Insect repellents for the skin are commonly available in three forms:

- **DEET:** (N,N-diethyl-meta-toluamide): A chemical compound that is marketed under various brand names (OFF!®, Cutter™, Ultrathon™, etc.) and offered in a variety of formulations including sprays, lotions, time-release preparations, and disposable wipes. The formulations will state a percentage of the active ingredient DEET on the packaging. DEET may be applied to exposed skin directly and/or sprayed on clothing. Please be careful when applying DEET as it can damage plastics and lens coatings.

- **Picaridin:** A synthetic formulation that is derived from piperine, a substance found in plants that produce black pepper.
- **Herbal insect repellents:** Various mixtures of organic ingredients such as oils from eucalyptus, citronella, cedar, and other herbs. The herbal repellents are more difficult to categorize because of the difference in ingredients from one brand to another. There is considerable variation in their effectiveness.

Insect repellent for clothing is marketed in one approved formulation:

- **Permanone® (Permethrin):** is an odorless spray-on repellent that may be used for pre-treatment of clothing, gear, and tents. It should not be used directly on the skin or sprayed on clothing while it is being worn. The pre-treatment process requires a number of hours to complete and must be done outdoors, so it is best completed in advance of travel. Do-it-yourself pre-treatment must be repeated more often than commercial treatment using Insect Shield® technology. It is available at various outdoor stores and can easily be found online.
- **Insect Shield® apparel:** Clothing pre-treated with Permanone is made by a variety of manufacturers. It is available for purchase from some sporting goods suppliers. The clothing is advertised as retaining its repellency for up to 70 washings.

The US EPA offers a search tool to help choose a repellent that is best for a particular situation. For example, some repellents work for mosquitoes, but not for ticks.

CLO Apps

eBird. Cornell Lab of Ornithology. Among the largest and most successful citizen science projects in existence, eBird is an essential tool in promoting bird study and conservation. Among a range of benefits, eBird allows users to keep a variety of lists in a single application. When taxonomic splits are incorporated, lists are automatically updated. Additionally, trip leaders can share daily lists, so one only need accept a shared list and it will upload to your files. **Highly recommended.**

Merlin Bird ID. Cornell Lab of Ornithology. Merlin is an app designed as a birding coach for beginning and intermediate birdwatchers. Excellent for use in the field, Merlin asks the observer a series of questions about his or her bird sighting, including date and location, and color, size, and behavior of a bird. Merlin then processes the viewer’s responses to present a shortlist of possible identifications, from which the user can choose the likely bird. Species profiles include a brief physical description, photographs, and sound samples. The Photo ID feature allows anyone with a camera to snap a photo and obtain a list of suggestions. Merlin’s Sound ID feature allows identification of birds through audible recognition. To use Merlin, download the app and the appropriate regional “pack.” Highly recommended.
