

Instructions for Scheduling a Semen Analysis at NCFMC

You may be seeking a semen analysis test without wanting to first establish with a provider at NCFMC. If you would like to have a semen analysis without also scheduling a consultation with our urologist, please use the following instructions and order form below:

1. NCFMC will only complete your semen analysis if you have a valid order from another medical/healthcare provider. Your provider may already have an order form, but if not, you can give your provider our order form (see below) and have them complete it for you. All orders at a *minimum* must have:
 - a. The patient's full legal name (as found on your state-issued identification)
 - b. The patient's date of birth
 - c. Specifically request that NCFMC render a semen analysis
 - d. The ordering provider's signature or stamp
 - e. The order provider's valid fax number so that we can send the results back to them

Your provider must fax the order form to our clinic directly. We will not accept an order from a patient directly.

2. After your provider has faxed us a completed order, you may call 916-773-2229 ext 202 to schedule an appointment. You can also schedule online at NCFMC.COM. Click the "Book Now" button. You will not be scheduled until your provider has faxed us an order.
3. After your appointment, we will fax the results of the semen analysis back to your ordering provider, and they will review the results with you. NCFMC is acting as a laboratory only and we will not review the results with you

If we are contracted with your insurance and your insurance covers a semen analysis, we will bill your insurance. If you do not have a contracted insurance or your insurance does not cover a semen analysis, the cash-price is \$250.00. You will need to prepay for your appointment to book a slot.

If you have an HMO plan with Hill Physicians, Sutter Gould, or UC Davis Medical Group, **you are responsible for obtaining an authorization** for a semen analysis at NCFMC before scheduling an appointment. Ask your ordering provider to request authorization from your insurance for cpt code 89322 to be rendered at NCFMC. *Sutter Independent Physicians and Sutter Medical Group do not require authorization for a semen analysis.*

NCFMC offers semen analysis on Monday, Tuesday, and Wednesday at 2:00pm.

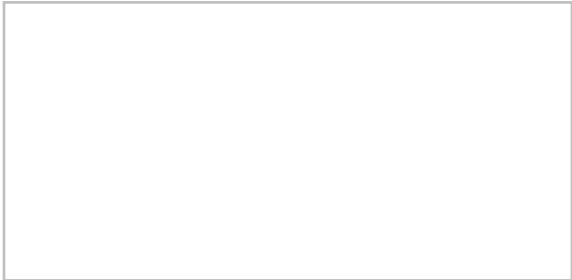

Semen Analysis with morphology

- Order required in office before patients may schedule. Ordering MD is responsible for relaying results to patient.
- An appointment is required. We do not accept walk-ins.
- HMO insurance require prior authorization or denial
- Abstinence period prior to appointment: 2-4 days
- Please bring a valid ID and insurance card (required for exam to be performed)
- The out-of-pocket cost if it's not covered by insurance is \$250 (this is the 2025 cost and is subject to change without notice). We don't accept cash in office. We accept all major credit cards, checks, or cashier's checks made out to NCFMC.
