

Summer of Football Prize Draw Offer

TERMS AND CONDITIONS OF THE SUMMER OF FOOTBALL PRIZE DRAW ("PRIZE DRAW") PROMOTION

1. THE PROMOTION

1.1 The Promoter of this Prize Draw is Postcode Neighbourhood Trust (the **Promoter**) which has engaged Postcode Lottery Limited trading as Postcode Lottery to manage it.

1.2 This promotion is available to **Players** (as defined below) of Postcode Lottery aged 18 years and over who are resident in Great Britain, and who are not self-excluded with Postcode Lottery.

1.3 Players can only enter **once**.

1.4 To enter the Prize Draw, the Player must enter via the Prize Draw link on the Promotions page within My Account, or if they are unable to access My Account, via the Postcode Lottery's [Customer Experience Team](#).

1.5 Players who enter via the Postcode Lottery's Customer Experience Team will be entered at the time their entry is processed by the Customer Experience Team and not at the time the Player initially contacts the Postcode Lottery. The Postcode Lottery will process such entries as soon as reasonably practicable, but neither the Promoter nor Postcode Lottery accept liability for any entries that are not entered into the Prize Draw due to the time taken to process the entry.

1.6 The Prize Draw will be open from 00:00:01 hours on 12 June 2026 until 23:59:59 hours on 28 June 2026.

1.7 Players who are blocked or self-exclude during the Prize Draw period will be removed from the Draw at the time they are blocked or self-exclude.

2. PRIZE/S, SELECTION OF WINNERS and CLAIMING OF PRIZE/S

2.1 Each eligible entrant's Postcode shall be entered into the Prize Draw. Where entrants play with the same Postcode, the Postcode shall only be entered once. One Postcode shall be selected by Postcode Lottery at random using Postcode Lottery's randomisation software. All eligible entrants who play with the winning Postcode shall win the prize. The prize is a cash sum, and the total value shall be determined by the process set out below. The prize will start at £10,000, with an additional £2,500 added for every goal scored by the national football teams of England and Scotland during the group stages of the World Cup in June 2026.

The total prize fund will be as advertised on the Promotions page of MyAccount and the value will be updated throughout the promotion and where applicable, following each football match. The full amount of the total prize will be available to view on 28 June 2026.

Each winner shall be entitled to receive the prize. The prize shall not be apportioned between winners. The prize will only be paid to a verified UK bank or building society account. Upon verification, the prize shall be paid within 28 days.

2.2 The Prize Draw will take place on 10 July 2026.

2.3 Postcode Lottery will check eligibility of winning participants prior to confirming the award of a prize. If a winner is found to be ineligible or if any potential winner does not comply with these terms and conditions, then the winner may in the Promoter's sole discretion, be disqualified and an alternate winner will be selected.

2.4 The Promoter's determination of any matter relating to eligibility or entitlement to a prize from the Prize Draw shall be final and binding.

2.5 Winners of the Prize Draw will be notified of their win by email and/or telephone by 17 July 2026 and by a representative of the Promoter or Postcode Lottery.

2.6 The first name and county of the winner will be shown on the Promotions section of My Account within seven days of the winner being notified, unless a winner has already contacted Postcode Lottery to object to this information being provided. In such circumstances the first name and county of the winner will not be published but will be provided to the Advertising Standards Authority if required.

2.7 While the Promoter and Postcode Lottery shall use their best efforts to ensure the accuracy of all winner notification communications, neither the Promoter nor Postcode Lottery shall be liable to award the prize to any individual advised in error that they have won in a Prize Draw, in circumstances where they have not in fact won in a Prize Draw.

2.8 Prizes are generally non-transferable and will be given to the winner only although the Promoter may, at its sole discretion, allow transfer of the prize in exceptional circumstances.

2.9 Postcode Lottery will make all reasonable efforts to contact the winners. If a winner cannot be contacted or is not available or has not claimed their prize within 7 days of the announcement date, Postcode Lottery reserves the right to select an alternate winner.

2.10 The Promoter and Postcode Lottery does not accept any responsibility for any loss, damage, injury or disappointment suffered by a winner as a result of taking up a prize or being unable to take up a prize.

3. GENERAL CONDITIONS

3.1 Neither the Promoter nor Postcode Lottery shall have any liability for any system failure or other action or event that prevents a customer from entering the promotion. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up a prize

except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Existing Players' statutory rights are not affected.

3.2 This promotion does not form part of the society lotteries managed by the Promoter. It is a free promotion, and the prize is funded by the Promoter.

3.3 These terms and conditions are governed by English Law and entrants to the Prize Draw submit to the non-exclusive jurisdiction of the English courts.

3.4 Any Existing Player who, if successful in a Prize Draw, would win prizes worth more than £500,000 in aggregate across that draw and any other individual paid-for society lottery draws managed by Postcode Lottery occurring within the previous 50 days of the relevant Prize Draw will not be eligible to win a prize in the Prize Draw.

4. PRIVACY

4.1 Postcode Lottery is the Data Controller for personal data you provide when entering the Prize Draw. Postcode Lottery takes the protection of personal data seriously.

4.2 The processing of entrants' and winners' details is a legitimate interest activity, which is necessary for the successful operation of the Prize Draw.
