

Dream Holiday Prize Draw Offer

TERMS AND CONDITIONS OF THE DREAM HOLIDAY PRIZE DRAW (“PRIZE DRAW”) PROMOTION

1. THE PROMOTION

1.1. This promotion is available to **Existing Players** (as defined below) of Postcode Lottery Limited trading as Postcode Lottery (the **Promoter**) aged 18 years and over who are resident in Great Britain, and who are not self-excluded with Postcode Lottery.

1.2 Existing Players can only enter **once**.

1.3. To enter the Prize Draws, the Existing Players must enter via the Prize Draw link on the Promotions page within My Account, or if they are unable to access My Account, via the Promoter’s [Customer Experience Team](#).

1.4 Existing Players who enter via the Promoter’s Customer Experience Team will be entered at the time their entry is processed by the Customer Experience Team and not at the time the Existing Player initially contacts the Promoter. The Promoter will process such entries as soon as reasonably practicable, but the Promoter accepts no liability for any entries that are not entered into the Prize Draws due to the time taken to process the entry.

1.5 The Prize Draws will be open from 00:00:01 hours on 4 April 2026 until 23:59:59 hours on 8 May 2026.

1.6 Existing Players who are blocked or self-exclude during the Prize Draws period will be removed from the Draws at the time they are blocked or self-exclude.

2. PRIZE/S, SELECTION OF WINNERS and CLAIMING OF PRIZE/S

2.1 Each eligible entrant’s Postcode shall be entered into the first Prize Draw. Where entrants play with the same Postcode, the Postcode shall only be entered once. One Postcode shall be selected by the Promoter at random using the Promoter’s randomisation software. All eligible entrants who play with the winning Postcode shall win a £1,000 cash prize and shall automatically be entered into the second Prize Draw. The £1,000 cash prize will only be paid to a verified UK bank or building society account. Upon verification, the £1,000 cash prize shall be paid within 28 days.

One winner shall be selected for the second Prize Draw by the Promoter at random using the Promoter’s randomisation software. The prize for the second Prize Draw shall be the option of a fourteen-night holiday to either the Maldives or Orlando, and the winner will choose their preferred destination. One prize is available to be won. Full details of the holiday prize options are found at the end of these terms and conditions.

2.2 The Prize Draws will take place on 15 May 2026.

2.3 The Promoter will check eligibility of winning participants prior to confirming the award of a prize. If a winner is found to be ineligible or if any potential winner does not comply with these terms and conditions, then the winner may in the Promoter's sole discretion, be disqualified and an alternate winner will be selected.

2.4 The Promoter's determination of any matter relating to eligibility or entitlement to a prize from the Prize Draws shall be final and binding.

2.5 Winners of the Prize Draws will be notified of their win by email and/or telephone by 22 May 2026 and by a representative of the Promoter.

2.6 The first name and county of the winner will be shown on the Promotions section of My Account within seven days of the winner being notified, unless a winner has already contacted the Promoter to object to this information being provided. In such circumstances the first name and county of the winner will not be published but will be provided to the Advertising Standards Authority if required.

2.7 While the Promoter shall use its best efforts to ensure the accuracy of all winner notification communications, the Promoter shall not be liable to award the prize to any individual advised in error that they have won in a Prize Draw, in circumstances where they have not in fact won in a Prize Draw.

2.8 Prizes are generally non-transferable, have no cash alternative, and will be given to the winner only although the Promoter may, at its sole discretion, allow transfer of the prize in exceptional circumstances.

2.9 While the Promoter makes every effort to describe the prize accurately, the published details are indicative, and the specification of a prize (but not any stated value) may vary.

2.10 Prizes may be subject to the relevant prize supplier's standard terms and conditions.

2.11 The Promoter shall be entitled to supply an alternative prize of equal or greater value where an advertised prize is unavailable for reasons outside the Promoter's reasonable control.

2.12 The Promoter will make all reasonable efforts to contact the winners. If a winner cannot be contacted or is not available or has not claimed their prize within 7 days of the announcement date, the Promoter reserves the right to select an alternate winner.

2.13 The Promoter does not accept any responsibility for any loss, damage, injury or disappointment suffered by a winner as a result of taking up a prize or being unable to take up a prize.

3. GENERAL CONDITIONS

3.1 The Promoter shall have no liability for any system failure or other action or event that prevents a customer from entering the promotion. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up a prize except

where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Existing Players' statutory rights are not affected.

3.2 This promotion does not form part of the society lotteries managed by the Promoter. It is a free promotion, and the prize is funded by the Promoter.

3.3 These terms and conditions are governed by English Law and entrants to the Prize Draws submit to the non-exclusive jurisdiction of the English courts.

3.4 Any Existing Player who, if successful in a Prize Draw, would win prizes worth more than £500,000 in aggregate across that draw and any other individual paid-for society lottery draws managed by Postcode Lottery occurring within the previous 50 days of the relevant Prize Draw will not be eligible to win a prize in the Prize Draw.

4. PRIVACY

4.1 The Promoter is the Data Controller for personal data you provide when entering these Prize Draws. The Promoter takes the protection of personal data seriously.

4.2 The processing of entrants' and winners' details is a legitimate interest activity, which is necessary for the successful operation of the Prize Draws.
