TERMS AND CONDITIONS OF THE ULTIMATE CHOICE PRIZE DRAWS (“PRIZE DRAWS”) PROMOTION

1. THE PROMOTION

1.1 The Promoter of the Prize Draws is Postcode Places Trust (the **Promoter**) which has engaged Postcode Lottery Limited trading as Postcode Lottery to manage them.

1.2 This promotion is available to **Players** (as defined below) of Postcode Lottery aged 18 years and over who are resident in Great Britain, and who are not self-excluded with Postcode Lottery.

1.3 Players may choose to enter **one** of the following Prize Draws:

- (a) the Family Time Prize Draw;
- (b) the Family Escape Prize Draw; or
- (c) the Cultural Discovery Prize Draw,

(together, the **Prize Draws**).

Players must select the Prize Draw they wish to enter using the Prize Draw link on the Promotions page within My Account or, if they are unable to access My Account, by contacting the Postcode Lottery’s [Customer Experience Team](#). **If a Player selects more than one Prize Draw, they will be entered into the first Prize Draw they selected only.**

1.4 Players who enter via Postcode Lottery’s Customer Experience Team will be entered at the time their entry is processed by the Customer Experience Team and not at the time the Player initially contacts Postcode Lottery. Postcode Lottery will process such entries as soon as reasonably practicable, but neither the Promoter nor Postcode Lottery accept liability for any entries that are not entered into the Prize Draw due to the time taken to process the entry.

1.5 The Prize Draws will be open from 10:00:00 hours on 3 August 2026 until 23:59:59 hours on 31 August 2026.

1.6 Players who are blocked or self-exclude during the Prize Draw period will be removed from the Draw at the time they are blocked or self-exclude.

2. PRIZE/S, SELECTION OF WINNERS and CLAIMING OF PRIZE/S

2.1 There will be three separate Prize Draws. Each eligible entrant’s Postcode will be entered into the Prize Draw they have selected. Where two or more eligible entrants play with the same Postcode and have selected the same Prize Draw, that Postcode will be entered into the selected Prize Draw once.

For each Prize Draw, one Postcode will be selected at random by Postcode Lottery using randomisation software. All eligible entrants who have selected the relevant

Prize Draw and play with the winning Postcode for that Prize Draw will win the applicable prize.

For the avoidance of doubt, if two or more eligible entrants play with the same Postcode but enter different Prize Draws, only those entrants who entered the Prize Draw in which that Postcode is selected as the winning Postcode will win the prize.

Example: *Player A and Player B play with the same Postcode. Player A selects and enters the Family Time Prize Draw, whereas Player B selects and enters the Cultural Discovery Prize Draw. If their Postcode is selected as the winning Postcode for the Cultural Discovery Prize Draw, only Player B will win the Cultural Discovery Prize Draw prize.*

2.2 Prizes for each Prize Draw are as advertised on MyAccount, and full details can be found at the end of these terms and conditions. Prizes may be subject to the relevant prize supplier's standard terms and conditions.

2.2 The Prize Draws will take place on 11 September 2026.

2.3 Postcode Lottery will check eligibility of the winning participants prior to confirming the award of any prize. If the winner is found to be ineligible or if any potential winner does not comply with these terms and conditions, then the winner may in the Promoter's sole discretion, be disqualified and an alternate winner will be selected.

2.4 The Promoter's determination of any matter relating to eligibility or entitlement to a prize from the Prize Draws shall be final and binding.

2.5 The winners of the Prize Draws will be notified of their win by 18 September 2026.

2.6 The winning Postcode of each Prize Draw will be shown in My Account within seven days of the relevant winner's being notified, unless a winner has already contacted Postcode Lottery to object to this information being published. In such circumstances the Postcode of the winner will not be published, and their details and winning entry will be provided to the Advertising Standards Authority if required.

2.7 While the Promoter and Postcode Lottery shall use their best efforts to ensure the accuracy of all winner notification communications, neither the Promoter nor Postcode Lottery shall be liable to award the prize to any individual advised in error that they have won in a Prize Draw, in circumstances where they have not in fact won in a Prize Draw.

2.8 Prizes are generally non-transferable and will be given to the winner only although the Promoter may, at its sole discretion, allow transfer of the prize in exceptional circumstances.

2.9 The Promoter and Postcode Lottery do not accept any responsibility for any loss, damage, injury or disappointment suffered by a winner as a result of taking up a prize or being unable to take up a prize.

3. GENERAL CONDITIONS

3.1 Neither the Promoter nor Postcode Lottery shall have any liability for any system failure or other action or event that prevents a customer from entering the promotion. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up a prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Existing Players' statutory rights are not affected.

3.2 This promotion does not form part of the society lotteries managed by Postcode Lottery. It is a free promotion, and the prize is funded by the Promoter.

3.3 These terms and conditions are governed by English Law and entrants to the Prize Draws submit to the non-exclusive jurisdiction of the English courts.

3.4 Any Existing Player who, if successful in a Prize Draw, would win prizes worth more than £500,000 in aggregate across that draw and any other individual paid-for society lottery draws managed by Postcode Lottery occurring within the previous 50 days of the relevant Prize Draw will not be eligible to win a prize in the Prize Draw.

4. PRIVACY

4.1 Postcode Lottery is the Data Controller for personal data you provide when entering the Prize Draws. Postcode Lottery takes the protection of personal data seriously.

4.2 The processing of entrants' and winners' details is a legitimate interest activity, which is necessary for the successful operation of the Prize Draws. PROMOTER

The Prize Draw is promoted by Postcode Places Trust which has its registered office at 28 Charlotte Square, Edinburgh, United Kingdom, EH2 4ET.

DEFINITIONS

Player shall mean any player who has played in the September draws of the society lottery managed by Postcode Lottery and who has not cancelled their subscription and paid for entry into the September draws on or before 31 August 2026.

Postcode shall mean the postcode used by the Player to play in Postcode Lottery's September draws.

PRIZE DETAILS

FAMILY TIME PRIZE DRAW

The Prize will consist of:

1. A Family Holiday to Mallorca

A seven-night holiday to Mallorca for 2 adults and 2 children (aged 11 and under) which will consist of:

- A seven-night stay in a one-bedroom Apartment Family Room at the 4-star Protur Safari Park Aparthotel in Sa Coma on an all-inclusive basis.
- Return economy flights to Mallorca from a UK airport. UK airport selection is subject to flight availability and flights may be indirect.
- In destination airport transfers included.

The Prize must be taken from May 2027 to October 2027 and preferred dates are subject to availability.

All travellers must have a valid passport for travel to Spain.

Tax and resort fees payable locally are excluded from the Prize. The winner shall be responsible for their own travel insurance and spending money.

- £500 spending money and in destination airport transfers included.

The Prize must be taken within twelve months from when the winner is confirmed and dates are subject to availability.

All travellers must have a valid passport for travel to Italy. One traveller must be aged 18 and above.

Tax and resort fees payable locally are excluded from the Prize. The winner shall be responsible for their own travel insurance.

- Dinner for two people.

The winner will receive the voucher electronically with full booking details and instructions. The voucher will be subject to the issuer's terms and conditions.

The Prize must be taken within twelve months from when the winner is confirmed and dates are subject to availability.

The winner shall be responsible for their own travel to London and spending money.

5. Garden Smart eGift Card

A Garden Smart eGift Card for the value of £250 through the Promoter's appointed issuer. The eGift Card will be supplied to the winner's nominated email address and will be subject to the respective issuer's terms and conditions, participating retailers, and expiry dates.

6. National Trust eGift Card

A National Trust eGift Card for the value of £250 through the Promoter's appointed issuer. The eGift Card will be supplied to the winner's nominated email address and will be subject to the respective issuer's terms and conditions, and expiry dates.

7. 2 x Samsonite Suitcases

Two Samsonite C-Lite Spinner 75/28 suitcases to be dispatched by courier to the winner's verified UK address within 10 working days of address confirmation.

8. 2 x Amazon Kindle Sribes

Two Amazon Kindle Scribes to be dispatched by courier to the winner's verified UK address within 10 working days of address confirmation.
