



Declaration of Conformity – Reach & RoHS

Phoenix Mecano AB hereby declares that all products produced and put on the market by Phoenix Mecano AB will to our best knowledge fulfil following regulations:

- The Regulation (EC) NO 1907/2006 of the European Parliament and of the Council concerning the registration, evaluation, authorization, and restriction of chemicals (**Reach**). Provided that we acquire knowledge of the presence of SVHC in our products, we will certainly inform you according to our legal obligation according to REACH article 33.
- The directive 2011/65/EU of the European Parliament and the Council on the restriction of the use of certain hazardous substances in electrical and electronic equipment (**RoHS II**) and the Directive 2015/863/EU (RoHS III). Irrespective of the scope RoHS II & III or exceed the maximum concentration stipulated therein, except for the Annex III & IV exemptions of RoHS II.

EU Directive 2011/65/EU restricts the use of 6 substances: Lead, Mercury, Hexavalent chromium, Polybrominated biphenyls, and Polybrominated diphenyl ether are all restricted to a maximum concentration of 1000 ppm. Cadmium is restricted to a maximum concentration level of 100 ppm.

Phoenix Mecano AB confirms that our products are in compliance with the EU RoHS directive 2011/65/EU. Some Phoenix Mecano AB's products might contain one of the restricted substances above the threshold, but these instances are covered by valid exemptions listed in Annex III.

On 31 March 2015, Directive 2011/65/EU was amended by Directive 2015/863. Directive 2015/863 further restricts the use of four phthalates: DEHP, BBP, DBP, and DIBP to a maximum concentration of 1000 ppm. The amendment will be in force from 22 July 2019 for electronic devices, except for medical equipment. Medical equipment is in scope from 22 July 2021.

Phoenix Mecano AB's products will not contain any of the restricted substances above the threshold as per the aforementioned deadlines.

Phoenix Mecano AB will monitor changes in the RoHS directive closely and update our products and documentation accordingly.
