

Christmas Wonderland at Drayton Manor

1. Promoter

The promoter is Motoring & Leisure Services Limited, trading as Boundless by CSMA, registered office: Britannia House, 21 Station Street, Brighton, BN1 4DE, registered in England and Wales under company number 02813598 ("Boundless").

2. Who can enter

The prize draw is open to current Boundless members aged 18 or over who attend Christmas Wonderland at Drayton Manor on 29 November 2026.

Members can:

- enter the adult prize draw for themselves; and
- enter the children's prize draw on behalf of a child aged under 18 who is attending the event with them.
- Children must not provide their own telephone number or email address. The accompanying adult's name and contact details must be used for all children's entries.
- Employees of Boundless, anyone involved in administering the prize draw, prize suppliers and their immediate families are not eligible to enter.

3. How to enter

Prize-draw cards will be handed out when members arrive at the event.

To enter, members must:

- complete the relevant adult or children's prize-draw card;
- provide their name, telephone number and email address; and
- place the completed card in the designated prize-draw bucket before the draw begins.

One adult entry may be submitted for each adult attending the event. One children's entry may be submitted for each child attending the event. No additional payment is required to enter once at the event.

Incomplete, illegible, altered or late entries will not be accepted.

4. Closing time

Entries close at 3.00pm on 29 November 2026, when the draw begins. Cards placed in the bucket after the draw has started will not be accepted.

5. The prizes

There are eight festive prizes available:

- four adult festive prizes, each worth up to £30; and
- four children's festive prizes, each worth up to £30.

The exact contents of the prizes will be confirmed and displayed at the Boundless area before entries open on the event day.

The contents may vary, but each prize will be appropriate for its adult or children's category. Any relevant age restrictions, allergen information or other product restrictions will be displayed with the prizes.

Each winner will receive one prize. Prizes are non-transferable and no cash alternative is available.

If circumstances outside Boundless's control make it necessary, Boundless may provide a reasonable alternative prize of an equivalent or greater value and a similar nature.

6. Selecting the winners

The winners will be drawn at random at 3.00pm on 29 November 2026.

Four winners will be drawn from the valid adult entries, and four winners will be drawn from the valid children's entries. The draw will be conducted by, or under the supervision of, an independent person.

7. Contacting the winners

The Boundless team will telephone each winner (or the adult named on a children's entry) using the telephone number provided on the entry card.

Winners who are still at the event will be asked to collect their prize from the Boundless area before the event closes.

If a winner has already left the event, Boundless will arrange to post the prize to them at no cost. A postal address will only be requested after the winner has been selected.

8. If a winner cannot be contacted

Boundless will make reasonable efforts to contact each winner by telephone or email.

If a winner cannot be contacted or does not respond within seven days, Boundless reserves the right to draw a replacement winner at random from the relevant adult or children's entry category.

9. Postal delivery

Prizes requiring postage will be sent to a valid UK postal address within 30 days of the winner confirming their delivery details.

Boundless is not responsible for delays caused by incorrect or incomplete contact or delivery information supplied by a winner.

10. Use of personal information

The information provided on the entry cards will only be used to:

- administer the prize draw;
- verify eligibility;
- contact the winners; and
- arrange collection or delivery of the prizes.

Entry details will not be used for marketing unless the entrant has separately agreed to receive marketing communications.

The cards will be removed securely from the event and securely destroyed once all winners have been contacted, all prizes have been collected or delivered and any related queries have been resolved. Cards will be destroyed no later than 90 days after the draw.

Personal information will be handled in accordance with the Boundless Privacy Centre.

11. General

Boundless may disqualify any entry it reasonably believes is fraudulent, incomplete or in breach of these terms and conditions.

Boundless's decision regarding the administration of the prize draw is final. Nothing in these terms affects entrants' statutory rights.
