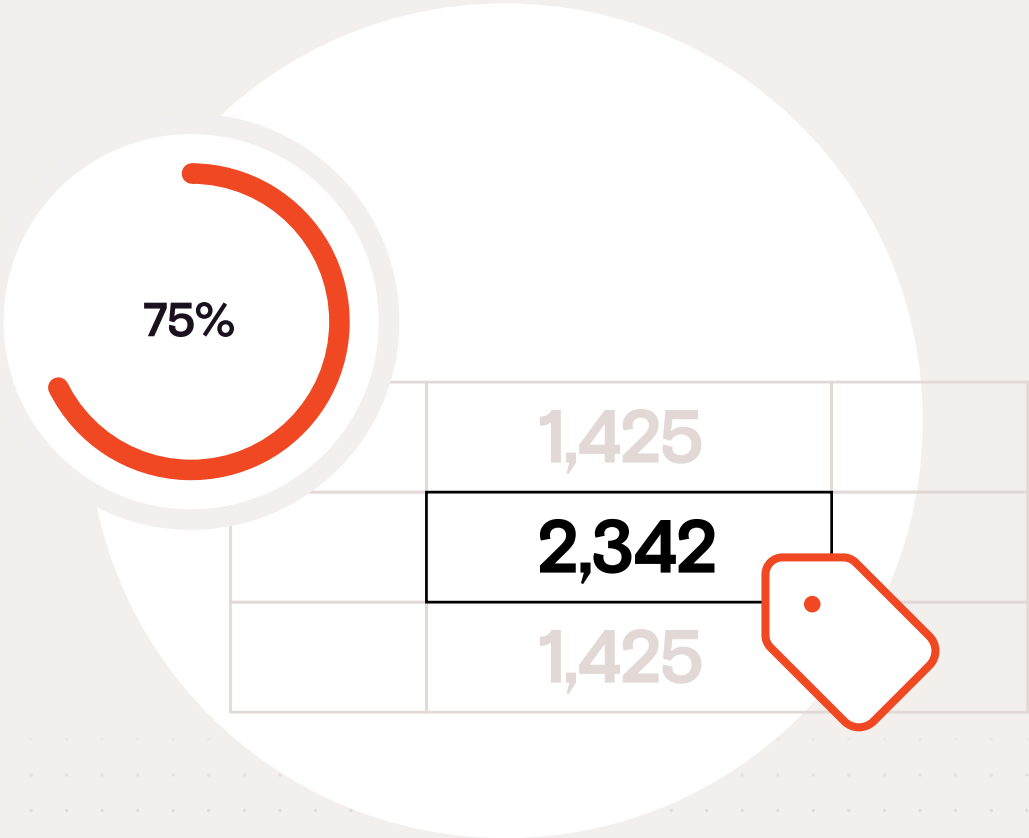

From 1 January 2025, large companies in the Netherlands must file their annual financial statements for the 2025 financial year in inline XBRL (iXBRL) format with the Chamber of Commerce (KvK) via SBR. For many organizations, this marks the first time filing in iXBRL with the KvK. It requires the right tools to manage tagging and validation carefully and efficiently.

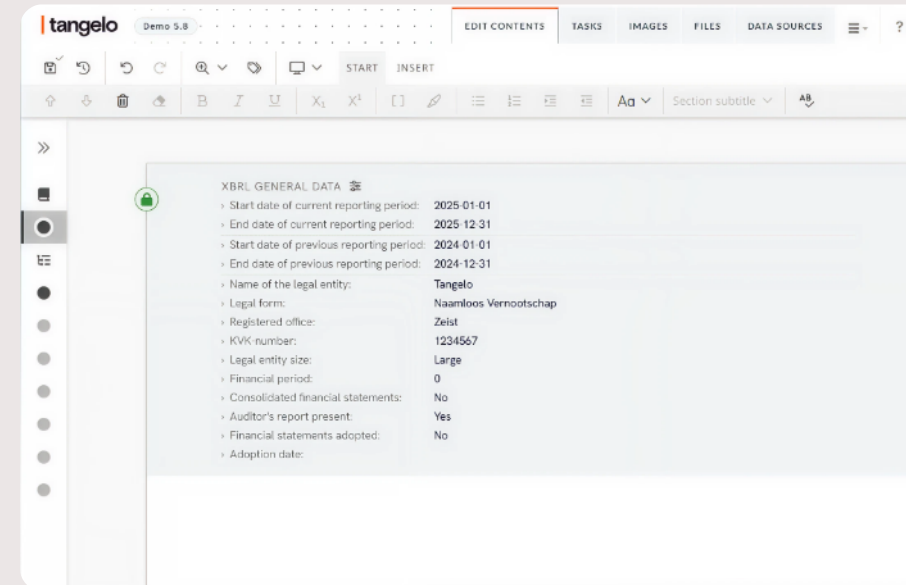
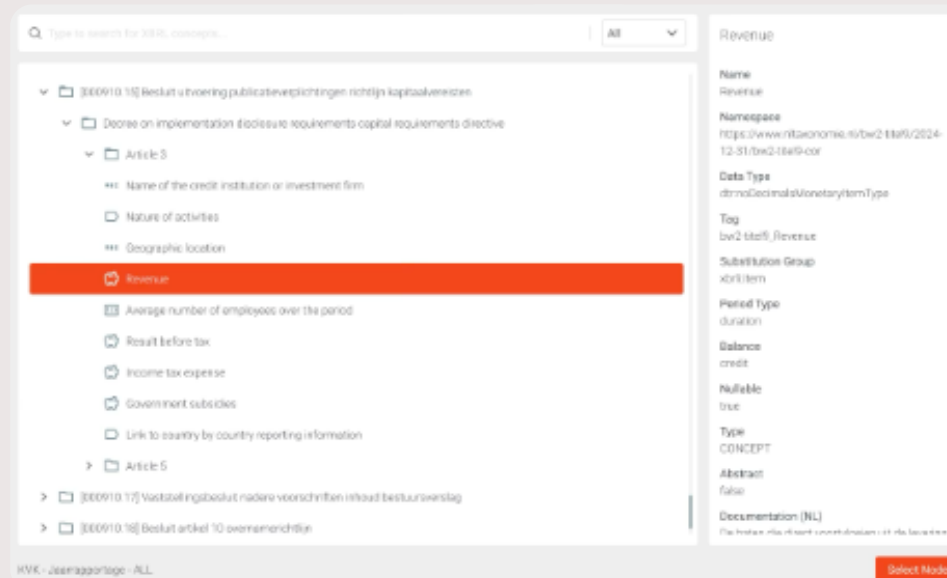

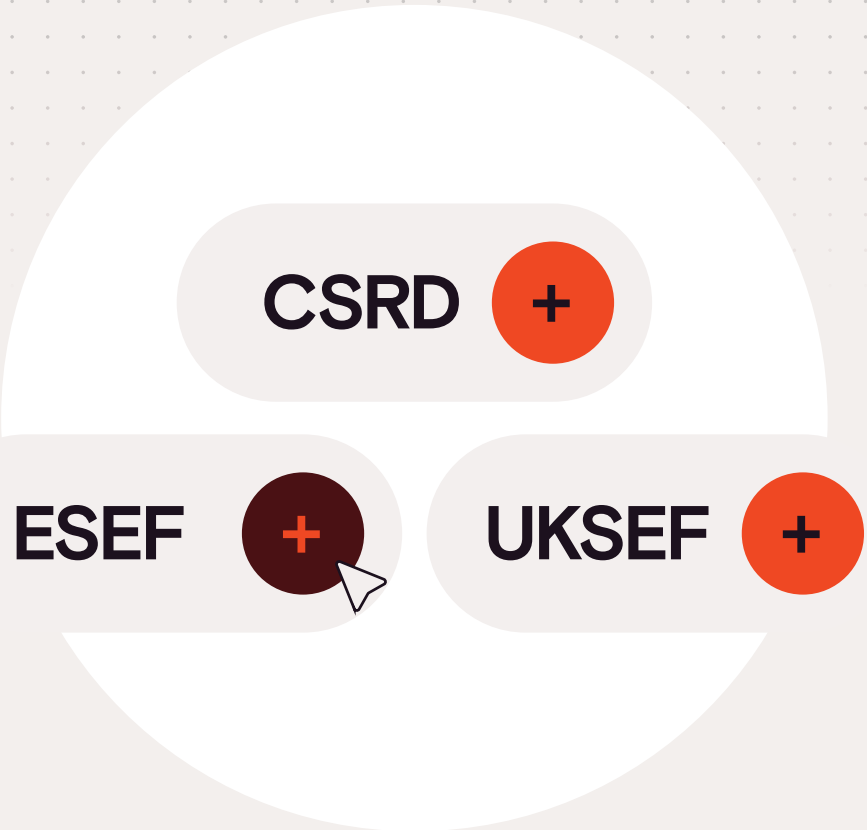
