



U.S. CARES ACT

Reporting on Emergency Financial Aid Grants to Students

(Updated January 14th, 2021)

On March 27, 2020, the Federal government enacted the Coronavirus Aid, Relief and Economic Security Act (CARES Act), Pub L. No. 116-136, providing funds to institutions from the Higher Education Emergency Relief Fund (HEERF) to make Emergency Financial Aid Grants to Students for expenses related to the disruption of campus operations due to coronavirus, including eligible expenses under a student's cost of attendance, such as food, course materials, technology, health care, and child care. The law requires institutions to report certain information related to the use of these funds. The following information is reported through January 10th, 2021.

- I. This statement shall serve to acknowledge that our institution signed and returned to the US Department of Education the *Certification and Agreement - Emergency Financial Aid Grants to Students*. We further attest that our institution has used, and/or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to Students.
- II. The total amount of funds that the institution has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Student is **\$441,377**.
- III. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of **January 10th, 2021**, is **\$376,507**.
- IV. The estimated total number of students at our institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 176.
- V. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act to date is **157**.
- VI. The following is the method used by our institution to determine which students receive Emergency Financial Aid Grants and how much each student will receive under Section 18004(a)(1) of the CARES Act.

Pursuant to the signed Funding Certification and Agreement, Hult intends to allocate no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to eligible students.

Recognizing that the disruption to campus activities caused by the ongoing Coronavirus pandemic has directly affected all our high residency students in unique and challenging ways, Hult has worked to

equitably distribute funds to eligible students within this population. Hult will distribute funding to students in three rounds of funding.

	Eligible Students
Round 1	All active Title IV recipients enrolled in Spring and/or Summer
Round 2	Non-Title IV recipients invited to apply and awarded if determined eligible for Title IV aid
Round 3	All CARES recipients from rounds 1 & 2 awarded additional grant based on availability of funds

In Round 1, all active Title IV recipients who were enrolled in either Spring and/or Summer classes received a fixed emergency financial aid grant based on their degree level. In Round 2, non-Title IV recipients who may be eligible for aid were invited to submit the FAFSA to determine eligibility for funding until mid-June. Students determined to be eligible to receive Title IV aid from Round 2 received an equal, fixed grant amount as the students in Round 1 (based on their degree level). In Round 3,

Hult distributed an additional award from the remaining funding to students who received a grant in either the first or second round.

Hult considered many factors to determine the emergency grant funding amounts. Based on an analysis of the comprehensive estimated cost of attendance for degree programs, Hult allocated funding between our Undergraduate and Postgraduate student population. During the 1st and 2nd rounds of funding, all eligible Undergraduate students will receive a fixed grant of \$1,939 and all eligible Postgraduate students will receive a fixed grant of \$684.

During the final round of funding, all eligible Undergraduate students received an additional fixed grant of \$2,352 and all eligible Postgraduate students received an additional fixed grant of \$829.

- VII. The follow instructions/directions/guidance will be provided by our institution to students concerning the Emergency Financial Aid Grants.

Hult began issuing Round 1 grants to students in mid-June, Round 2 grants to students in mid-July, and Round 3 grants after mid-September.
