Entrants	<p>Entry is open to all Australian residents aged 18 years and over.</p> <p>Employees of the Promoter and its franchisees and their associated companies are excluded.</p> <p>The immediate family members of employees of the Promoter and its franchisees and their associated companies are also excluded.</p>

1. General

- 1.1 The promoter of the Competition is the Promoter.
- 1.2 By entering this Competition, Entrants agree to be bound by these Terms and Conditions. Information on how to enter and prizes form part of these Terms and Conditions.

2. Eligibility

- 2.1 Entry is open only to the Entrants.
- 2.2 This Competition will be conducted during the Entry Period. Entries must be received by the Promoter during the Entry Period during the Daily Entry Timeframes.
- 2.3 An entry that is eligible will be known in these Terms and Conditions as an "Entry" and "Entries" will have a similar meaning.
