Dear Educators and Educational Partners of WE:

I am writing this letter in support of WE and the WE Schools Program.

appropriate and consistent use of logo placement (teacher facing and not student facing) and the balance used in the recognition and participation of corporate partners in the resources and opportunities created for classrooms and teachers. This is clearly reflected in the policy *WE Schools Standards & Guidelines: Corporate and Foundation Sponsorship Recognition Program*. It is clear that the primary purpose of corporate sponsors' recognition is to express gratitude and to understand that corporate sponsors also have a responsibility for social good. As Fr.
