General Legacy Gift

If you plan to give WE Charity a legacy gift without restrictions, the following sample clause may apply:

*I bequeath to WE Charity [**\$___ or ___% of my estate**] to be used for WE Charity's general purposes and as WE Charity sees fit.*

Legacy Gift to a Specific Project

If you plan to direct your legacy gift to a specific WE Charity project, we humbly ask that you contact us (416.925.5894) before completing your will. Contacting us will help ensure that your intentions are given proper effect. In this situation, the following sample clause may apply:

*I bequeath to WE Charity [**\$___ or ___% of my estate**] (the "WE Gift") and direct that WE Charity apply the WE Gift towards [**insert detailed description, or name of, the WE Charity project**] (the "WE Project"). If circumstances dictate that application of the WE Gift toward the WE Project is no longer practical or desirable, WE Charity is hereby authorized to make changes in use of the WE Gift, on the condition that such new use is consistent with the spirit and utility of the WE Project.*

General Gift from the Residue of your Estate

The 'residue' of your estate is the amount remaining in your estate after your debts and legacies are paid in full. If you plan to give WE Charity a gift from the residue of your estate, the following sample clause may apply:

*I bequeath to WE Charity [**___%**] of the residue of my estate to be used for general purposes and as WE Charity sees fit.*



Residue Gift to a Specific Project

If you plan to give a gift from the residue of your estate to a specific WE Charity project, we humbly ask that you contact us (416.925.5894) before completing your will. Contacting us will help ensure that your intentions are given proper effect. In this situation, the following sample clause may apply:

*I bequeath to WE Charity [%] of the residue of my estate (the “WE Residue Gift”) and direct that WE Charity apply the WE Residue Gift towards **[insert detailed description or name of the WE Charity project]** (the “WE Residue Project”). If circumstances dictate that application of the WE Residue Gift toward the WE Residue Project is no longer practical or desirable, WE Charity is hereby authorized to make changes in use of the WE Residue Gift, on the condition that such new use is consistent with the spirit and utility of the WE Residue Project.*

General Transfer of Shares

If you plan to transfer shares of a publicly traded company or corporation to WE Charity, the following sample clause may apply:

*I bequeath to WE Charity **[number of shares]** shares of **[legal name of company or corporation]** stock to be used for WE Charity’s general purposes and as WE Charity sees fit.*

Transfer of Shares to a Specific Project

If you plan to transfer shares of a publicly traded company or corporation to a specific WE Charity project, we humbly ask that you contact us (416.925.5894) before completing your will. Contacting us will help ensure that your intentions are given proper effect. In this situation, the following sample clause may apply:

*I bequeath to WE Charity **[number of shares]** shares of **[legal name of company or corporation]** stock (the “WE Stock Gift”) and direct that WE Charity apply the WE Stock Gift towards **[insert detailed description or name of the WE Charity project]** (the “WE Stock Project”). If circumstances dictate that application of the WE Stock Gift toward the WE Stock Project is no longer practical or desirable, WE Charity is hereby authorized to make changes in use of the WE Stock Gift, on the condition that such new use is consistent with the spirit and utility of the WE Stock Project.*
