<b>**Covid Restrictions Support Scheme</b> <a href="https://revenue.ie/en/corporate/communications/covid-19-support-schemes/index.aspx">https://revenue.ie/en/corporate/communications/covid-19-support-schemes/index.aspx</a>	<b>**This scheme will remain in place for businesses that have to stay closed. For businesses re-opening in June and July, they will receive a double payment for the first three weeks upon reopening up to a maximum of €30,000. Scheme extended to the end of the year.</b>	<b>Note:</b> Double rate will be paid for 2 weeks to those forced to close from 26 December 2020.
	The support will be available to eligible businesses who carry on a business activity that is impacted by COVID-19 restrictions. The business must have been required to prohibit or considerably restrict customers from accessing their business premises.	
	Eligible businesses can make a claim to Revenue for a payment known as an Advance Credit for Trading Expenses (ACTE). An ACTE is payable for each week a business is affected by the restrictions.	
	The ACTE is equal to 10% of the average weekly turnover of the business in 2019 up to €20,000, plus 5% on turnover over €20,000.	
	In the case of new businesses, the turnover is based on the average actual weekly turnover in 2020. The ACTE is subject to a maximum weekly payment of €5,000.

	<b>Waiver of excise duty on on-trade liquor licences on renewal in 2020.</b> The waiver applies to renewals of on- trade liquor licenses whose licenses expire on 30 September 2020, and once renewed will issue for a period of 1 October 2020- 30 September 2021.	
	<b>**Commercial rates waiver:</b> With limited exceptions, all businesses in affected sectors will be granted a commercial rates waiver. This scheme will remain in place. View <a href="http://www.gov.ie">www.gov.ie</a> for more information.	
	<b>**Warehousing’ of deferred tax debts:</b> Measures available for warehousing of tax debts. Scheme is extended to the end of 2021 for all eligible taxpayers, with an interest free period during 2022, and to include overpayments of EWSS in the scheme;)(speak to your DBASS adviser for more information)	
	<b>**VAT rate reduction from 13.5% to 9%:</b> A VAT rate reduction from 13.5% to 9% . This scheme will be extended until the 1st of September 2022.(Tourism & Hospitality)	
<b>**NEW SCHEME</b> <b>Business Resumption Support Scheme(BRSS)</b>	<b>**This scheme will be introduced in September 2021 for businesses with very significantly reduced turnover as a result of Covid-19.</b> It will be open to businesses with and without a rateable premise and will be administered by Revenue in a similar way to the CRSS. Businesses who previously availed of other schemes such as the Small Business Assistance Scheme for COVID (SBASC) and the Tourism Business Continuity Scheme for example, or the CRSS will be eligible to apply provided they meet the qualifying criteria. Further details on this scheme will be issued shortly.

<b>**Pandemic Unemployment Payment</b> <a href="https://www.gov.ie/en/service/be74d3-covid-19-pandemic-unemployment-payment/">https://www.gov.ie/en/service/be74d3-covid-19-pandemic-unemployment-payment/</a>	<p>To qualify for the PUP, you must have lost your job or been laid off because of Covid-19 or be self-employed and your trading income has ceased due to Covid-19, or your trading income has collapsed to the extent that you are available to take up other full-time employment.</p> <p><b>**While set to continue the PUP is expected to be reduced from September 7th next, with the top rate dropping from €350 to €300. The middle rate will drop from €300 to €250 and the bottom rate from €250 to €203. PUP will close to new entrants from July 1st and students will not be eligible from September 7th. By early 2022 payment will be back in line with the Jobseekers' Allowance</b></p> <p>Payment based on weekly payment bands(see value column)</p> <p>Self-employed persons can earn up to €960 over 8 weeks and keep your PUP payment. This limit is based on gross income minus expenses. 	<b>Micro-Enterprise Assistance Fund-</b> The Micro-Enterprise Assistance Fund is designed to help businesses with fewer than 10 employees, which are ineligible for existing grants, with a	Grant of up to €1,000 to help them adapt and invest to rebuild their business.
	<b>Enterprise Support Grant-</b> The Enterprise Support Grant for businesses impacted by COVID-19 is available for eligible selfemployed people who close their COVID-19 Pandemic Unemployment Payment on or after 18 May 2020.	Once-off grant of up to €1,000 to restart their business which was closed due to the COVID-19 pandemic.
