

Deliveroo Summer of Plus - Deliveroo Plus member-only promotions 8 June 2026 - 19 July 2026 - Terms & Conditions

These are the terms and conditions (“Terms”) that apply to the Summer of Plus Offers in addition to the Deliveroo Terms of Service. By signing up to Deliveroo Plus or placing an order with a Plus exclusive offer(s), each individual agrees to these Terms and the Deliveroo Terms and Conditions available here <https://deliveroo.co.uk/legal> and confirms they have read and understood the Deliveroo Privacy Notice at <https://deliveroo.co.uk/privacy>.

The “Summer of Plus” is Deliveroo’s promotional event designed exclusively for Deliveroo Plus members, offering member-only deals across multiple weeks. Customers must have an active Deliveroo Plus subscription at the time of order to qualify for member-only deals.

Promotions will be displayed in app, and include Buy 1 Get 1 Free on selected restaurants partners and menu items (“**BOGOF Offer**”), 30% off selected grocery and retail partners and items (“**30% off Stores Offer**”), together with additional ad hoc daily deals (“**Weekly Deal Drops**”) that will be displayed in-app and on the website (together, the “**Summer of Plus Offers**”).

Non-Plus users can sign up to Deliveroo Plus via deliveroo.co.uk/plus. Subscription required, which auto-renews unless cancelled. Terms, conditions and benefits of the Plus memberships can be found at deliveroo.co.uk/plus and deliveroo.co.uk/legal.

1. **Promoter:** Roofoods Limited (trading as Deliveroo), a company incorporated and registered in England and Wales with registered company number 08167130 and registered office address at River Building, Level 1 Cannon Bridge House, 1 Cousin Lane, London EC4R 3TE (“**Deliveroo**”).
2. **Entry periods:** the **Summer of Plus BOGOF and 30% off Stores Offers** open for entry on 08/06/2026 at 12:01 am (UK time), and close at 11:59 pm (UK time) 19/07/2026 (“**Entry Period**”) - subject to item availability and stock levels during that time. The Weekly Deal Drops will be available throughout the Entry Period and, when available, will be displayed in-app and on the website.
3. **Eligibility:**
 - a. Entrants must be a legal resident of England, Scotland, Wales or Northern Ireland and at least 18 years old at the time of entry.
 - b. Entrants must have signed up to, and be a current member of, a Deliveroo Plus tier at the time of order.
 - c. Internet access is required to enter the Promotion.
 - d. Elements of this Promotion are only available to selected entrants, and are non-transferable.
4. **The BOGOF Offer**
 - a. The BOGOF Offer will run for the Entry Period. Restaurants and items in-scope may change during this time. Restaurants in scope will be marked in-app or on the website with the “Buy 1 Get 1 Free” tag.
 - b. All items are subject to availability and may be unavailable subject to stock.

- c. If the BOGOF Offer category displays a restaurant, or the promotion is displayed in the relevant restaurant page, but no menu items are marked with the “Buy One Get One Free” tag, then no items are available at that time due to stock or participation reasons. Please check again later or see which other restaurants have available offers.
- d. **Offer redemption:** To redeem the BOGOF Offer, entrants must complete the following steps during the Entry Period:
 - i. Entrants must be signed up as a member of Deliveroo Plus.
 - ii. Participants must log into their Deliveroo account on www.deliveroo.co.uk or the Deliveroo app, and place a Qualifying Order. A “**Qualifying Order**” means a paid-for and delivered Deliveroo order from a participating restaurant of selected products with the tag “Buy 1, get 1 free”.
 - iii. Add **two** qualifying items to the basket. The discount will be applied at checkout and participants will only pay for one item. Please ensure you add two of the same item. The Offer will then be applied automatically.
 - iv. Participating Restaurants and selected items only. Items in scope will be labelled with the “Buy 1, Get One Free” tag. Available items may vary.

5. The 30% off Stores Offer

- b. If the *30% off matchday must haves* category page displays a grocery or shopping partner, or the promotion is displayed in the relevant grocery or shopping partner page, but no items are showing as available, then no items are available at that time due to stock or participation reasons. Please check again later.
- c. This offer will run for the Entry Period. Participating partners and items included in the offer may vary during this time. All items are subject to availability.
- d. **Offer redemption:** To redeem the 30% off Stores Offer, entrants must complete the following steps during the Entry Period:
 - i. Entrants must be signed up as a member of Deliveroo Plus.
 - ii. Participants must log into their Deliveroo account on www.deliveroo.co.uk or the Deliveroo app, and place a Qualifying Order. A “**Qualifying Order**” means a paid-for and delivered Deliveroo order from a participating grocery or retail store of selected products with the 30% off tag.

- v. Discounts are applied to single items. Some items may have volume restrictions. If customers are limited to ordering a certain number of an item, this will be indicated in the app or on the website in the product information.
- vi. Geographical restrictions, delivery, service and small order fees apply.

6. **Weekly Deal Drops**

- a. Additional Weekly Deals for the Summer of Plus from selected restaurant, grocery and shopping partners will be displayed in-app and on the website during the Entry Period. The promotions and deals will vary by week and are subject to availability.
- b. Any applicable minimum spend (excluding fees, tips and donations) requirements and maximum discounts will be indicated in or close to the promotional content.
- c. Geographical restrictions, delivery, service and small order fees apply. Restricted items excluded. Volume restrictions may apply.

Terms applicable to all Summer of Plus Offers
