

DELIVEROO PROMOTION RULES

These are the terms and conditions ("Rules") that apply to the Deliveroo Student Promotion ("Promotion"). By entering the Promotion, each entrant agrees to these Rules and confirms they have read and understood the Deliveroo Privacy Notice at <https://deliveroo.co.uk/privacy> or <https://deliveroo.ie/privacy>.

1. Promoter:

For UK: Roofoods Limited (trading as Deliveroo), a company incorporated and registered in England and Wales with registered company number 08167130 and registered office address at River Building, Level 1 Cannon Bridge House, 1 Cousin Lane, London EC4R 3TE ("**Deliveroo**").

For Ireland: Deliveroo Ireland Limited (trading as Deliveroo), a company incorporated and registered in England and Wales with registered company number 556923 and registered office address at 1-2 Victoria Buildings, Haddington Road Dublin 4 Dublin, Ireland ("**Deliveroo**").

2. Entry period: The Promotion opens on 01/09/2025 and closes 31/08/2026 ("**Entry Period**").

3. Eligibility:

- a. To participate in the Promotion, entrants must be a legal resident of England, Scotland or Wales, Northern Ireland and the Republic of Ireland and at least 18 years old at the time of entry and be a verified student with either an .ac.uk or .ac.ie email address
- b. A limit of one (1) entry per person applies to this Promotion.
- c. Internet access is required to enter the Promotion.
- d. Deliveroo reserves the right at any time to require proof of eligibility in such form as Deliveroo reasonably considers necessary.

4. Not eligible: The following persons are not eligible to enter the Promotion:

- (i) any employee or other individual engaged by Deliveroo or any of its associated companies;

- c. UNiDAYS will email you a 6-digit number to put into the Deliveroo app and verify your student status.

D. Once verified, you'll get access to free Deliveroo Plus Silver for up to three years. You will also get access to exclusive Student offers (which may be updated from time to time).

6. Free Delivery Offer and Deliveroo Plus Silver terms:

- a. UK and Ireland students with a verified registered .ac.uk or .ac.ie email address can access free delivery with Deliveroo Plus Silver, for up to 3 years from initial sign up to Deliveroo Students (£15/€18 minimum spend on restaurants and £25/€30 minimum spend on grocery and retail shops).
- b. Deliveroo Plus Silver terms apply. See deliveroo.co.uk/legal for full terms & conditions.

7. National Express Offer (Available for UK Deliveroo Students only):

- a. To redeem the offer, customers must be signed up to Deliveroo Students, and opted in to receive marketing emails and communications. Customers will receive one redemption per month, delivered via email with a unique code.
- b. This offer gives Deliveroo members a 25% discount for travel Monday - Thursday or a 15% discount for travel Friday - Sunday off a full priced National Express Standard or Fully Flexible fare.
- c. It does not apply to online Restricted fare or any other promotional fares.
- d. The offer is not available for travel on Christmas Day or Boxing Day Bookings must be made at least 24 hours in advance of outbound travel.
- e. The offer is available to redeem a maximum of once per month until 31 August 2025.
