

DELIVEROO FOR STUDENTS OFFER RULES

These are the terms and conditions (“Rules”) that apply to the Deliveroo for Students offer (“Offer”). By signing up for the Offer, each entrant agrees to these Rules and confirms they have read and understood the Deliveroo Privacy Notice at <https://deliveroo.co.uk/privacy>

1. Promoter:

Roofoods Limited (trading as Deliveroo), a company incorporated and registered in England and Wales with registered company number 08167130 and registered office address at River Building, Level 1 Cannon Bridge House, 1 Cousin Lane, London EC4R 3TE (“Deliveroo”).

2. Entry period: The Offer is available from 01/09/2026 and closes on 31/08/2027 (“Entry Period”).

3. Eligibility:

- a. To participate in the Offer, entrants must be a legal resident of England, Scotland, Wales or Northern Ireland, at least 18 years old at the time of entry and be a verified student with a [.ac.uk](https://deliveroo.co.uk/privacy) email address. Deliveroo will verify your student status.
- b. A limit of one (1) entry per person applies to this Offer.
- c. Internet access is required to enter the Offer.
- d. Anyone under the age of 18, who is not a verified student in the markets listed above is not eligible for the Offer. Deliveroo reserves the right at any time to require proof of eligibility in such form as Deliveroo reasonably considers necessary, and to remove the Offer from any person they have reason to believe is under 18 or not a student.
- e. You can only use the Deliveroo Plus benefits in the market in which you complete the Deliveroo for Students sign up process.

4. How to redeem: To redeem the Offer, entrants must complete the following steps during the Entry Period:

- a. Visit deliveroo.co.uk/students to sign up for a Deliveroo account, or sign in if you’ve already got one.
- b. Look for the display of the Offer and ensure you read the information carefully - we will explain the specific offer to you prior to sign up, including the length of any free Deliveroo Plus trial available to you and any subsequent monthly or annual costs, fees or other conditions. We will also clearly display what will happen to your Deliveroo for Students membership and associated Plus plan when you are no longer a student - including if your Deliveroo for Students membership will roll into a standard paid membership. You will always be able to opt out of your membership renewing prior to being charged.
- c. If you wish to proceed, you can then sign up for Deliveroo for Students by submitting your university email address. We’ll verify your Student status with the help of our partner, UNiDAYS.
- d. Once your student status has been verified, you get access to the Deliveroo Plus tier at the discounted rate displayed to you during the sign up flow, for so long as you remain an eligible and verified student. We’ll verify your student status when you sign up, and we will reverify it each year. You will also get access to exclusive Deliveroo for Students offers (which may be updated from time to time). The Deliveroo Plus

plan you are offered may vary by tier (Gold or Silver), with different prices and benefits depending on your plan. Your available plan, price, benefits, and subscription duration will be clearly shown during sign-up.

- e. If we cannot successfully reverify your student status, we will notify you of the date your Deliveroo for Students plan will end and explain what will happen afterwards. Depending on the terms you agreed to when you signed up, you will either lose your Plus benefits or automatically move to a full-price Plus Gold plan.

5. Deliveroo Plus Free Delivery Fees Offer and Deliveroo Plus terms:

- a. If you are a student in the UK with a verified registered .ac.uk email address you will have access to free delivery fees with Deliveroo Plus for as long as you remain an eligible student.
 - i. If you are offered Plus Gold then you will get free delivery fees on orders over £10 at restaurants and £15 at grocery and retail shops.
 - ii. If you are offered Plus Silver you will get free delivery fees on orders over £15 at restaurants and £25 at grocery and retail shops.
