(either casual, part-time, full-time or all of the above) and select an available 10-minute session with their preferred hiring retailer (subject to availability). Bookings are subject to availability. Successful bookings will be confirmed via email. The confirmation email will include a ticket containing a QR code, which must be presented upon arrival. By submitting the form, individuals subscribe to receive news of exclusive Galleria events and Activities via email or SMS from Vicinity Centres.
Session Information and Arrival Requirements	• Each confirmed booking entitles the attendee to one (1) 10-minute session with their selected hiring retailer. • Attendees are responsible for ensuring they are available to attend their allocated session. • Attendees must arrive at the Activity Area (located at Galleria, 284 Collier Rd, Morley WA 6062 near Target and Soul Origin at least five (5) minutes before their scheduled session. • Upon arrival, attendees must present their booking confirmation (including the QR code) for scanning by Activity personnel. • Late arrivals or non-bookings may not be accommodated due to scheduling requirements. • If an attendee can no longer attend their booked session, the attendee must notify the Promoter as soon as possible so their session may be made available to another attendee. • The Promoter reserves the right to reschedule session times where reasonably necessary due to circumstances beyond the Promoter's control. Where practicable, affected attendees will be notified at least 48 hours before their original session time.

	• The Promoter is not responsible for any costs incurred by attendees arising from a cancellation or rescheduling of a session.
Bookings permitted:	Attendees may make multiple bookings, provided each booking is submitted separately in accordance with these Booking Conditions. Each booking must be for a unique hiring retailer and session time.

1. The attendee agrees and acknowledges that they have read these Booking Conditions (and the Schedule) and that eligibility is deemed to be acceptance of these Booking Conditions (and the Schedule). Any capitalised terms used in these Booking Conditions have the meaning given in the Schedule, unless stated otherwise.
2. The Activity commences on the Start Date and ends on the End Date ("Booking Period"). Where applicable, bookings are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the attendee. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
3. Valid and eligible bookings will be accepted during the Booking Period, while the booking spots last.
4. The Promoter may update these Booking Conditions from time to time. The version in force at the time a booking is submitted will apply to that booking.
5. If for any reason any aspect of this Activity is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Activity.
6. The Promoter reserves the right, at any time, to validate and check the authenticity of bookings and attendee's details (including an attendee's identity, age and place of residence). If an attendee cannot provide suitable proof as required by the Promoter to validate their booking, the attendee will forfeit the booking session secured in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible bookings, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to book a session. The use of any automated software or any other mechanical or electronic means that allows an individual to automatically book repeatedly is prohibited and may render all bookings submitted by that individual invalid.
7. The Promoter reserves the right to disqualify attendees in the event of non-compliance with these Booking Conditions or where the Promoter has reason to believe that the attendee has engaged in unlawful or other improper conduct calculated to jeopardize the fair and proper conduct of the Activity. If there is a dispute concerning the conduct of the Activity or booking a session, the Promoter will resolve the dispute in direct consultation with the complainant/attendee. If the dispute cannot be resolved the Promoter's decision, acting reasonably, will be final.
8. The Promoter, the Shopping Centre owner/s and their associated agencies, related companies, officers, employees and contractors will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence or willful misconduct) in connection with this Activity. For the sake of clarity, this clause shall not apply where the Promoter has contributed to or caused such loss, expense, damage, personal injury or death and shall not apply to any liability which cannot be excluded by law (in each case the Promoter's liability is limited to the minimum allowable by law).
9. The attendee will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the Activity, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledges that the Promoter and Shopping Centre may use any such marketing and editorial material without further reference or compensation to them.
