# Step-By-Step How To Take Part

### Step 1: Create Your Amber Flag Committee



As a participant you will create an Amber Flag Committee in your workplace.

We recommend that your committee includes:

- · Co-ordinator: this must be a member of staff
- Committee member: the team should aim to include staff from a variety of departments

Records of meetings should be kept as evidence of the work of the team.

Your goal as a team should be to promote positive mental health in the workplace and link to the objectives of the Pieta Amber Flag for Business.

#### **Building Your Roadmap to Wellness**

As part of the Amber Flag for Business journey, your team will have the opportunity to meet with a Pieta therapist who will guide you in creating a tailored roadmap for mental health and wellbeing in the workplace.

### Step 2: Review Your Mental Health Promotion



The Amber Flag Committee will review:

- What could you do to improve the promotion of positive mental health?

Once formed, the committee must prepare an audit of any existing activities that promote an ethos of positive mental health in the workplace.

## Step 3:Set Your Goals and Objectives



Once your committee have reviewed the existing activities, you will set the goals and objectives for the coming year. Our team are more than happy to support you throughout the entire process.

The team should identify a minimum of three main goals that support the objectives of the Pieta Amber Flag for Business.

#### Step 4: Keep Records and Submit Your Progress

Your bespoke SharePoint folder will act as a secure space for you and your committee to save your records and upload any materials from your events (e.g. photos).

### Step 5: Accreditation



The Amber Flag for Business isn't just a recognition; it's a partnership grounded in expertise. Your business will meet with a Pieta therapist who is fully accredited.

This accreditation means you can be confident your business is guided by a mental health professional with the highest standards of training, practice, and ethics. Our therapists bring years of frontline experience in suicide prevention, workplace wellbeing, resilience, and mental health education.

After your team has uploaded your files, our therapist will review your documentation. When the review is completed and the application is successful, we will award you the Amber Flag for Business.

You will receive a digital certificate as well as a bespoke email signature and Teams background for all employees to use. We will also issue you with an Amber Flag logo for your website and a physical flag for your business premises.
