Vertex Holdings provides anchor funding and operational support to our proprietary global network of venture capital funds. This network of funds comprises:

- **Vertex Ventures China**, focused on early stage technology opportunities in China
- **Vertex Ventures Israel**, focused on early stage technology opportunities in Israel
- **Vertex Ventures SEA & India**, focused on early stage technology opportunities across SEA and India markets
- **Vertex Ventures US**, focused on early stage technology opportunities in US
- **Vertex Ventures HC**, focused on early stage technology opportunities in the biotech and medtech sectors
- **Vertex Growth**, focused on growth stage, follow-on opportunities from the portfolios of the other early-stage network funds across both technology and healthcare

These Vertex funds are managed by independent and separate General Partnerships and investment teams. Together, our network has over 90 VC professionals, all highly experienced with deep knowledge and strong networks in their respective target geographies and sectors.


