



## Instructions for the EXPRESS FEE Analyses in the Food Division of the GBA Laboratory Group

In this table you will find the parameters that can be ordered as EXPRESS FEE Analyses WITHOUT needing to make any further agreements about the turnaround times.

Please clearly mark the respective orders, samples and parcels with “EXPRESS FEE” so that these samples can be prioritized upon arrival. We recommend using our GBA “EXPRESS FEE” stickers, which you will find enclosed. More stickers are available by request or we can send you a file so you can print them on your own. Please note that there may be delays in express processing if the samples are insufficiently marked.

The parameters that cannot be found in the table can normally be determined as “EXPRESS FEE Analyses” as well. However, this requires our APPROVAL IN ADVANCE. Otherwise express processing cannot be guaranteed. Please note that the express service cannot be offered for any microbiological parameters, because the incubation times are defined by the methods and cannot be changed (exception: salmonella analysis using PCR).

### 1) Express- Turnaround time: 1 day (excl. day of sample reception)

## 2) Express- Turnaround time: 2 or 3 days (depends on time of sample reception; excl. day of sample reception)

#### 4) Express- Turnaround time: 4 days (excl. day of sample reception)

Please use our GBA "Express Fee" stickers.</p> <p><b>Exception:</b> If you have more than 4 express samples per parameter per day, you need to contact us in advance so we can check our capacities.</p>

If you are ordering both express and non-express analyses, please send two separate packages of sample material. For example, a sample shall be analyzed for aflatoxins (express), OTA (not express), and vitamin E – please send two packages of your sample: one for aflatoxins, the second for OTA (not express), and vitamin E.

If we are not able to report on the reporting date (e.g. due to technical problems), of course the express fee will not be charged. GBA will try to inform you about any potential delays as soon as possible.
