Mr Keen was joined by John Henwood MBE (winner of the IoD Jersey Lifetime Achievement Award), Brendan McMahon, (former CEO of PwC Channel Islands and Chair of the Good Business Charter), Dr Lesley Dickie (CEO of Durrell Wildlife Conservation Trust), Kate Wright (Co-Founder of the Diversity Network), Kristina Le Feuvre (Co-Founder of aMaizin! Adventure Park and a Non Executive Director of Jersey Business) and Tom Hacquoil (Co-Founder & Chief Executive Officer of Pinpoint and former Jersey/UK winner for Start-Up Director of the Year).

### Kevin Keen, Chair of the judging panel, said:

'The judging panel had a very difficult job this year, we had over 60 entrants completing comprehensive online entries. After a lot of work and debate, we were unanimous in this list of really inspiring finalists. Jersey leadership at its very best.'
