IoD Director of the Year Awards 2021 Winners

The winners of the Jersey Institute of Directors (IoD) 2021 Director of the Year Awards, have been announced at a sell-out black tie dinner at the Royal Yacht on Friday September 17^{th.} The event was supported by gold sponsor, Appleby, and silver sponsors, Quilter Cheviot and Jersey Post, and hosted by impressionist and comedian, Rory Bremner.

The awards celebrate strong leadership and recognise excellence across the private, public and third sectors of Jersey's community.
