# <u>Exam</u>

IoD certificate-level qualifications are internationally recognised and credit-rated under the Scottish Credit and Qualifications Framework (SCQF). Exams are flexible and can be taken at various dates throughout the year at a time that works best for you. They are completed using a computer-based testing system and are remotely invigilated allowing you to choose when and where you take them. All four module exams can be taken the same day although IoD Pall Mall recommend no more than two per day.

£200 per module or if you purchase all four certificate exams together, it is £600 (to be paid directly to IoD Pall Mall when confirming exam time/date)

Complimentary exam preparation dates will be available nearer the time.
