Exams are included in the cost of the programme.

IoD certificate-level qualifications are internationally recognised and credit-rated under the Scottish Credit and Qualifications Framework (SCQF). Exams are flexible and can be taken on various dates throughout the year at a time that works best for you.

They are completed via the digital platform Civica and are remotely invigilated, allowing you to choose when and where you take them. Exams are held between 08.00 - 17.00, and the exams are 45 minutes each.

Complimentary exam preparation dates will be available nearer the time.

Next available exam date after this course is Wednesday 22 July 2026. Please note these dates book very quickly.
